8 of liquor for on–premises consumption in addition to beer and wine; altering the
9 amount of beer the holder may provide for on–premises consumption; and generally

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Alcoholic Beverages and Cannabis

25–102.

This title applies only in Montgomery County.

25–1002.

(a) There is a beauty salon AND BARBERSHOP beer [and], wine, AND LIQUOR license.

(b) The Board may issue the license to a holder of:

(1) a beauty salon permit issued under § 5–501 of the Business Occupations and Professions Article; OR

(2) A BARBERSHOP PERMIT ISSUED UNDER § 4–501 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.

(c) The license authorizes the license holder to provide not more than **12 OUNCES OF BEER**, 5 ounces of [beer or] wine [by the glass], **OR 1.7 OUNCES OF LIQUOR** for on–premises consumption by a beauty salon OR BARBERSHOP customer:

(1) when the customer is provided a cosmetology service under ~~§ 5–101(n)~~ **TITLE 5** of the Business Occupations and Professions Article **OR A BARBERING SERVICE UNDER TITLE 4 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE;** or

(2) while the customer is attending a fund–raising event at the beauty salon OR BARBERSHOP for which the County Department of Permitting Services has issued a permit.

(d) The license may not be transferred to another location.

(e) The license holder may provide beer [and], wine, AND LIQUOR during normal business hours but not later than 9 p.m.

(f) An establishment for which the license is issued is subject to the alcohol awareness training requirements under § 4–505 of this article.

(g) The annual license fee is \$100.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025.
