The District Court has exclusive jurisdiction over a small claim action, which, for purposes of this section, means a civil action for money in which the amount claimed does not exceed \$5,000 exclusive of interest, costs, and attorney's fees, if attorney's fees are recoverable by law or contract; and landlord tenant action under §§ 8–401 and 8–402 of the

- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
