A BILL

To amend title 31, United States Code, to repeal the authorities of the Government Accountability Office with respect to the District of Columbia government, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “District of Columbia
5 Government Accountability Office Home Rule Act”.

1 **SEC. 2. REPEAL OF AUTHORITIES OF GOVERNMENT AC-**
 2 **COUNTABILITY OFFICE OVER DISTRICT OF**
 3 **COLUMBIA GOVERNMENT.**

4 (a) TREATMENT OF DISTRICT GOVERNMENT AS
 5 FEDERAL AGENCY.—Section 701(1) of title 31, United
 6 States Code, is amended by striking “includes the District
 7 of Columbia government but”.

8 (b) ANNUAL AUDIT.—

9 (1) IN GENERAL.—Title 31, United States
 10 Code, is amended by striking section 715.

11 (2) CLERICAL AMENDMENT.—The table of sec-
 12 tions of chapter 7 of such title is amended by strik-
 13 ing the item relating to section 715.

14 (c) EVALUATION OF PROGRAMS AND ACTIVITIES.—
 15 Section 717(a) of such title is amended by striking “or
 16 the District of Columbia government”.

17 (d) REPORTS TO CONGRESS.—Section 719(f)(3) of
 18 such title is amended by striking “or the District of Co-
 19 lumbia government”.

20 (e) RESPONSE TO REPORTS.—Section 720(a) of such
 21 title is amended by striking “or the District of Columbia
 22 government”.

14 (A) in subparagraph (A), by striking “the
 15 Comptroller General,”; and

16 (B) by striking subparagraph (B).

17 (e) REPEAL OF ANNUAL AUDITS OF DEBT SERVICE
 18 PAYMENTS.—Section 481 of such Act (sec. 1–204.81,
 19 D.C. Official Code) is amended—

20 (1) by striking “(a) Any Act” and inserting
 21 “Any Act”; and

22 (2) by striking subsection (b).
