During the open season for migratory waterfowl, a person may not fish by any means within 500 yards of any stationary blind or blind site which is occupied and is being used for hunting migratory waterfowl.

- DURING THE OPEN SEASON FOR MIGRATORY WATERFOWL, A PERSON MAY NOT
  OPERATE A VESSEL IN ANY MANNER WITHIN 500 YARDS OF ANY STATIONARY BLIND
  OR BLIND SITE THAT IS OCCUPIED AND BEING USED FOR HUNTING MIGRATORY
  WATERFOWL.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 2023.
