A BILL

To protect civilians from cluster munitions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Cluster Munitions Ci-
- 5 vilian Protection Act of 2017".
- 6 SEC. 2. FINDINGS.
- 7 Congress makes the following findings:
- 8 (1) The Convention on Cluster Munitions, done
- 9 at Dublin May 30, 2008, and entered into force Au-

- 1 gust 1, 2010, now has 100 States Parties, including 2 Canada, France, Germany, and the United King-3 dom, and an additional 19 signatories.
- The Convention on Cluster Munitions, 5 which comprehensively bans the use, production, ac-6 quisition, export, or transfer of cluster munitions 7 and requires the destruction of existing stockpiles, 8 clearance of contaminated land, and assistance to 9 cluster munition victims, has led to the destruction 10 of nearly 1,400,000 cluster munitions containing more than 170,000,000 submunitions.
 - (3) Under a policy issued in 2008 by Secretary of Defense Robert Gates, by the end of 2018, the United States will no longer use cluster munitions anywhere in the world, unless, after arming, the cluster munitions do not result in more than 1 percent unexploded ordnance across the range of intended operational environments.
- 19 (4) The CBU-105 Sensor Fuzed Weapon meets 20 the standard established by Secretary Gates in 21 2008.
