23	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24	That the Laws of Maryland read as follows:

- 2 (a) Except as provided in [§ 4–701.1] §§ 4–701.1 AND 4–701.2 of this subtitle, 3 this section applies to any person who is required under this subtitle or Subtitle 2, 8, 9, or 4 10 of this title to be licensed to guide fishing parties or to catch, sell, buy, process, transport, 5 export, or otherwise deal in fish caught in tidal waters.
- 6 (b) (1) Except as provided in [§ 4–701.1] §§ 4–701.1 AND 4–701.2 of this subtitle, the Department shall utilize a single, commercial license, to be known and designated as a tidal fish license.
- 9 (d) (2) (ii) The following annual fees for an authorization shall apply 10 regardless of when the license is issued or an activity is authorized:
- 4. For a person to buy, process, pack, resell, market or otherwise deal in fish caught in the tidal waters of Maryland, seafood dealer:
- 13 A. \$50 for a person licensed under item 2 of this 14 subparagraph or 4-701.1 OR 4-701.2 of this subtitle; or
- B. \$250 for a person not licensed under item 2 of this subparagraph; and
- 5. For a person who is not licensed under this section to land fish caught in out–of–state tidal waters, seafood landing \$350.

- 20 (A) THERE IS A COMMERCIAL BLUE AND FLATHEAD CATFISH FINFISH 21 TROTLINE LICENSE.
- 22 (B) (1) THE LICENSE AUTHORIZES THE HOLDER TO CATCH FOR SALE 23 BLUE AND FLATHEAD CATFISH IN THE TIDAL WATERS OF THE STATE USING A FINFISH TROTLINE, AS DEFINED IN DEPARTMENT REGULATIONS.
- 25 (2) A LICENSEE SHALL FISH IN ACCORDANCE WITH DEPARTMENT 26 REGULATIONS.
- 27 (C) A PERSON WHO WISHES TO OBTAIN THE LICENSE SHALL COMPLETE AND SUBMIT AN APPLICATION FOR THE LICENSE TO THE DEPARTMENT OR ANY PERSON DESIGNATED BY THE DEPARTMENT.
- 30 **(D)** AN APPLICANT FOR THE LICENSE DOES NOT NEED TO HOLD A TIDAL 31 FISH LICENSE UNDER § 4–701 OF THIS SUBTITLE TO BE ELIGIBLE FOR THE LICENSE.

- 1 (E) THE TERM OF THE LICENSE IS 1 YEAR FROM SEPTEMBER 1 THROUGH 2 AUGUST 31 THE FOLLOWING YEAR.
- 3 (F) THE ANNUAL LICENSE FEE IS \$15.
- 4 (G) A LICENSEE MAY NOT TRANSFER A LICENSE ISSUED UNDER THIS 5 SECTION.
- 6 (H) A LICENSEE SHALL HAVE A COMMERCIAL BLUE AND FLATHEAD CATFISH 7 FINFISH TROTLINE LICENSE IN THE LICENSEE'S POSSESSION WHEN THE LICENSEE 8 FISHES UNDER THE LICENSE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
