and from school, including data related to bus and pedestrian safety, strategies for ensuring

- 4 (g) Beginning in fiscal year 2020 and each fiscal year thereafter, at least \$10,000,000 of the money in the Fund shall be used to provide grants to local school systems 6 and local law enforcement agencies as provided under § 7–1508 of this subtitle.

- [(i)] (J) (1) The State Treasurer shall invest the money of the Fund in the same manner as other State money may be invested.

- [(k)] (L) Money expended from the Fund by local school systems to enhance school safety is supplemental to and is not intended to take the place of funding that otherwise would be appropriated to local school systems.
