A BILL

To amend section 5163.06 and to enact section 1
5163.062 of the Revised Code regarding Medicaid 2
coverage for workers with a disability and to 3
make an appropriation upon approval of a 4
Medicaid state plan amendment. 5

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 5163.06 be amended and section 6
5163.062 of the Revised Code be enacted to read as follows: 7

Sec. 5163.06. The medicaid program shall cover all of the 8
following optional eligibility groups: 9

(A) The group consisting of children placed with adoptive 10
parents who are specified in ~~the "Social Security Act,"~~ section 11
1902(a)(10)(A)(ii)(VIII) of the "Social Security Act," 42 U.S.C. 12
1396a(a)(10)(A)(ii)(VIII); 13

(B) Subject to section 5163.061 of the Revised Code, the 14
group consisting of women during pregnancy and the maximum 15
postpartum period permitted under 42 U.S.C. 1396a(e) beginning 16
on the last day of the pregnancy, infants, and children who are 17

specified in the ~~"Social Security Act,"~~ section 1902(a)(10)(A) 18
(ii)(IX) of the "Social Security Act," 42 U.S.C. 1396a(a)(10)(A) 19
(ii)(IX); 20

(C) The group consisting of employed individuals with 21
disabilities who are specified in section 1902(a)(10)(A)(ii) 22
(XIII) of the "Social Security Act," 42 U.S.C. 1396a(a)(10)(A) 23
(ii)(XIII); 24

(D) Subject to sections 5163.09 to 5163.098 of the Revised 25
Code, the group consisting of employed individuals with 26
disabilities who are specified in the ~~"Social Security Act,"~~ 27
section 1902(a)(10)(A)(ii)(XV) of the "Social Security Act," 42 28
U.S.C. 1396a(a)(10)(A)(ii)(XV); 29

~~(D)~~ (E) Subject to sections 5163.09 to 5163.098 of the 30
Revised Code, the group consisting of employed individuals with 31
medically improved disabilities who are specified in the ~~"Social~~ 32
~~Security Act,"~~ section 1902(a)(10)(A)(ii)(XVI) of the "Social 33
Security Act," 42 U.S.C. 1396a(a)(10)(A)(ii)(XVI); 34

~~(E)~~ (F) The group consisting of independent foster care 35
adolescents who are specified in the ~~"Social Security Act,"~~ 36
section 1902(a)(10)(A)(ii)(XVII) of the "Social Security Act," 37
42 U.S.C. 1396a(a)(10)(A)(ii)(XVII); 38

~~(F)~~ (G) The group consisting of women in need of treatment 39
for breast or cervical cancer who are specified in the ~~"Social~~ 40
~~Security Act,"~~ section 1902(a)(10)(A)(ii)(XVIII) of the "Social 41
Security Act," 42 U.S.C. 1396a(a)(10)(A)(ii)(XVIII). 42

Sec. 5163.062. The medicaid director shall adopt rules 43
under section 5163.02 of the Revised Code as necessary to 44
provide medicaid coverage for the optional eligibility group 45
described in section 1902(a)(10)(A)(ii)(XIII) of the "Social 46

Security Act," 42 U.S.C. 1396a(a)(10)(A)(ii)(XIII).

By requiring the medicaid program to provide coverage to
the optional eligibility group consisting of employed
individuals with disabilities under division (C) of section
5163.06 of the Revised Code, it is the intent of the general
assembly to establish medicaid coverage for employed individuals
with disabilities who are sixty-five years of age or older in a
manner that is consistent with the coverage provided to
individuals participating in the medicaid buy-in for workers
with disabilities program described in sections 5163.09 to
5163.098 of the Revised Code.

Section 2. That existing section 5163.06 of the Revised
Code is hereby repealed.

Section 3. Upon approval of a state plan amendment by the
United States Centers for Medicare and Medicaid Services
authorizing Medicaid coverage for the optional eligibility group
specified in section 1902(a)(10)(A)(ii)(XIII) of the "Social
Security Act," 42 U.S.C. 1396a(a)(10)(A)(ii)(XIII) and
authorized under sections 5163.06 and 5163.062 of the Revised
Code, the Medicaid Director may certify to the Director of
Budget and Management the necessary amount to pay for the
optional eligibility group described in this act in fiscal year
2022 and fiscal year 2023. Upon certification, the necessary
amounts, both state and federal shares, are hereby appropriated
to appropriation item 651525, Medicaid Health Care Services.

Section 4. Within the limits set forth in this act, the
Director of Budget and Management shall establish accounts
indicating the source and amount of funds for each appropriation
made in this act, and shall determine the form and manner in
which appropriation accounts shall be maintained. Expenditures

accounted for as though made in H.B. 110 of the 134th General	78
