

1 AN ACT relating to motor vehicle insurance.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔ Section 1. KRS 186A.040 is amended to read as follows:

4 (1) *As used in this section, unless the context requires otherwise:*

5 *(a) "Accessible online insurance verification system" or "system" means the*
6 *accessible online insurance verification system established by the*
7 *department under this section;*

8 *(b) "Commercial motor vehicle" means a motor vehicle that is covered by*
9 *commercial motor vehicle insurance;*

10 *(c) "Commercial motor vehicle insurance" means coverage:*

11 *1. Provided to an insured, regardless of the number of vehicles or entities*
12 *covered, under a commercial coverage form; and*

13 *2. Rated from a commercial manual approved by the Department of*
14 *Insurance;*

15 *(d) "Department" means the Department of Vehicle Regulation;*

16 *(e) "IICMVA" means the Insurance Industry Committee on Motor Vehicle*
17 *Administration or a successor organization;*

18 *(f) "Insurer" means an insurer that provides coverage for the security required*
19 *under KRS 304.39-080;*

20 *(g) "Personal motor vehicle" means a motor vehicle that is not covered by*
21 *commercial motor vehicle insurance; and*

22 *(h) "Requestor" means the authorized personnel of any of the following:*

23 *1. The department;*

24 *2. Any District or Circuit Court of this state;*

25 *3. Any county clerk of this state;*

26 *4. Any law enforcement agency of this state; or*

27 *5. Any other entities authorized by the department, to the extent*

1 permitted by state and federal privacy laws.

2 (2) (a) The department~~[of Vehicle Regulation]~~ shall:

3 1. Provide and receive information on the insurance status of motor
4 vehicles registered in~~[the Commonwealth of]~~ Kentucky in accordance
5 with this section and~~[pursuant to]~~ KRS 304.39-087 and 304.39-085;~~[-~~
6 The department shall provide appropriate insurance information to the
7 Commonwealth Office of Technology for inclusion in the AVIS
8 database to assist in identifying uninsured motor vehicles]

9 2. Establish an accessible online insurance verification system that:

10 a. Is used for verification of whether motor vehicles are covered by
11 the security required under KRS 304.39-080;

12 b. Is interfaced with AVIS;

13 c. Beginning not later than October 1, 2026, is:

14 i. Operational; and

15 ii. Available to insurers;

16 d. Beginning not later than January 1, 2027, is accessible by
17 requestors to assist the requestors in the identification of motor
18 vehicles that are not in compliance with KRS 304.39-080; and

19 e. Includes information that enables the department to make
20 inquiries to insurers by using multiple data elements for greater
21 matching accuracy;

22 3. On or before January 1, 2026, promulgate an emergency and ordinary
23 administrative regulation in accordance with KRS Chapter 13A to
24 establish, implement, and effectuate the accessible online insurance
25 verification system, which:

26 a. Shall:

27 i. Except as otherwise provided in this section, establish

1 guidelines and requirements for the system that are
2 consistent with IICMVA guidelines;

3 ii. Include appropriate provisions to secure the system's data
4 against unauthorized access;

5 iii. Specify, in accordance with subsection (3) of this section,
6 the information that insurers shall electronically submit,
7 and the format, manner, and frequency of the electronic
8 submissions, to the system for personal motor vehicles and
9 commercial motor vehicles; and

10 iv. Establish a period of not less than six (6) months but not
11 more than twelve (12) months from the date of all requests
12 and responses that system data shall be retained; and

13 b. May establish an alternative method of reporting, in lieu of
14 reporting to the system, for insurers who write one thousand
15 (1,000) or fewer policies or contracts that provide coverage for
16 the security required under KRS 304.39-080; and

17 4. Make any amendments to the administrative regulation promulgated
18 under this section or any other administrative regulation related to the
19 system that are necessary to establish, implement, operate, or maintain
20 the accessible online insurance verification system, which shall
21 include any necessary improvements to or replacement of the system.

22 (b) The department may contract with a private service provider who has
23 successfully implemented similar systems in other states to assist in
24 establishing, implementing, operating, and maintaining the accessible
25 online insurance verification system.

26 (c) 1. Notwithstanding KRS 13A.100, the department shall:

27 a. By January 1, 2026, publish on its website and distribute to

1 motor vehicle insurers authorized to do business in Kentucky a
2 final detailed guide of the accessible online insurance
3 verification system;

4 b. Periodically review, make any necessary updates to, and publish
5 on its website any updates to the guide referenced in this
6 subparagraph; and

7 c. Distribute any updates made to the guide referenced in this
8 subparagraph to motor vehicle insurers authorized to do
9 business in Kentucky.

10 2. The guide referenced in subparagraph 1. of this paragraph shall not
11 conflict with, or impose requirements that are not set out or
12 incorporated by reference in, an administrative regulation
13 promulgated by the department under this section.

14 3. The Department of Insurance shall assist the department in making
15 the distributions required under this paragraph.

16 (d) The department and any contracted private service provider shall each
17 maintain a contact person for insurers during the implementation and
18 operation of the accessible online insurance verification system.

19 ~~(3)~~~~(2)~~ (a) Except as otherwise provided in this section, insurers that provide
20 coverage for the security required under KRS 304.39-080 for personal
21 motor vehicles shall:

22 1. Cooperate with the department in the implementation, operation,
23 maintenance, and any necessary improvements to or replacement of
24 the accessible online insurance verification system; and

25 2. On and after January 1, 2027:

26 a. Send to the department:

27 i. A list of the vehicle identification numbers (VINs) of the

1 personal motor vehicles that are covered by the insurer;
2 and

3 ii. The name of each policyholder for each personal motor
4 vehicle covered by the insurer as specified by the
5 department;

6 b. Provide access to any other insurance status information for
7 personal motor vehicles that are covered by the insurer as
8 specified by the department; and

9 c. Submit the information required under this subparagraph
10 electronically to the department through the accessible online
11 insurance verification system.

12 (b) 1. In lieu of compliance with Section 9 of this Act, an insurer may opt to
13 submit insurance status information for commercial motor vehicles
14 electronically to the department through the accessible online
15 insurance verification system.

16 2. An insurer that opts to submit insurance status information under this
17 paragraph shall comply with any specifications and requirements
18 established by the department under subsection (2)(a)3.a.iii. of this
19 section for the information.

20 (c) Insurers may contract for the services of a third-party vendor to facilitate or
21 otherwise comply with the requirements of this section.

22 (d) Insurers shall not be subject to civil or administrative liability for libel,
23 slander, or any other relevant tort, and no civil cause of action of any
24 nature shall arise against an insurer or an authorized employee of an
25 insurer for any good-faith efforts to comply with this section, including but
26 not limited to submitting, or providing access to, any information or data
27 required or permitted under this section, even if the information or data is

1 inaccurate or incomplete.

2 (4) (a) As used in this subsection, "domestic" insurer and "foreign" insurer have
3 the same meanings as in KRS 304.1-070.

4 (b) There is created a technical advisory committee whose duties shall be to:

5 1. Review the establishment, implementation, operation, and
6 maintenance of the accessible online insurance verification system;
7 and

8 2. Make recommendations to the department to ensure that the
9 accessible online insurance verification system is:

10 a. Efficient and operational upon implementation; and

11 b. Consistent with the objectives and requirements of this section.

12 (c) The technical advisory committee shall be composed of the following seven
13 (7) members:

14 1. Four (4) voting members appointed by the commissioner of the
15 Department of Insurance in accordance with paragraph (d) of this
16 subsection;

17 2. The president of the Kentucky County Clerk's Association or the
18 president's designee, who shall serve as a voting ex officio member;

19 3. The commissioner of the Department of Insurance or the
20 commissioner's designee, who shall serve as a voting ex officio
21 member; and

22 4. The commissioner of the department or the commissioner's designee,
23 who shall serve as a nonvoting ex officio member and as chair of the
24 committee.

25 (d) 1. The commissioner of the Department of Insurance shall, in
26 accordance with this paragraph, appoint to the technical advisory
27 committee one (1) representative for each of the four (4) insurers:

a. Identified by the Department of Insurance under this paragraph;

and

b. That designate, upon request and within a reasonable amount of time, an individual to serve as a representative on the committee.

2. The Department of Insurance shall identify the following four (4) insurers:

a. The domestic property and casualty insurer that has the largest dollar amount of direct written premiums for motor vehicle insurance in Kentucky as of the date of the notification made under subparagraph 4. of this paragraph;

b. The two (2) foreign property and casualty insurers that have the largest dollar amounts of direct written premiums for motor vehicle insurance in Kentucky as of the date of the notification made under subparagraph 4. of this paragraph; and

c. A domestic or foreign property and casualty insurer with direct written premiums for motor vehicle insurance in Kentucky designated by the commissioner of the Department of Insurance to represent small and medium-sized insurers in Kentucky's motor vehicle insurance market.

3. If an insurer identified by the Department of Insurance under subparagraph 2. of this paragraph declines or fails, within a reasonable amount of time, to designate an individual to serve as a representative of the insurer on the technical advisory committee, the Department of Insurance shall identify:

a. For an insurer identified under subparagraph 2.a. of this paragraph, the domestic property and casualty insurer with the next largest dollar amount of direct written premiums for motor

1 vehicle insurance in Kentucky as of the date that the previously
2 identified domestic property and casualty insurer declined or
3 failed to designate a representative;

4 b. For an insurer identified under subparagraph 2.b. of this
5 paragraph, the foreign property and casualty insurer with the
6 next largest dollar amount of direct written premiums for motor
7 vehicle insurance in Kentucky as of the date that the previously
8 identified foreign property and casualty insurer declined or
9 failed to designate a representative; and

10 c. For an insurer identified under subparagraph 2.c. of this
11 paragraph, an insurer that meets the requirements of that
12 subdivision.

13 4. The Department of Insurance shall:

14 a. Request each insurer identified by the Department of Insurance
15 under subparagraph 2. of this paragraph, and if applicable,
16 subparagraph 3. of this paragraph, to designate an individual to
17 serve as a representative of the insurer on the technical advisory
18 committee; and

19 b. Appoint the individual designated by the insurer notified under
20 this subparagraph to the technical advisory committee.

21 5. Each member appointed under this paragraph shall serve a four (4)
22 year term and may be reappointed.

23 6. Vacancies of members appointed under this paragraph shall be filled:

24 a. Within thirty (30) days of the vacancy; and

25 b. In the same manner as the original appointment.

26 (e) Prior to making a filing under KRS Chapter 13A or publishing and
27 distributing, as applicable, the department shall submit drafts of the

1 following to the technical advisory committee for review and
2 recommendations:

3 1. Any new, amended, or repealer emergency or ordinary administrative
4 regulation, along with any forms required under KRS 13A.230,
5 required or permitted under this section or otherwise related to the
6 system; and

7 2. The final detailed guide, including any updates to the final detailed
8 guide, required under subsection (2)(c) of this section.

9 (f) In addition to the requirements of paragraph (e) of this subsection, the
10 department shall keep the technical advisory committee informed about,
11 and consult with the committee regarding, the establishment,
12 implementation, operation, and maintenance of the accessible online
13 insurance verification system.

14 (g) All meetings of, and communications to and from, the technical advisory
15 committee shall be exempt from the requirements of the Open Meetings Act,
16 KRS 61.805 to 61.850.

17 (5) (a) The department shall immediately make a notification to a motor vehicle
18 owner upon any of the following:

19 1. Notification to the department~~[of Vehicle Regulation]~~ from an
20 insurer~~[insurance company]~~ of cancellation or nonrenewal of the
21 owner's commercial motor vehicle insurance~~[a policy]~~ pursuant to
22 KRS 304.39-085;~~[, or]~~

23 2. Prior to January 1, 2027~~[on and after January 1, 2006]~~, if the vehicle
24 identification number (VIN) of the owner's~~[a]~~ personal motor vehicle,
25 as defined in subsection (1)(a) of Section 10 of this Act, does not
26 appear in the database created by KRS 304.39-087 for two (2)
27 consecutive reporting months; or

1 3. On and after January 1, 2027, if the vehicle identification number
2 (VIN) of the owner's personal motor vehicle, or commercial motor
3 vehicle if the commercial motor vehicle is covered by an insurer that
4 has opted to report to the system, does not appear in the accessible
5 online insurance verification system for seven (7) consecutive days;
6 ~~the department shall immediately make a determination as to the~~
7 ~~notification of the insured~~.

8 (b) The notification required under paragraph (a) of this subsection shall:

9 1. Be in either a paper or an electronic format;

10 2. Specify each motor vehicle to which the notification pertains; and

11 3. ~~to the insured shall~~ State that:

12 a. The owner's insurance~~insured's policy~~ is no longer valid; and ~~that~~
13 ~~that~~

14 b. The department shall revoke the registration of each motor
15 vehicle to which the notification pertains unless one (1) of the
16 following occurs within fourteen (14)~~insured shall have thirty~~
17 ~~(30)~~ days after the date the insurance became invalid~~; to~~

18 i. The owner provides~~Show~~ proof of insurance to the county
19 clerk or the department; or

20 ii. The accessible online insurance verification system
21 indicates that the motor vehicle or motor vehicles are
22 covered by the security required under KRS 304.39-080;~~;~~

23 ~~The department shall further inform the insured that if~~
24 ~~evidence of insurance is not received within thirty (30) days~~
25 ~~the department shall revoke the registration of the motor~~
26 ~~vehicle until:~~

27 ~~1. The person presents proof of insurance to the county clerk and pays the~~

1 reinstatement fee required by KRS 186.180;

2 ~~2. The person presents proof in the form of an affidavit stating, under~~
3 ~~penalty of perjury as set forth in KRS 523.030, that the failure to~~
4 ~~maintain motor vehicle insurance on the vehicle specified in the~~
5 ~~department's notification is the result of the inoperable condition of the~~
6 ~~motor vehicle;~~

7 ~~3. The person presents proof in the form of an affidavit stating, under~~
8 ~~penalty of perjury as set forth in KRS 523.030, that the failure to~~
9 ~~maintain motor vehicle insurance on the vehicle specified in the~~
10 ~~department's notification is the result of the seasonal nature of the~~
11 ~~vehicle. The affidavit shall explain that when the vehicle is out of~~
12 ~~dormancy and when the seasonal use of the vehicle is resumed, the~~
13 ~~proper security will be obtained; or~~

14 ~~4. The person presents proof in the form of an affidavit stating, under~~
15 ~~penalty of perjury as set forth in KRS 523.030, that he or she requires a~~
16 ~~registered motor vehicle in order to carry out his or her employment and~~
17 ~~that the motor vehicle that he or she drives during the course of his or~~
18 ~~her employment meets the security requirement of Subtitle 39 of KRS~~
19 ~~Chapter 304. The person shall also declare in the affidavit that he or she~~
20 ~~will operate a motor vehicle only in the course of his or her~~
21 ~~employment. If a person has his or her motor vehicle registration~~
22 ~~revoked in accordance with this subsection three (3) times within any~~
23 ~~twelve (12) month period, the revocations shall constitute a violation of~~
24 ~~KRS 304.39-080. The department shall notify the county attorney to~~
25 ~~begin prosecution for violation of subtitle 39 of KRS Chapter 304.~~

26 ~~(b) The Department of Vehicle Regulation shall be responsible for notification to~~
27 ~~the appropriate county attorney that a motor vehicle is not properly insured, if~~

1 the insured does not respond to notification set out by paragraph (a) of this
2 subsection. The notice that the department gives to the county attorney in
3 accordance with paragraph (a) of this subsection shall include a certified copy
4 of the person's driving record which shall include:

5 1. The notice that the department received from an insurance company that
6 a person's motor vehicle insurance policy has been canceled or has not
7 been renewed; and

8 2. A dated notice that the department sent to the person requiring the
9 person to present proof of insurance to the county clerk.

10 Upon notification by the department, a county attorney shall
11 immediately begin prosecution of the person who had his or her motor
12 vehicle registration revoked three (3) times within any twelve (12)
13 month period in accordance with paragraph (a) of this subsection.]

14 (c) An owner may present the proof of insurance required under this
15 subsection in either a paper or an electronic format [The certified copies sent
16 by the department described in paragraph (b) of this subsection, shall be prima
17 facie evidence of a violation of KRS 304.39-080].

18 (d) When proof of insurance is provided in electronic format, the department or
19 county clerk may require the owner to email or otherwise electronically
20 submit the proof of insurance for the department's or clerk's records [If the
21 insured provides proof of insurance to the clerk within the thirty (30) day
22 notification period, the department shall ensure action is taken to denote a
23 valid insurance policy is in force].

24 (6) [(3)] (a) In developing the mechanism to electronically transfer information
25 pursuant to this section and KRS 304.39-087 and 304.39-085, the
26 commissioner of the department [of Vehicle Regulation] shall:

27 1. Consult with the commissioner of the Department of Insurance and

1 insurers of ~~personal~~ motor vehicles to adopt a standardized system of
 2 organizing, recording, and transferring the information so as to
 3 minimize insurer administrative expenses; and ~~The commissioner of~~
 4 ~~vehicle regulation shall~~

5 2. To the maximum extent possible, utilize nationally recognized
 6 electronic data information systems consistent with the requirements of
 7 this section ~~[such as those developed by the American National~~
 8 ~~Standards Institute or the American Association of Motor Vehicle~~
 9 ~~Administrators]~~.

10 (b) Notwithstanding any other provision of law: ~~[,]~~

11 1. Information obtained by the department pursuant to this section and
 12 KRS 304.39-087 shall not be:

13 a. Subject to the Kentucky Open Records Act, KRS 61.870 ~~[61.872]~~
 14 to 61.884; or ~~[, and shall not be]~~

15 b. Disclosed, used, sold, accessed, or utilized in any manner, or
 16 released by the department to any individual, entity ~~[person,~~
 17 ~~corporation]~~, or state or ~~[and]~~ local agency, except:

18 i. In accordance with state law for the purposes specified by
 19 this section; or

20 ii. In response to a specific individual request for the
 21 information authorized pursuant to the federal Driver's
 22 Privacy Protection Act, 18 U.S.C. sec. ~~[secs.]~~ 2721 et seq.;

23 2. The department shall institute measures to ensure that only authorized
 24 persons are permitted to access the information referenced in this
 25 paragraph for the purposes specified by this section; and ~~[,]~~

26 3. Persons who knowingly release or disclose information ~~[from the~~
 27 ~~database created by KRS 304.39-087]~~ for a purpose other than those

described as} authorized by this paragraph~~[section]~~ or to a person not entitled to receive it shall be guilty of a Class A misdemeanor for each release or disclosure.

(7) The Commonwealth Office of Technology and the Department of Insurance shall provide support and assistance to the department in carrying out the provisions of this section.

➔Section 2. KRS 186A.042 is amended to read as follows:

(1) As used in this section, the following have the same meaning as in Section 1 of this Act:

(a) "Accessible online insurance verification system"; and

(b) "Personal motor vehicle."

(2) ~~[On and after January 1, 2006,]~~A county clerk shall not process an application for, nor issue, a:

(a) Kentucky title and registration or renewal of registration;

(b) Replacement plate, decal, or registration certificate;

(c) Duplicate registration;

(d) Transfer of registration; or

(e) Temporary tag;

for any personal motor vehicle~~[as defined in KRS 304.39-087(1)]~~ if **the accessible online insurance verification system**~~[AVIS]~~ does not list the vehicle identification number of the personal motor vehicle as an insured vehicle, except as provided in subsection **(3)**~~[(2)]~~ of this section.

(3)~~[(2)]~~ If **the accessible online insurance verification system**~~[AVIS]~~ does not list the vehicle identification number of the personal motor vehicle as an insured vehicle, the county clerk may process the application if :

(a) The applicant has an insurance card in **either a** paper or **an** electronic format that indicates the required security is currently in full force **and effect** on the

1 personal motor vehicle if the paper or electronic proof of insurance card was
2 effective no more than seven (7)~~forty-five (45)~~ days before the application is
3 submitted to the county clerk; or

4 (b) The owner of the motor vehicle:

5 1. Is serving in the Armed Forces outside of Kentucky;~~;~~ and~~the owner~~

6 2. Provides an affidavit by the provost marshal of the base where the
7 owner is stationed stating that the motor vehicle is covered by security
8 as required by Subtitle 39 of KRS Chapter 304.

9 (4)~~(3)~~ This section shall not apply to any transactions involving Kentucky motor
10 vehicle dealers who are licensed as required by KRS 190.030.

11 (5)~~(4)~~ For purposes of this section:

12 (a) An insurance card in an electronic format means the display of an image
13 subject to immediate download or transmission from the applicant's insurer or
14 insurance agent to the applicant on an~~any portable~~ electronic device,
15 including a cellular phone or any other type of portable electronic device, but
16 shall not include a photographic copy of a paper insurance card on a portable
17 electronic device; and

18 (b) The county clerk may require the applicant to email~~e-mail~~ the electronic
19 insurance card to the clerk, and the clerk may print a copy of the card for the
20 clerk's records.

21 ➔Section 3. KRS 186A.100 is amended to read as follows:

22 (1) (a) A motor vehicle dealer licensed under KRS 186.070 who sells a vehicle for
23 use upon the highways of this state shall equip the vehicle with a temporary
24 tag executed in the manner prescribed below, which shall be valid for sixty
25 (60) days from the date the vehicle is delivered to the purchaser.

26 (b) The cost of the tag shall be two dollars (\$2), of which the county clerk shall
27 retain one dollar (\$1).

- 1 (c) A motor vehicle dealer licensed under KRS 186.070 shall apply to the county
2 clerk of the county in which the dealer maintains his or her principal place of
3 business for issuance of temporary tags. Application shall be made for such
4 tags on forms supplied to the county clerk by the Transportation Cabinet.
- 5 (2) The county clerk of any county who receives a proper application for issuance of
6 temporary tags shall record the number of each tag issued upon the application of
7 the dealer for such tags, or if a group of consecutively numbered temporary tags are
8 issued to a dealer in connection with a single application, record the beginning and
9 ending numbers of the group on the application.
- 10 (3) The clerk shall retain, for a period of two (2) years, one (1) copy of the dealer's
11 temporary tag application, and ensure that it reflects the numbers appearing on the
12 tags issued with respect to such application.
- 13 (4) (a) If the owner of a motor vehicle submits to the county clerk a properly
14 completed application for Kentucky certificate of title and registration
15 pursuant to KRS 186A.120, any motor vehicle required to be registered and
16 titled in Kentucky, that is not currently registered and titled in Kentucky, may
17 be equipped with a temporary tag, which shall be valid for sixty (60) days
18 from the date of issuance, issued by the county clerk for the purpose of
19 operating the vehicle in Kentucky while assembling the necessary documents
20 in order to title and register the vehicle in Kentucky.
- 21 (b) The Transportation Cabinet may promulgate~~establish~~ administrative
22 regulations in accordance with KRS Chapter 13A governing this

- 24 (5) (a) The county clerk may issue a temporary tag to the owner of a motor vehicle
25 that is currently registered and titled in Kentucky.
- 26 (b) A temporary tag authorized by this subsection shall be used for emergency or
27 unusual purposes as determined by the county clerk for the purpose of

1 maintaining the owner's current registration.

2 (c) A temporary tag authorized by this subsection may only be issued by the
3 county clerk and shall be valid for a period of between twenty-four (24) hours
4 and seven (7) days, as determined is necessary by the clerk.

5 (d) A county clerk shall not issue a temporary tag authorized by this subsection
6 unless the owner of the motor vehicle applying for the tag presents proof of
7 motor vehicle insurance pursuant to KRS 304.39-080. ~~On and after January~~
8 ~~1, 2006, If the motor vehicle is a personal motor vehicle as defined in KRS~~
9 ~~304.39-087,]~~Proof of insurance for a personal motor vehicle shall be
10 determined by the county clerk as provided in KRS 186A.042.

11 (e) A temporary tag issued pursuant to this subsection shall not be reissued by the
12 county clerk for the same owner and same motor vehicle within one (1) year
13 of issuance of a temporary tag.

14 ➔Section 4. KRS 186.021 is amended to read as follows:

15 (1) Except as provided in subsection (2) of this section, a county clerk shall not issue a
16 replacement plate, decal, or registration certificate as provided in KRS 186.180, or a
17 registration for renewal to any person who on January 1 of any year owned a motor
18 vehicle on which state, county, city, urban-county government, school, or special
19 taxing district ad valorem taxes are delinquent.

20 (2) (a) Pursuant to KRS 134.810(4), the owner as defined in KRS 186.010(7)(a) and
21 (c) on January 1 of any year shall be liable for taxes due on a motor vehicle.

22 (b) A person other than the owner of record who applies to a county clerk to
23 transfer the registration of a motor vehicle may pay any delinquent ad valorem
24 taxes due on the motor vehicle to facilitate the county clerk's transferring
25 registration of the motor vehicle.

(c) When a person provides evidence of financial responsibility using an~~a mobile~~ electronic device to a peace officer, the peace officer shall only view the electronic image of the insurance card and is prohibited from viewing any other content on the~~mobile~~ electronic device.

➔Section 12. By July 1, 2025:

(1) The Department of Insurance shall identify and appoint the initial four insurer

1 representatives to the technical advisory committee created under subsection (4) of
2 Section 1 of this Act in accordance with paragraph (d) of that subsection; and

3 (2) The Department of Vehicle Regulation shall notify the members of the
4 technical advisory committee created under subsection (4) of Section 1 of this Act of the
5 date, time, and location of the first meeting, which meeting may include remote
6 attendance and shall:

7 (a) Take place within 30 days of the date of the notification; and

8 (b) Include an informational status update from the department relating to the
9 establishment and implementation of the accessible online insurance verification system.
