6           WHEREAS, we take great pride and pleasure in  
7 honoring Mr. Tim Hudson of Auburn, Alabama, for his  
8 outstanding athletic achievements, his extraordinary  
9 professional baseball career, and his philanthropy benefitting  
10 the children of Alabama and Georgia; and

11           WHEREAS, Hudson attended Glenwood School in Phenix  
12 City, Alabama, Chattahoochee Valley Community College, and  
13 Auburn University; he earned top baseball honors and holds  
14 numerous records and titles; he met his wife, Kim Bruner,  
15 while he was a student at Auburn and together they have three  
16 children, Kennedie, Tess, and Kade; and

17           WHEREAS, during his professional baseball career,  
18 Hudson played with the Oakland Athletics from 1999-2004, the  
19 Atlanta Braves 2005-2013, and the San Francisco Giants  
20 2014-2015; he continued to set records and earn a multitude of  
21 honors and awards during his professional career including:  
22 2010 Hutch Award, 2010 Major League Baseball Comeback Player  
23 of the Year; four-time All-Star, 2000, 2004, 2010, and 2014;  
24 and three-time Top 10 in American League Cy Young Award  
25 voting; and

1           WHEREAS, retiring in 2015 as the winningest active  
2 Major League pitcher, Hudson has since served as a guest  
3 instructor and a spring training instructor; he is also known  
4 for his faith and his willingness to give back to the citizens  
5 of Alabama, particularly the children; and

6           WHEREAS, Tim and Kim Hudson have been active in  
7 numerous charitable organizations providing a positive impact  
8 on many of our citizens; in 2009 they established the Hudson  
9 Family Foundation to serve those persons in Alabama and  
10 Georgia who need assistance in specific physical, emotional,  
11 or financial circumstances; and

12           WHEREAS, his unwavering commitment to excellence in  
13 athletics and his philanthropy reflect immense credit upon the  
14 entire State of Alabama; Tim has enriched countless lives  
15 through his meritorious life's work, and he is truly deserving  
16 of special recognition; it is a tremendous privilege to  
17 recognize Tim Hudson and welcome him as a special guest on a  
18 legislative day; now therefore,

19           BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
20 HOUSES THEREOF CONCURRING, That it is a unique privilege to
