Mr. Stewart introduced the following bill; which was referred to the Committee on Foreign Affairs

## A BILL

- To prohibit the use of funds to propose amendments to the International Health Regulations, the Global Pandemic Treaty, or any other agreement among World Health Organization member states, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SENSE OF CONGRESS.
  - 4 Congress finds that absent a United States with-
  - 5 drawal from the World Health Organization (WHO), the
  - 6 United States should hold the WHO accountable and over-
  - 7 haul its operations, including by—

1	(1) ensuring the People's Republic of China is
2	held accountable for the COVID-19 pandemic and
3	for failing to comply with the International Health
4	Regulations;
5	(2) ensuring the WHO conducts a thorough in-
6	vestigation into the role that the People's Republic
7	of China played in the origin and spread of COVID-
8	19; and
9	(3) ensuring the United States does not relin-
10	quish any authorities to the WHO that would super-
11	sede any new or existing United States authorities.

6	SEC. 3. PROHIBITION ON USE OF FUNDS TO PROVIDE CON-
7	TRIBUTIONS TO THE WORLD HEALTH ORGA-
8	NIZATION.
9	Notwithstanding any other provision of law, no funds
10	available to any Federal department or agency may be
11	used to provide contributions to the World Health Organi-
12	zation (WHO) unless and until the Secretary of State cer-
13	tifies to Congress that—
14	(1) the WHO—
15	(A) holds the People's Republic of China
16	accountable for failing to comply with the Inter-
17	national Health Regulations; and
18	(B) makes available a report of its findings
19	and actions under subparagraph (A);
20	(2) the steps the WHO is taking to ensure Chi-
21	na's accountability, including the role China played
22	in the origin and spread of COVID-19; and
23	(3) the steps the WHO is taking to strengthen
24	accountability and its ability to be impartial and ob-

- 1 jective while improving its transparency and its over-
- 2 all effectiveness.
- 3 SEC. 4. INTERNATIONAL HEALTH REGULATIONS DEFINED.
- 4 In this Act, the term "International Health Regula-
- 5 tions" means the International Health Regulations adopt-
- 6 ed by the 58th World Health Assembly in 2005 under Res-
- 7 olution WHA58.3.
