- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 13 That the Laws of Maryland read as follows:

- 16 (a) (1) The Department shall audit the books of any person who packs or deals
- 17 in fish resources within the jurisdiction of the Department including anyone who catches
- 18 and ships directly to market.
- 19 (2) The Department audit shall be conducted to determine the quantity of
- 20 resources caught and any other data needed for reporting and accounting to State officials.
- 21 (b) (1) Every person engaged in the business of packing or dealing in any fish
- 22 resource within the Department's jurisdiction shall keep accurate books, statements, and
- 23 accounts showing every detail of the business.



- 1 **(2)** Every book, statement, and account shall be open for the Department 2 to inspect at reasonable hours.
- 3 (3) Every person engaged in the business of packing or dealing in any fish 4 resource within the Department's jurisdiction shall [make] SUBMIT any report the 5 Department requires [on forms the Department prescribes] IN ACCORDANCE WITH 6 REGULATIONS ADOPTED BY THE SECRETARY.
- 7 (c) Every person the Department licenses to catch the fish resource shall [make] 8 SUBMIT any report the Department requires [on forms the Department provides] IN 9 ACCORDANCE WITH REGULATIONS ADOPTED BY THE SECRETARY.
- 10 (d) (1) An officer or employee of any department or unit of the Executive 11 Branch of State government may not divulge or use in any manner information contained 12 in any report submitted pursuant to the provisions of this section that would reveal the 13 income of any person submitting the report.
- 14 **(2)** This section does not prohibit the publication of statistics classified to prevent the identification of particular reports and items of them or prohibit inspection of reports and records by any official or employee of the Executive Branch having a proper interest in them.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024.
