AN ACT

Making further continuing appropriations for the fiscal year ending September 30, 2022, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Further Additional Ex-
- 5 tending Government Funding Act".

7 CONTINUING APPROPRIATIONS ACT, 2022

- 8 Sec. 101. The Continuing Appropriations Act, 2022
- 9 (division A of Public Law 117–43) is further amended—
- 10 (1) by striking the date specified in section
- 11 106(3) and inserting "March 11, 2022";
- 12 (2) in section 163, by striking "\$200,000,000"
- and inserting "\$300,000,000"; and
- 14 (3) by adding after section 163 the following
- 15 new sections:
- 16 "Sec. 164. Notwithstanding sections 102 and 104,
- 17 amounts made available by section 101 to the Department
- 18 of Defense for 'Shipbuilding and Conversion, Navy' may
- 19 be apportioned up to the rate for operations necessary for
- 20 'Columbia Class Submarine (AP)' in an amount not to ex-
- 21 ceed \$1,601,805,000.
- "Sec. 165. (a) Notwithstanding sections 101 and
- 23 106 of this Act, for the duration of fiscal year 2022,

- 1 amounts made available in fiscal year 2022 to the Depart-
- 2 ment of Defense under the heading 'Operation and Main-
- 3 tenance', other than amounts designated by the Congress
- 4 as being for an emergency requirement pursuant to sec-
- 5 tion 4001(a)(1) and section 4001(b) of S. Con. Res. 14
- 6 (117th Congress), the concurrent resolution on the budget
- 7 for fiscal year 2022, may be used for emergencies and ex-
- 8 traordinary expenses, in addition to any other funds spe-
- 9 cifically made available for such expenses, for purposes the
- 10 Secretary of Defense or the Secretary of the Navy, as ap-
- 11 propriate, determines to be proper with regard to the re-
- 12 sponse to the disruption of the water supply near the Red
- 13 Hill Bulk Fuel Storage Facility, on O'ahu, Hawaii, in ac-
- 14 cordance with 10 U.S.C. 127, in an amount not to exceed
- 15 \$53,000,000: Provided, That not later than 30 days after
- 16 the date of enactment of the Further Additional Con-
- 17 tinuing Appropriations Act, 2022 and every 30 days there-
- 18 after through fiscal year 2022, the Secretary of Defense
- 19 shall submit a report to the Committees on Appropriations
- 20 of the House of Representatives and Senate, setting forth

- 8 remain available until September 30, 2022;
- 9 "'Military Personnel, Marine Corps',
- \$5,206,000, to remain available until September 30,
- 11 2022;
- 12 "'Military Personnel, Air Force', \$27,564,000,
- to remain available until September 30, 2022;
- 14 "'Operation and Maintenance, Army',
- 15 \$22,640,000, to remain available until September
- 16 30, 2022; and
- 17 "'Operation and Maintenance, Navy',
- 18 \$70,000,000, to remain available until September
- 19 30, 2022.
- 20 "(c) In addition to amounts otherwise provided by
- 21 this Act, there is appropriated to the Department of De-
- 22 fense \$100,000,000, for an additional amount for fiscal
- 23 year 2022, to remain available until expended, for transfer
- 24 only to accounts under the headings 'Operation and Main-
- 25 tenance', 'Procurement', 'Research, Development, Test

- 1 and Evaluation', and 'Defense Working Capital Funds',
- 2 for the Secretary of Defense to conduct activities in com-
- 3 pliance with the State of Hawaii Department of Health
- 4 Order 21-UST-EA-02, signed December 6, 2021, related
- 5 to the removal of fuel from and improvement of infrastruc-
- 6 ture at the Red Hill Bulk Fuel Storage Facility: Provided,
- 7 That the transfer authority provided in this subsection is
- 8 in addition to any other transfer authority available to the
- 9 Department of Defense: Provided further, That amounts
- 10 provided in this subsection shall not be available for trans-
- 11 fer, obligation, or expenditure until the Secretary of De-
- 12 fense briefs the Committees on Appropriations of the
- 13 House of Representatives and Senate regarding the rec-
- 14 ommendations of the third-party assessment of the oper-
- 15 ations and system integrity of the Red Hill facility and
- 16 the Department's own analysis regarding the distribution
- 17 of fuel reserves for operations in the Pacific theater, as
- 18 well as other activities recommended by the third-party as-
- 19 sessment or Departmental analysis: Provided further, That
- 20 not less than 15 days prior to any transfer of funds pursu-
- 21 ant to this subsection, the Secretary of Defense shall no-
- 22 tify the congressional defense committees of the details of
- 23 any such transfer: Provided further, That not later than
- 24 60 days after the date of enactment of the Further Addi-

- 9 scorecard maintained for purposes of section 4106 of H.
- 10 Con. Res. 71 (115th Congress).
- 11 (c) Classification of Budgetary Effects.—
- 12 Notwithstanding Rule 3 of the Budget Scorekeeping
- 13 Guidelines set forth in the joint explanatory statement of
- 14 the committee of conference accompanying Conference Re-
- 15 port 105-217 and section 250(c)(8) of the Balanced
- 16 Budget and Emergency Deficit Control Act of 1985, the
- 17 budgetary effects of this division shall not be estimated—
- 18 (1) for purposes of section 251 of such Act;
- 19 (2) for purposes of an allocation to the Com-
