A BILL TO BE ENTITLED

AN ACT TO PERMIT CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA TO PROVIDE DISCOUNTED TUITION TO PERSONS RECEIVING MILITARY TUITION ASSISTANCE OR PERSONS ENROLLED IN AN EMPLOYER-SPONSORED FINANCIAL SUPPORT PROGRAM.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 116-143 reads as rewritten:

"§ 116-143. State-supported institutions of higher education required to charge tuition and fees.

 (c) Inasmuch as the giving of tuition and fee waivers, or especially reduced rates, represent in effect a variety of scholarship awards, the said practice is hereby prohibited except when expressly authorized by statute.

- (d) Notwithstanding the above provision relating to the abolition of free tuition, subsection (c) of this section, the Board of Governors of The University of North Carolina may, in its discretion, provide do any of the following:
 - (1) Provide regulations under which personnel may during the period of normal employment enroll in The University of North Carolina free of charge for tuition and fees, provided such enrollment does not interfere with normal employment obligations and further provided that such enrollments are not counted for the purpose of receiving General Fund appropriations as follows:
 - (1)a. Except as provided in subdivision (2) of this subsection, sub-subdivision b. of this subdivision, a full-time faculty member of the rank of full-time instructor or above and any full-time staff member of The University of North Carolina may enroll in not more than three courses per year.
 - (2)b. A full-time or part-time campus law enforcement officer may enroll in the number of courses per year determined by regulation.
 - (2) Permit constituent institutions to provide discounted tuition to enrolled students, in the discretion of the constituent institution, as follows:
 - a. For qualifying military students, by an amount of up to the difference in the maximum amount of military tuition assistance funds the student receives and the applicable rate of tuition. For purposes of this

5			2. Receives either federal military tuition assistance funds or

9		<u>b.</u>	For students who are enrolled in an employer-sponsored financial
10			support program that is approved by the Board of Governors, by an
11			amount of up to the difference in the maximum amount provided by
12			the employer and the applicable rate of tuition. For purposes of this
13			sub-subdivision, an employer-sponsored financial support program is
14			a program in which the employer of a student has committed to
15			provide financial support to the student to offset the costs of tuition or
16			fees in the student's degree or credential program.
