## A BILL

- To require directors of medical centers of the Department of Veterans Affairs to submit annual fact sheets to the Secretary of Veterans Affairs on the status of such facilities, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "VA Medical Center
  - 5 Facility Transparency Act".

#### SEC. 2. INFORMATION ON MEDICAL FACILITIES OF THE DE-2 PARTMENT OF VETERANS AFFAIRS. 3 (a) Fact Sheets.—The Secretary of Veterans Affairs shall ensure that each director of a medical center 4 5 of the Department of Veterans Affairs submits to the Secretary, the Committees on Veterans' Affairs of the House 6 7 of Representatives and the Senate, and the appropriate Members of Congress the following: 9 (1) An annual concise, easy-to-read fact sheet 10 containing, with respect to the year covered by the 11 fact sheet: 12 (A) Statistics regarding— 13 (i) the number of veterans who were 14 treated at a medical facility of the Depart-15 ment under the jurisdiction of the director; 16 (ii) the number of appointments con-17 ducted by each such facility; 18 (iii) the most common illnesses or con-19 ditions for which treatment was furnished; 20 (iv) the satisfaction of veterans who 21 were treated at each such facility; 22 (v) how each such facility compares with other facilities with respect to the sat-23 24 isfaction of veterans who were treated at 25 the facilities; and

1	(vi) other matters the director deter-
2	mines appropriate.
3	(B) A description of any successes or
4	achievements experienced by such facilities, in-
5	cluding—
6	(i) actions taken to improve such fa-
7	cilities;
8	(ii) actions taken to improve the ac-
9	cess to and quality of the care provided at
10	such facilities; and
11	(iii) any other accomplishments deter-
12	mined appropriate by the director.
13	(C) A description of special areas of em-
14	phasis or specialization by such facilities, such
15	as efforts aimed at meeting the needs of women
16	veterans, suicide prevention and other mental
17	health initiatives, opioid abuse prevention and
18	pain management, or special efforts on veteran
19	homelessness, or other matters as the director
20	determines appropriate.
21	(D) A description of matters concerning
22	such facilities that have previously been identi-
23	fied as deficient and needing remediation that
24	are still in need of such remediation.

1	(2) A quarterly fact sheet containing, with re-
2	spect to the quarter covered by the fact sheet, the
3	average wait time for veterans to receive treatment
4	at the medical facility of the Department under the
5	jurisdiction of the director.
6	(b) AVAILABILITY.—Each fact sheet under sub-
7	section (a) shall be made publicly available—
8	(1) in a physical form at the relevant medical
9	facility of the Department in a conspicuous location;
10	and
11	(2) in an electronic form on the internet website
12	of the facility.
13	(c) TIMING OF FACT SHEETS.—The fact sheets
14	under subsection (a) shall be submitted during the first
15	fiscal year beginning after the date that is 180 days after
16	the date of the enactment of this Act and not less fre-
17	quently than—
18	(1) once each fiscal year thereafter with respect
19	to the annual fact sheet under paragraph (1) of such
20	subsection; and
21	(2) once each fiscal quarter thereafter with re-
22	spect to the quarterly fact sheet under paragraph
23	(2) of such subsection.
24	(d) STANDARDIZED FORMAT.—The Secretary shall
25	establish a standard format for the fact sheets under sub-

- 1 section (a) to ensure that each director of a medical center
- 2 of the Department carries out such subsection in a con-
- 3 sistent manner.

- 4 (e) Definitions.—In this section:
- (1) The term "appropriate Members of Con-5 gress" means, with respect to a medical facility of 6 7 the Department of Veterans Affairs about which a fact sheet is submitted under subsection (a), the 8 9 Senators representing the State, and the Member, Delegate, or Resident Commissioner of the House of 10 11 Representatives representing the district, that in-12 cludes the facility.
  - (2) The term "State" means each of the several States, the District of Columbia, the Commonwealth of Puerto Rico, and any territory or possession of the United States.
