

22	$\frac{a}{a}$ A summary of seizure and forfeiture activity in
23	the state for the preceding fiscal year.
24	$\frac{b}{(2)}$ The type, approximate value, and disposition of
25	the property seized and forfeited.
26	$\frac{c}{c}$ The amount of any proceeds received.
27	(2) (b) The summary for data on seizures and forfeitures
28	may be disaggregated by the commission. The aggregate report

29	shall also be made available on the website of the Alabama
30	Justice Information Commission consistent with the format of
31	other reports posted on the commission's website and shall
32	contain all civil case numbers assigned in state court.
33	(b)(c) The Alabama Justice Information Commission may
34	include in the report required under subsection (a)this
35	section recommendations to improve laws, rules, and policies
36	to better ensure that seizure, forfeiture, and expenditures
37	are done and reported in a manner that is fair to crime
38	victims, innocent property owners, secured interest holders,
39	citizens, law enforcement, and taxpayers."
