A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Sign Language Interpreter Act**

3 FOR the purpose of establishing the State Board of Sign Language Interpreters in the
4 Maryland Department of Labor; providing that certain provisions of law do not apply
5 to certain individuals; providing for the composition of the Board and the
6 appointment, terms, qualifications, expenses, and removal of the Board members;
7 providing for the chair, term of the chair, meetings, and quorum of the Board;
8 authorizing the Board to perform certain acts to enforce certain provisions of law;
9 providing for the powers and duties of the Board; requiring the Board to establish
10 criteria for the development of certain specialty area portfolios and certain
11 requirements for certain services; requiring the Board to maintain a certain list of
12 licensees and to make the list available to the public; authorizing the Board to set
13 certain fees for certain purposes; requiring certain fees to be paid to the Comptroller,
14 and the Comptroller to distribute certain fees in a certain manner; establishing the
15 Sign Language Interpreters Fund; providing for the purpose and administration of
16 the Fund; providing that the Fund is a special, nonlapsing fund; requiring the State
17 Treasurer to hold the Fund separately, and the Comptroller to account for the Fund;
18 providing for the contents of the Fund; providing for certain uses of the Fund;
19 requiring the State Treasurer to invest the money of the Fund in a certain manner;
20 requiring certain investment earnings to be credited to the General Fund of the
21 State; providing that certain expenditures must be made in accordance with the
22 State budget; requiring the Board to confirm the license status and qualifications of
23 an individual in a certain manner under certain circumstances; providing that the
24 Board exercises its powers, duties, and functions subject to the authority of the
25 Secretary of Labor; requiring an individual, except under certain circumstances, to
26 be licensed by the Board before the individual may provide sign language
27 interpretation services in the State or make certain representations; establishing
28 certain qualifications for a license to provide sign language interpretation services;
29 authorizing the Board to waive certain requirements for a certain license under
30 certain circumstances; requiring the Board to issue a certain license in a certain
31 manner; providing that certain licenses are not transferable; providing for the scope

of certain licenses; requiring a licensee to provide a certain notice to the Board to change certain information on a license within a certain period of time; providing for the renewal, reinstatement, and reactivation of certain licenses; authorizing the Board to adopt certain regulations regarding continuing professional competency requirements; providing for the issuance, term, scope, and renewal of a provisional license; authorizing the Board to impose certain sanctions on certain license holders or applicants under certain circumstances; authorizing an individual sanctioned by the Board to submit a certain request for review in a certain manner; authorizing the Board to take certain actions on review; requiring the Board to commence certain proceedings on receipt of a certain complaint; establishing certain hearing procedures; establishing that certain confidentiality and privileges apply to sign language interpreters; establishing certain penalties for certain violations of law; authorizing certain individuals to report certain violations of law to the Board within a certain period of time; requiring the Board to provide a certain written notice under certain circumstances; authorizing a certain person to bring a certain action in court under certain circumstances; requiring that an evaluation of the Board and the statutes and regulations that relate to the Board be performed on or before a certain date; providing for a delayed effective date for certain licensing requirements; requiring the Board to develop and implement a certain public awareness campaign; providing that holding a certain certification satisfies a certain licensing requirement for members initially appointed to the Board; providing for the terms of the initial members of the Board; requiring the Governor to include a certain amount in the budget bill for a certain fiscal year for a certain purpose; defining certain terms; and generally relating to the State Board of Sign Language Interpreters.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That Section(s) 2–108(a)(23) through (33), respectively, of Article – Business Regulation of
the Annotated Code of Maryland be renumbered to be Section(s) 2–108(a)(24) through (34),
respectively.

SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 8–403(58) through

SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
as follows:

Article – Business Occupations and Professions

TITLE 22. SIGN LANGUAGE INTERPRETERS.

SUBTITLE 1. DEFINITIONS; GENERAL PROVISIONS.

22–101.

(A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS
INDICATED.

(B) “AMERICAN SIGN LANGUAGE” MEANS A VISUAL–SPATIAL METHOD OF
COMMUNICATION THAT IS A DISTINCT LANGUAGE INVOLVING THE HANDS, ARMS,
FACIAL MARKERS, AND BODY MOVEMENTS TO COMMUNICATE WITH OTHERS,
INCLUDING THROUGH THE CONVEYANCE OF THOUGHTS, WORDS, EMOTIONS, AND
GRAMMATICAL INFORMATION.

(C) “BEHAVIORAL HEALTH SETTING” MEANS A SETTING THAT PROVIDES:

(1) PSYCHIATRIC OR PSYCHOLOGICAL ASSESSMENT OR SCREENING;

(2) GROUP OR INDIVIDUAL PSYCHOTHERAPY, COUNSELING, OR

1 TREATMENT; OR

2 (3) REHABILITATION SERVICES FOR SUBSTANCE USE DISORDERS,
3 ADDICTIVE DISORDERS, MENTAL DISORDERS, OR A COMBINATION OF THESE
4 DISORDERS.

5 (D) “BOARD” MEANS THE STATE BOARD OF SIGN LANGUAGE
6 INTERPRETERS.

7 (E) “DIRECTOR” MEANS THE DIRECTOR OF THE OFFICE OF THE DEAF AND
8 HARD OF HEARING.

9 (F) “FUND” MEANS THE SIGN LANGUAGE INTERPRETERS FUND
10 ESTABLISHED UNDER § 22–210 OF THIS TITLE.

11 (G) “LEGAL SETTING” INCLUDES:

12 (1) COURT PROCEEDINGS;

13 (2) ATTORNEY–CLIENT CONFERENCES;

14 (3) INVESTIGATIONS BY LAW ENFORCEMENT;

15 (4) DEPOSITIONS;

16 (5) WITNESS INTERVIEWS;

17 (6) REAL ESTATE SETTLEMENTS; AND

18 (7) ADMINISTRATIVE HEARINGS.

19 (H) “LICENSE” MEANS A LICENSE ISSUED UNDER THIS TITLE TO PROVIDE
20 SIGN LANGUAGE INTERPRETATION SERVICES.

21 (I) “MEDICAL SETTING” INCLUDES:

22 (1) AN ACUTE CARE HOSPITAL;

23 (2) AN URGENT CARE CENTER;

24 (3) AN OUTPATIENT CLINIC;

25 (4) SHORT–TERM CARE FACILITIES;

1 **(5) LONG-TERM CARE FACILITIES;**

2 **(6) A PHYSICIAN'S OFFICE; AND**

3 **(7) HOME HEALTH CARE.**

4 **(J) "NATIONALLY RECOGNIZED CERTIFICATION" MEANS:**

5 **(1) CERTIFICATION ISSUED BY:**

6 **(I) THE NATIONAL ASSOCIATION OF THE DEAF; OR**

7 **(II) THE REGISTRY OF INTERPRETERS FOR THE DEAF; OR**

8 **(2) ANY OTHER CERTIFICATION ISSUED BY A NATIONAL**
9 **ORGANIZATION THAT IS RECOGNIZED BY THE BOARD.**

10 **(K) "OFFICE" MEANS THE OFFICE OF THE DEAF AND HARD OF HEARING**
11 **ESTABLISHED UNDER § 9-2402 OF THE STATE GOVERNMENT ARTICLE.**

12 **(L) (1) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES" MEANS**
13 **TO CONVEY THE MEANING OF A MESSAGE THAT IS EXPRESSED IN:**

14 **(I) AN ORAL LANGUAGE BY RENDERING THE MESSAGE IN**
15 **AMERICAN SIGN LANGUAGE; OR**

16 **(II) AMERICAN SIGN LANGUAGE BY RENDERING THE MESSAGE**
17 **IN AN ORAL LANGUAGE.**

18 **(2) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES"**
19 **INCLUDES PROVIDING SERVICES THROUGH VIDEO REMOTE INTERPRETING.**

20 **(M) "SCHOOL SETTING" MEANS A SETTING IN WHICH THE FOLLOWING IS**
21 **PROVIDED:**

22 **(1) EDUCATIONAL PROGRAMS OR SERVICES OFFERED BY A PUBLIC**
23 **OR PRIVATE SCHOOL; OR**

24 **(2) CAREER TRAINING PROGRAMS FOR SECONDARY EDUCATION**
25 **STUDENTS THAT ARE REGULATED BY THE STATE DEPARTMENT OF EDUCATION.**

26 **(N) "SIGN LANGUAGE INTERPRETER" MEANS AN INDIVIDUAL WHO IS**

LICENSED BY THE BOARD TO PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES.

(O) "VIDEO RELAY SERVICE" MEANS THE FEDERALLY REIMBURSED AND REGULATED PROGRAM ESTABLISHED TO ENABLE PHONE CALLS BETWEEN USERS OF AMERICAN SIGN LANGUAGE AND INDIVIDUALS WHO DO NOT USE AMERICAN SIGN LANGUAGE BY VIDEOCONFERENCING TECHNOLOGY AND THE USE OF THE SERVICES OF A REMOTELY LOCATED SIGN LANGUAGE INTERPRETER.

(P) (1) "VIDEO REMOTE INTERPRETING SETTING" MEANS PROVIDING SIGN LANGUAGE INTERPRETATION SERVICES BY VIDEOCONFERENCING IN WHICH AT LEAST ONE INDIVIDUAL IS AT A SEPARATE LOCATION.

(2) "VIDEO REMOTE INTERPRETING SETTING" DOES NOT INCLUDE A VIDEO RELAY SERVICE.

22-102.

THE PURPOSES OF THIS TITLE ARE TO ENSURE EFFECTIVE COMMUNICATIONS FOR DEAF, DEAF-BLIND, AND HARD OF HEARING INDIVIDUALS AND TO PROMOTE THE PUBLIC WELFARE BY REGULATING INDIVIDUALS WHO PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES IN THE STATE.

22-103.

THIS TITLE DOES NOT APPLY TO AN INDIVIDUAL WHO:

(1) IS ENGAGED IN SIGN LANGUAGE INTERPRETING AS PART OF A SUPERVISED INTERNSHIP OR PRACTICUM FOR AN ACCREDITED INSTITUTION OF HIGHER EDUCATION, IF THE SIGN LANGUAGE INTERPRETING IS NOT IN:

(I) A BEHAVIORAL HEALTH SETTING, UNLESS THE INDIVIDUAL IS ACCOMPANIED BY A LICENSED SIGN LANGUAGE INTERPRETER;

(II) AN EMERGENCY MEDICAL SETTING, UNLESS THE INDIVIDUAL IS ACCOMPANIED BY A LICENSED SIGN LANGUAGE INTERPRETER;

(III) A LEGAL SETTING; OR

(IV) AN ELEMENTARY OR SECONDARY EDUCATION SETTING;

(2) IS ENGAGED IN SIGN LANGUAGE INTERPRETING AS PART OF A VIDEO REMOTE INTERPRETING SETTING;

(3) IS ENGAGED IN SIGN LANGUAGE INTERPRETING AS PART OF A VIDEO RELAY SERVICE;

(4) (I) HOLDS A NATIONALLY RECOGNIZED CERTIFICATION IN SIGN LANGUAGE INTERPRETING;

(II) DOES NOT PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES IN THE STATE FOR MORE THAN 80 HOURS EACH CALENDAR YEAR;

(III) SELF-CERTIFIES ELIGIBILITY FOR THIS EXEMPTION; AND

(IV) NOTIFIES THE BOARD OF EACH SIGN LANGUAGE INTERPRETING ASSIGNMENT THE INDIVIDUAL COMPLETES WITHIN 10 DAYS AFTER PROVIDING SIGN LANGUAGE INTERPRETATION SERVICES;

(5) ENGAGES IN SIGN LANGUAGE INTERPRETATION AS AN UNCOMPENSATED VOLUNTEER AND IN A SETTING IN WHICH A SIGN LANGUAGE INTERPRETER IS NOT OTHERWISE REQUIRED BY LAW;

(6) PROVIDES SIGN LANGUAGE INTERPRETATION SERVICES TO PREVENT UNDUE HARM IN THE EVENT OF AN EMERGENCY UNTIL A LICENSED SIGN LANGUAGE INTERPRETER CAN ARRIVE; OR

(7) INTERPRETS BETWEEN A PAIR OF SIGNED LANGUAGES FOR WHICH THERE IS NO EXISTING CERTIFICATION.

SUBTITLE 2. STATE BOARD OF SIGN LANGUAGE INTERPRETERS.

22-201.

THERE IS A STATE BOARD OF SIGN LANGUAGE INTERPRETERS IN THE DEPARTMENT.

22-202.

(A) (1) THE BOARD CONSISTS OF EIGHT MEMBERS.

(2) THE MEMBERS SHALL BE APPOINTED BY THE GOVERNOR AS FOLLOWS:

(I) ONE SHALL BE A DEAF MEMBER OF THE MARYLAND ADVISORY COUNCIL FOR THE DEAF AND HARD OF HEARING;

(II) ONE SHALL BE A MEMBER OF THE MARYLAND ASSOCIATION OF THE DEAF;

(III) ONE SHALL BE A DEAF-BLIND INDIVIDUAL WHO IS A MEMBER OF A DEAF-BLIND ORGANIZATION IN THE STATE;

(IV) ONE SHALL BE A MEMBER OF THE POTOMAC CHAPTER OF THE REGISTRY OF THE INTERPRETERS FOR THE DEAF WHO HOLDS A LICENSE UNDER SUBTITLE 3 OF THIS TITLE;

(V) TWO SHALL BE DEAF INDIVIDUALS WHO HOLD A LICENSE UNDER SUBTITLE 3 OF THIS TITLE; AND

(VI) TWO SHALL BE HEARING INDIVIDUALS WHO HOLD A LICENSE UNDER SUBTITLE 3 OF THIS TITLE.

(3) THE GOVERNOR SHALL APPOINT THE MEMBERS FROM A LIST OF NAMES SUBMITTED TO THE GOVERNOR FROM A NOMINATION PROCESS ESTABLISHED BY THE OFFICE.

(4) TO THE EXTENT PRACTICABLE, THE MEMBERS APPOINTED BY THE GOVERNOR UNDER PARAGRAPH (2) OF THIS SUBSECTION SHALL REFLECT THE RACIAL AND GEOGRAPHIC DIVERSITY OF THE STATE.

(B) EACH MEMBER OF THE BOARD MUST:

(1) BE A RESIDENT OF THE STATE; AND

(2) BE PROFICIENT IN AMERICAN SIGN LANGUAGE.

(C) (1) THE TERM OF A MEMBER IS 2 YEARS, BEGINNING ON THE DATE OF APPOINTMENT.

(2) THE TERMS OF THE MEMBERS ARE STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE BOARD ON OCTOBER 1, 2021.

(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

1 **(5) A MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE FULL**
2 **TERMS.**

3 **(D) BEFORE TAKING OFFICE, EACH APPOINTEE TO THE BOARD SHALL TAKE**
4 **THE OATH OR AFFIRMATION REQUIRED BY ARTICLE I, § 9 OF THE MARYLAND**
5 **CONSTITUTION.**

6 **(E) (1) THE GOVERNOR MAY REMOVE A MEMBER FOR INCOMPETENCE,**
7 **MISCONDUCT, NEGLECT OF DUTIES, OR OTHER SUFFICIENT CAUSE.**

8 **(2) THE GOVERNOR SHALL REMOVE A MEMBER WHO:**

9 **(I) CEASES TO MEET THE REQUIREMENTS UNDER WHICH THE**
10 **MEMBER WAS APPOINTED, AS PROVIDED UNDER SUBSECTIONS (A) AND (B) OF THIS**
11 **SECTION; OR**

12 **(II) FAILS TO ATTEND AT LEAST 50% OF THE REGULARLY**
13 **SCHEDULED MEETINGS OF THE BOARD DURING ANY 12-MONTH PERIOD.**

14 **22-203.**

15 **(A) THE BOARD SHALL ELECT THE CHAIR OF THE BOARD FROM AMONG ITS**
16 **MEMBERS.**

17 **(B) THE TERM OF THE CHAIR IS 2 YEARS.**

18 **22-204.**

19 **(A) A MAJORITY OF THE MEMBERS THEN SERVING ON THE BOARD IS A**
20 **QUORUM.**

21 **(B) (1) THE BOARD SHALL MEET AT LEAST ONE TIME EACH QUARTER AT**
22 **THE TIMES AND PLACES SET BY THE BOARD.**

23 **(2) THE BOARD MAY CALL SPECIAL MEETINGS AT THE REQUEST OF:**

24 **(I) THE CHAIR;**

25 **(II) THE DIRECTOR; OR**

26 **(III) A MAJORITY OF THE MEMBERS OF THE BOARD.**

(C) EACH MEMBER OF THE BOARD:

(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;

BUT

(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

(D) (1) THE OFFICE SHALL ASSIGN AN APPROPRIATE NUMBER OF STAFF TO MANAGE THE OPERATIONS OF THE BOARD.

(2) THE STAFF SHALL BE RESPONSIBLE FOR ASSISTING THE BOARD IN CARRYING OUT ITS RESPONSIBILITIES UNDER THIS TITLE, INCLUDING:

(I) PROVIDING INFORMATION TO THE PUBLIC ABOUT SIGN LANGUAGE INTERPRETER LICENSING REQUIREMENTS;

(II) PROVIDING TECHNICAL ASSISTANCE TO LICENSE APPLICANTS AND OTHER INTERESTED PERSONS;

(III) PROMOTING THE PROFESSION OF SIGN LANGUAGE INTERPRETING, INCLUDING PROVIDING WORKSHOPS AND TRAININGS TO RAISE PUBLIC AWARENESS AND TO FACILITATE PROFESSIONAL DEVELOPMENT; AND

(IV) ANY OTHER ACTIVITIES ASSIGNED BY THE BOARD OR THE DIRECTOR.

22-205.

TO ENFORCE THIS TITLE, THE BOARD MAY:

(1) CONDUCT INVESTIGATIONS AND HOLD HEARINGS ON ANY MATTER COVERED BY THIS TITLE, AT ANY TIME AND PLACE IN THE STATE;

(2) ADMINISTER OATHS;

(3) EXAMINE WITNESSES; AND

(4) RECEIVE EVIDENCE.

22-206.

(A) IN ADDITION TO ANY POWERS SET FORTH ELSEWHERE AND WITH THE

1 **SUPPORT OF THE OFFICE, THE BOARD SHALL ADOPT:**

2 **(1) BYLAWS FOR THE CONDUCT OF ITS PROCEEDINGS; AND**

3 **(2) REGULATIONS TO CARRY OUT THIS TITLE.**

4 **(B) IN ADDITION TO ANY DUTIES SET FORTH ELSEWHERE AND WITH THE**
5 **SUPPORT OF THE OFFICE, THE BOARD SHALL:**

6 **(1) ADMINISTER THIS TITLE;**

7 **(2) ADOPT A SEAL;**

8 **(3) KEEP A RECORD OF ITS PROCEEDINGS;**

9 **(4) KEEP A FILE ON EACH APPLICANT FOR A LICENSE;**

10 **(5) ESTABLISH A VISITING SIGN LANGUAGE INTERPRETER REGISTRY;**

11 **AND**

12 **(6) DEVELOP AND MAINTAIN AN INTERNET PORTAL TO ACCEPT**
13 **LICENSE APPLICATIONS AND RELATED DOCUMENTATION, COMPLAINTS, AND**
14 **REGISTRATIONS OF VISITING SIGN LANGUAGE INTERPRETERS.**

15 **22-207.**

16 **(A) (1) THE BOARD SHALL ESTABLISH CRITERIA FOR THE DEVELOPMENT**
17 **OF PORTFOLIOS IN THE FOLLOWING SPECIALIST AREAS:**

18 **(I) LEGAL SETTINGS;**

19 **(II) MEDICAL SETTINGS;**

20 **(III) BEHAVIORAL HEALTH SETTINGS;**

21 **(IV) LANGUAGE PAIRS FOR OTHER THAN AMERICAN SIGN**
22 **LANGUAGE AND SPOKEN ENGLISH;**

23 **(V) CONFERENCE INTERPRETING; AND**

24 **(VI) ANY OTHER SPECIALIST AREAS CONSIDERED NECESSARY BY**
25 **THE BOARD.**

(2) A PORTFOLIO FOR A SPECIALIST AREA MAY INCLUDE DEMONSTRATION OF NECESSARY SKILLS AND TRAINING BUT MAY NOT INCLUDE A SCREENING ASSESSMENT, TESTING, OR CERTIFICATION BY THE BOARD.

(B) THE BOARD SHALL ESTABLISH REQUIREMENTS FOR:

(1) PROVIDING SIGN LANGUAGE INTERPRETATION SERVICES IN:

(I) A BEHAVIORAL HEALTH SETTING;

(II) A LEGAL SETTING; OR

(III) A MEDICAL SETTING;

(2) INTRALINGUISTIC TRANSLATIONS AND SIGN LANGUAGE INTERPRETATION; AND

(3) TACTILE AND LOW-VISION SIGN LANGUAGE INTERPRETATION SERVICES.

22-208.

(A) THE BOARD SHALL MAINTAIN A LIST OF THE NAMES AND MAILING ADDRESSES OF ALL LICENSEES, INCLUDING BY LICENSE TYPE.

(B) THE BOARD MAY RELEASE THE LIST TO THE PUBLIC.

(C) A LICENSEE SHALL DESIGNATE THE LICENSEE'S MAILING ADDRESS AT THE TIME OF ISSUANCE OF THE ORIGINAL LICENSE AND ON THE RENEWAL OF THE LICENSE.

22-209.

(A) (1) THE BOARD SHALL SET BY REGULATION REASONABLE FEES FOR ITS SERVICES.

(2) THE FEES SHALL BE SET SO AS TO PRODUCE FUNDS TO APPROXIMATE THE COST OF MAINTAINING THE BOARD.

(B) THE BOARD SHALL PUBLISH THE FEE SCHEDULE SET BY THE BOARD.

(C) (1) THE BOARD SHALL PAY ALL FEES COLLECTED UNDER THIS TITLE TO THE COMPTROLLER.
