Income Tax - Credit for Travel, Hospitality, and Entertainment Expenses

3 FOR the purpose of allowing an individual to claim a credit against the State income tax for certain travel, hospitality, and entertainment expenses paid or incurred by the 4 5 individual during certain taxable years under certain circumstances; providing that 6 the credit may not exceed a certain amount and that a credit may not be allowed for 7 certain expenses for which the individual claimed a certain federal deduction; 8 providing that any unused amount of the credit may not be carried over to any other 9 taxable year; requiring the Department of Commerce, on application by an individual, to issue a tax credit certificate in a certain amount; providing for the form 10 11 and content of the application; requiring the Department to approve applications for 12 the credit on a first-come, first-served basis and to provide certain notice to the 13 applicant; providing that the total amount of tax credit certificates issued in a 14 taxable year may not exceed a certain amount; requiring the Department to report 15 certain information to the Comptroller on or before a certain date each year; 16 requiring the Department and the Comptroller to jointly adopt certain regulations; 17 defining certain terms; providing for the termination of this Act; and generally relating to a credit against the State income tax for travel, hospitality, and 18 19 entertainment expenses.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 4 (2) "DEPARTMENT" MEANS THE DEPARTMENT OF COMMERCE.
- 5 (3) "QUALIFIED EXPENSES" MEANS ANY OF THE FOLLOWING
- 6 EXPENSES PAID OR INCURRED BY AN INDIVIDUAL DURING ANY PERIOD OF

5 6	B. \$8,000 FOR A MARRIED COUPLE FILING A JOINT TAX RETURN; AND
7 8	2. AN AMOUNT EQUAL TO THE PRODUCT OF \$500 MULTIPLIED BY THE NUMBER OF DEPENDENT CHILDREN OF THE INDIVIDUAL.
9 10 11	(2) A CREDIT MAY NOT BE ALLOWED UNDER THIS SECTION WITH RESPECT TO ANY QUALIFIED EXPENSES FOR WHICH THE INDIVIDUAL CLAIMED A DEDUCTION UNDER § 162(A)(2) OF THE INTERNAL REVENUE CODE.
12 13 14	(3) IF THE CREDIT ALLOWED UNDER THIS SECTION IN ANY TAXABLE YEAR EXCEEDS THE STATE INCOME TAX FOR THAT TAXABLE YEAR, THE UNUSED AMOUNT OF THE CREDIT MAY NOT BE CARRIED OVER TO ANY OTHER TAXABLE YEAR.

- 4 (F) THE DEPARTMENT AND THE COMPTROLLER JOINTLY SHALL ADOPT 5 REGULATIONS TO:
