A BILL

To amend section 4501.21 and to enact section 1
4503.703 of the Revised Code to create the 2
"Loyal Order of the Moose" license plate. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and section 4
4503.703 of the Revised Code be enacted to read as follows: 5

Sec. 4501.21. (A) There is hereby created in the state 6
treasury the license plate contribution fund. The fund shall 7
consist of all contributions for specialty license plates paid 8
by motor vehicle registrants and collected by the registrar of 9
motor vehicles pursuant to the Revised Code sections referenced 10
in division (B) of this section. 11

(B) The registrar shall pay the contributions the 12
registrar collects in the fund as follows: 13

The registrar shall pay the contributions received 14
pursuant to section 4503.491 of the Revised Code to the breast 15
cancer fund of Ohio, which shall use that money only to pay for 16
programs that provide assistance and education to Ohio breast 17
cancer patients and that improve access for such patients to 18
quality health care and clinical trials and shall not use any of 19

the money for abortion information, counseling, services, or 20
other abortion-related activities. 21

The registrar shall pay the contributions the registrar 22
receives pursuant to section 4503.492 of the Revised Code to the 23
organization cancer support community central Ohio, which shall 24
deposit the money into the Sheryl L. Kraner Fund of that 25
organization. Cancer support community central Ohio shall expend 26
the money it receives pursuant to this division only in the same 27
manner and for the same purposes as that organization expends 28
other money in that fund. 29

The registrar shall pay the contributions received 30
pursuant to section 4503.493 of the Revised Code to the autism 31
society of Ohio, which shall use the contributions for programs 32
and autism awareness efforts throughout the state. 33

The registrar shall pay the contributions the registrar 34
receives pursuant to section 4503.494 of the Revised Code to the 35
national multiple sclerosis society for distribution in equal 36
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 37
chapters of the national multiple sclerosis society. These 38
chapters shall use the money they receive under this section to 39
assist in paying the expenses they incur in providing services 40
directly to their clients. 41

The registrar shall pay the contributions the registrar 42
receives pursuant to section 4503.495 of the Revised Code to the 43
national pancreatic cancer foundation, which shall use the money 44
it receives under this section to assist those who suffer with 45
pancreatic cancer and their families. 46

The registrar shall pay the contributions the registrar 47
receives pursuant to section 4503.496 of the Revised Code to the 48

Ohio sickle cell and health association, which shall use the 49
contributions to help support educational, clinical, and social 50
support services for adults who have sickle cell disease. 51

The registrar shall pay the contributions the registrar 52
receives pursuant to section 4503.497 of the Revised Code to the 53
St. Baldrick's foundation, which shall use the contributions for 54
its research and other programs. 55

The registrar shall pay the contributions the registrar 56
receives pursuant to section 4503.498 of the Revised Code to 57
special olympics Ohio, inc., which shall use the contributions 58
for its programs, charitable efforts, and other activities. 59

The registrar shall pay the contributions the registrar 60
receives pursuant to section 4503.499 of the Revised Code to the 61
children's glioma cancer foundation, which shall use the 62
contributions for its research and other programs. 63

The registrar shall pay the contributions the registrar 64
receives pursuant to section 4503.4910 of the Revised Code to 65
the KylerStrong foundation, which shall use the contributions to 66
raise awareness of brain cancer caused by diffuse intrinsic 67
pontine glioma and to fund research for the cure of such cancer. 68

The registrar shall pay the contributions the registrar 69
receives pursuant to section 4503.4911 of the Revised Code to 70
the research institution for childhood cancer at nationwide 71
children's hospital, which shall use the contributions to fund 72
research for the cure of childhood cancers. 73

The registrar shall pay the contributions the registrar 74
receives pursuant to section 4503.50 of the Revised Code to the 75
future farmers of America foundation, which shall deposit the 76
contributions into its general account to be used for 77

educational and scholarship purposes of the future farmers of 78
America foundation. 79

The registrar shall pay the contributions the registrar 80
receives pursuant to section 4503.501 of the Revised Code to the 81
4-H youth development program of the Ohio state university 82
extension program, which shall use those contributions to pay 83
the expenses it incurs in conducting its educational activities. 84

The registrar shall pay the contributions received 85
pursuant to section 4503.502 of the Revised Code to the Ohio 86
cattlemen's foundation, which shall use those contributions for 87
scholarships and other educational activities. 88

The registrar shall pay the contributions received 89
pursuant to section 4503.505 of the Revised Code to the 90
organization Ohio region phi theta kappa, which shall use those 91
contributions for scholarships for students who are members of 92
that organization. 93

The registrar shall pay the contributions the registrar 94
receives pursuant to section 4503.506 of the Revised Code to 95
Ohio demolay, which shall use the contributions for 96
scholarships, educational programs, and any other programs or 97
events the organization holds or sponsors in this state. 98

The registrar shall pay the contributions received 99
pursuant to section 4503.508 of the Revised Code to the 100
organization bottoms up diaper drive to provide funding for that 101
organization for collecting and delivering diapers to parents in 102
need. 103

The registrar shall pay the contributions the registrar 104
receives pursuant to section 4503.509 of the Revised Code to a 105
kid again, incorporated for distribution in equal amounts to the 106

Ohio chapters of a kid again. 107

The registrar shall pay each contribution the registrar 108
receives pursuant to section 4503.51 of the Revised Code to the 109
university or college whose name or marking or design appears on 110
collegiate license plates that are issued to a person under that 111
section. A university or college that receives contributions 112
from the fund shall deposit the contributions into its general 113
scholarship fund. 114

The registrar shall pay the contributions the registrar 115
receives pursuant to section 4503.514 of the Revised Code to the 116
university of Notre Dame in South Bend, Indiana, for purposes of 117
awarding grants or scholarships to residents of Ohio who attend 118
the university. The university shall not use any of the funds it 119
receives for purposes of administering the scholarship program. 120
The registrar shall enter into appropriate agreements with the 121
university of Notre Dame to effectuate the distribution of such 122
funds as provided in this section. 123

The registrar shall pay the contributions the registrar 124
receives pursuant to section 4503.521 of the Revised Code to the 125
Ohio bicycle federation to assist that organization in paying 126
for the educational programs it sponsors in support of Ohio 127
cyclists of all ages. 128

The registrar shall pay the contributions the registrar 129
receives pursuant to section 4503.522 of the Revised Code to the 130
"friends of Perry's victory and international peace memorial, 131
incorporated," a nonprofit corporation organized under the laws 132
of this state, to assist that organization in paying the 133
expenses it incurs in sponsoring or holding charitable, 134
educational, and cultural events at the monument. 135

The registrar shall pay the contributions the registrar 136
receives pursuant to section 4503.523 of the Revised Code to the 137
fairport lights foundation, which shall use the money to pay for 138
the restoration, maintenance, and preservation of the 139
lighthouses of fairport harbor. 140

The registrar shall pay the contributions the registrar 141
receives pursuant to section 4503.524 of the Revised Code to the 142
Massillon tiger football booster club, which shall use the 143
contributions only to promote and support the football team of 144
Washington high school of the Massillon city school district. 145

The registrar shall pay the contributions the registrar 146
receives pursuant to section 4503.525 of the Revised Code to the 147
United States power squadron districts seven, eleven, twenty- 148
four, and twenty-nine in equal amounts. Each power squadron 149
district shall use the money it receives under this section to 150
pay for the educational boating programs each district holds or 151
sponsors within this state. 152

The registrar shall pay the contributions the registrar 153
receives pursuant to section 4503.526 of the Revised Code to the 154
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 155
international, which shall use the money it receives under this 156
section to pay the costs of its educational and humanitarian 157
activities. 158

The registrar shall pay the contributions the registrar 159
receives pursuant to section 4503.528 of the Revised Code to the 160
Ohio children's alliance, which shall use the money it receives 161
under this section to pay the expenses it incurs in advancing 162
its mission of sustainably improving the provision of services 163
to children, young adults, and families in this state. 164

The registrar shall pay the contributions the registrar receives pursuant to section 4503.529 of the Revised Code to the Ohio nurses foundation. The foundation shall use the money it receives under this section to provide educational scholarships to assist individuals who aspire to join the nursing profession, to assist nurses in the nursing profession who seek to advance their education, and to support persons conducting nursing research concerning the evidence-based practice of nursing and the improvement of patient outcomes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.531 of the Revised Code to the thank you foundation, incorporated, a nonprofit corporation organized under the laws of this state, to assist that organization in paying for the charitable activities and programs it sponsors in support of United States military personnel, veterans, and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.534 of the Revised Code to the disabled American veterans department of Ohio, to be used for programs that serve disabled American veterans and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.55 of the Revised Code to the pro football hall of fame, which shall deposit the contributions into a special bank account that it establishes and which shall be separate and distinct from any other account the pro football hall of fame maintains, to be used exclusively for the purpose of promoting the pro football hall of fame as a travel destination.

The registrar shall pay the contributions that are paid to

the registrar pursuant to section 4503.545 of the Revised Code 195
to the national rifle association foundation, which shall use 196
the money to pay the costs of the educational activities and 197
programs the foundation holds or sponsors in this state. 198

The registrar shall pay to the Ohio pet fund the 199
contributions the registrar receives pursuant to section 200
4503.551 of the Revised Code and any other money from any other 201
source, including donations, gifts, and grants, that is 202
designated by the source to be paid to the Ohio pet fund. The 203
Ohio pet fund shall use the moneys it receives under this 204
section to support programs for the sterilization of dogs and 205
cats and for educational programs concerning the proper 206
veterinary care of those animals, and for expenses of the Ohio 207
pet fund that are reasonably necessary for it to obtain and 208
maintain its tax-exempt status and to perform its duties. 209

The registrar shall pay the contributions the registrar 210
receives pursuant to section 4503.552 of the Revised Code to the 211
rock and roll hall of fame and museum, incorporated. 212

The registrar shall pay the contributions the registrar 213
receives pursuant to section 4503.553 of the Revised Code to the 214
Ohio coalition for animals, incorporated, a nonprofit 215
corporation. Except as provided in division (B) of this section, 216
the coalition shall distribute the money to its members, and the 217
members shall use the money only to pay for educational, 218
charitable, and other programs of each coalition member that 219
provide care for unwanted, abused, and neglected horses. The 220
Ohio coalition for animals may use a portion of the money to pay 221
for reasonable marketing costs incurred in the design and 222
promotion of the license plate and for administrative costs 223
incurred in the disbursement and management of funds received 224

under this section. 225

The registrar shall pay the contributions the registrar 226
receives pursuant to section 4503.554 of the Revised Code to the 227
Ohio state council of the knights of Columbus, which shall use 228
the contributions to pay for its charitable activities and 229
programs. 230

The registrar shall pay the contributions the registrar 231
receives pursuant to section 4503.555 of the Revised Code to the 232
western reserve historical society, which shall use the 233
contributions to fund the Crawford auto aviation museum. 234

The registrar shall pay the contributions the registrar 235
receives pursuant to section 4503.556 of the Revised Code to the 236
Erica J. Holloman foundation, inc., for the awareness of triple 237
negative breast cancer. The foundation shall use the 238
contributions for charitable and educational purposes. 239

The registrar shall pay each contribution the registrar 240
receives pursuant to section 4503.557 of the Revised Code to the 241
central Ohio chapter of the Ronald McDonald house charities, 242
which shall distribute the contribution to the chapter of the 243
Ronald McDonald house charities in whose geographic territory 244
the person who paid the contribution resides. 245

The registrar shall pay the contributions the registrar 246
receives pursuant to section 4503.561 of the Revised Code to the 247
state of Ohio chapter of ducks unlimited, inc., which shall 248
deposit the contributions into a special bank account that it 249
establishes. The special bank account shall be separate and 250
distinct from any other account the state of Ohio chapter of 251
ducks unlimited, inc., maintains and shall be used exclusively 252
for the purpose of protecting, enhancing, restoring, and 253

managing wetlands and conserving wildlife habitat. The state of 254
Ohio chapter of ducks unlimited, inc., annually shall notify the 255
registrar in writing of the name, address, and account to which 256
such payments are to be made. 257

The registrar shall pay the contributions the registrar 258
receives pursuant to section 4503.562 of the Revised Code to the 259
Mahoning river consortium, which shall use the money to pay the 260
expenses it incurs in restoring and maintaining the Mahoning 261
river watershed. 262

The registrar shall pay the contributions the registrar 263
receives pursuant to section 4503.564 of the Revised Code to the 264
Glen Helen association to pay expenses related to the Glen Helen 265
nature preserve. 266

The registrar shall pay the contributions the registrar 267
receives pursuant to section 4503.565 of the Revised Code to the 268
conservancy for Cuyahoga valley national park, which shall use 269
the money in support of the park. 270

The registrar shall pay the contributions the registrar 271
receives pursuant to section 4503.566 of the Revised Code to the 272
Ottawa national wildlife refuge, which shall use the 273
contributions for wildlife preservation purposes. 274

The registrar shall pay the contributions the registrar 275
receives pursuant to section 4503.567 of the Revised Code to the 276
girls on the run of Franklin county, inc., which shall use the 277
contributions to support the activities of the organization. 278

The registrar shall pay the contributions the registrar 279
receives pursuant to section 4503.576 of the Revised Code to the 280
Ohio state beekeepers association, which shall use those 281
contributions to promote beekeeping, provide educational 282

information about beekeeping, and to support other state and 283
local beekeeping programs. 284

The registrar shall pay the contributions the registrar 285
receives pursuant to section 4503.577 of the Revised Code to the 286
national aviation hall of fame, which shall use the 287
contributions to fulfill its mission of honoring aerospace 288
legends to inspire future leaders. 289

The registrar shall pay the contributions the registrar 290
receives pursuant to section 4503.579 of the Revised Code to the 291
national council of negro women, incorporated, which shall use 292
the contributions for educational purposes. 293

The registrar shall pay the contributions the registrar 294
receives pursuant to section 4503.581 of the Revised Code to the 295
Ohio sons of the American legion, which shall use the 296
contributions to support the activities of the organization. 297

The registrar shall pay to a sports commission created 298
pursuant to section 4503.591 of the Revised Code each 299
contribution the registrar receives under that section that an 300
applicant pays to obtain license plates that bear the logo of a 301
professional sports team located in the county of that sports 302
commission and that is participating in the license plate 303
program pursuant to division (E) of that section, irrespective 304
of the county of residence of an applicant. 305

The registrar shall pay to a community charity each 306
contribution the registrar receives under section 4503.591 of 307
the Revised Code that an applicant pays to obtain license plates 308
that bear the logo of a professional sports team that is 309
participating in the license plate program pursuant to division 310
(G) of that section. 311

The registrar shall pay the contributions the registrar 312
receives pursuant to section 4503.592 of the Revised Code to 313
pollinator partnership's monarch wings across Ohio program, 314
which shall use the contributions for the protection and 315
preservation of the monarch butterfly and pollinator corridor in 316
Ohio and for educational programs. 317

The registrar shall pay the contributions the registrar 318
receives pursuant to section 4503.594 of the Revised Code to 319
pelotonia, which shall use the contributions for the purpose of 320
supporting cancer research. 321

The registrar shall pay the contributions the registrar 322
receives pursuant to section 4503.595 of the Revised Code to the 323
Stan Hywet hall and gardens. 324

The registrar shall pay the contributions the registrar 325
receives pursuant to section 4503.596 of the Revised Code to the 326
Cuyahoga valley scenic railroad. 327

The registrar shall pay the contributions the registrar 328
receives pursuant to section 4503.67 of the Revised Code to the 329
Dan Beard council of the boy scouts of America. The council 330
shall distribute all contributions in an equitable manner 331
throughout the state to regional councils of the boy scouts. 332

The registrar shall pay the contributions the registrar 333
receives pursuant to section 4503.68 of the Revised Code to the 334
girl scouts of Ohio's heartland. The girl scouts of Ohio's 335
heartland shall distribute all contributions in an equitable 336
manner throughout the state to regional councils of the girl 337
scouts. 338

The registrar shall pay the contributions the registrar 339
receives pursuant to section 4503.69 of the Revised Code to the 340

Dan Beard council of the boy scouts of America. The council 341
shall distribute all contributions in an equitable manner 342
throughout the state to regional councils of the boy scouts. 343

The registrar shall pay the contributions the registrar 344
receives pursuant to section 4503.70 of the Revised Code to the 345
charitable foundation of the grand lodge of Ohio, f. & a. m., 346
which shall use the contributions for scholarship purposes. 347

The registrar shall pay the contributions the registrar 348
receives pursuant to section 4503.701 of the Revised Code to the 349
Prince Hall grand lodge of free and accepted masons of Ohio, 350
which shall use the contributions for scholarship purposes. 351

The registrar shall pay the contributions the registrar 352
receives pursuant to section 4503.702 of the Revised Code to the 353
Ohio Association of the Improved Benevolent and Protective Order 354
of the Elks of the World, which shall use the funds for 355
charitable purposes. 356

The registrar shall pay the contributions the registrar 357
receives pursuant to section 4503.703 of the Revised Code to the 358
Ohio chapter of the loyal order of the moose. 359

The registrar shall pay the contributions the registrar 360
receives pursuant to section 4503.71 of the Revised Code to the 361
fraternal order of police of Ohio, incorporated, which shall 362
deposit the fees into its general account to be used for 363
purposes of the fraternal order of police of Ohio, incorporated. 364

The registrar shall pay the contributions the registrar 365
receives pursuant to section 4503.711 of the Revised Code to the 366
fraternal order of police of Ohio, incorporated, which shall 367
deposit the contributions into an account that it creates to be 368
used for the purpose of advancing and protecting the law 369

enforcement profession, promoting improved law enforcement 370
methods, and teaching respect for law and order. 371

The registrar shall pay the contributions received 372
pursuant to section 4503.712 of the Revised Code to Ohio 373
concerns of police survivors, which shall use those 374
contributions to provide whatever assistance may be appropriate 375
to the families of Ohio law enforcement officers who are killed 376
in the line of duty. 377

The registrar shall pay the contributions received 378
pursuant to section 4503.713 of the Revised Code to the greater 379
Cleveland peace officers memorial society, which shall use those 380
contributions to honor law enforcement officers who have died in 381
the line of duty and support its charitable purposes. 382

The registrar shall pay the contributions received 383
pursuant to section 4503.714 of the Revised Code to the Ohio 384
association of chiefs of police. 385

The registrar shall pay the contributions the registrar 386
receives pursuant to section 4503.715 of the Revised Code to the 387
fallen linemen organization, which shall use the contributions 388
to recognize and memorialize fallen linemen and support their 389
families. 390

The registrar shall pay the contributions the registrar 391
receives pursuant to section 4503.716 of the Revised Code to the 392
fallen timbers battlefield preservation commission, which shall 393
use the contributions to further the mission of the commission. 394

The registrar shall pay the contributions the registrar 395
receives pursuant to section 4503.72 of the Revised Code to the 396
organization known on March 31, 2003, as the Ohio CASA/GAL 397
association, a private, nonprofit corporation organized under 398

Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 399
shall use these contributions to pay the expenses it incurs in 400
administering a program to secure the proper representation in 401
the courts of this state of abused, neglected, and dependent 402
children, and for the training and supervision of persons 403
participating in that program. 404

The registrar shall pay the contributions the registrar 405
receives pursuant to section 4503.722 of the Revised Code to the 406
Down Syndrome Association of Central Ohio, which shall use the 407
contributions for advocacy purposes throughout the state. 408

The registrar shall pay the contributions the registrar 409
receives pursuant to section 4503.724 of the Revised Code to the 410
Ohio Chapter of the American Foundation for Suicide Prevention, 411
which shall use the contributions for programs, education, and 412
advocacy purposes throughout the state. 413

The registrar shall pay the contributions the registrar 414
receives pursuant to section 4503.725 of the Revised Code to the 415
ALS association central & southern Ohio chapter, which shall 416
split the contributions between that chapter and the ALS 417
association northern Ohio chapter in accordance with any 418
agreement between the two associations. The contributions shall 419
be used to discover treatments and a cure for ALS, and to serve, 420
advocate for, and empower people affected by ALS to live their 421
lives to the fullest. 422

The registrar shall pay the contributions the registrar 423
receives pursuant to section 4503.73 of the Revised Code to 424
Wright B. Flyer, incorporated, which shall deposit the 425
contributions into its general account to be used for purposes 426
of Wright B. Flyer, incorporated. 427

The registrar shall pay the contributions the registrar 428
receives pursuant to section 4503.732 of the Revised Code to the 429
Siegel Shuster society, a nonprofit organization dedicated to 430
commemorating and celebrating the creation of Superman in 431
Cleveland, Ohio. 432

The registrar shall pay the contributions the registrar 433
receives pursuant to section 4503.733 of the Revised Code to the 434
central Ohio chapter of the juvenile diabetes research 435
foundation, which shall distribute the contributions to the 436
chapters of the juvenile diabetes research foundation in whose 437
geographic territory the person who paid the contribution 438
resides. 439

The registrar shall pay the contributions the registrar 440
receives pursuant to section 4503.734 of the Revised Code to the 441
Ohio highway patrol auxiliary foundation, which shall use the 442
contributions to fulfill the foundation's mission of supporting 443
law enforcement education and assistance. 444

The registrar shall pay the contributions the registrar 445
receives pursuant to section 4503.74 of the Revised Code to the 446
Columbus zoological park association, which shall disburse the 447
moneys to Ohio's major metropolitan zoos, as defined in section 448
4503.74 of the Revised Code, in accordance with a written 449
agreement entered into by the major metropolitan zoos. 450

The registrar shall pay the contributions the registrar 451
receives pursuant to section 4503.75 of the Revised Code to the 452
rotary foundation, located on March 31, 2003, in Evanston, 453
Illinois, to be placed in a fund known as the permanent fund and 454
used to endow educational and humanitarian programs of the 455
rotary foundation. 456

The registrar shall pay the contributions the registrar 457
receives pursuant to section 4503.751 of the Revised Code to the 458
Ohio association of realtors, which shall deposit the 459
contributions into a property disaster relief fund maintained 460
under the Ohio realtors charitable and education foundation. 461

The registrar shall pay the contributions the registrar 462
receives pursuant to section 4503.752 of the Revised Code to 463
buckeye corvettes, incorporated, which shall use the 464
contributions to pay for its charitable activities and programs. 465

The registrar shall pay the contributions the registrar 466
receives pursuant to section 4503.754 of the Revised Code to the 467
municipal corporation of Twinsburg. 468

The registrar shall pay the contributions the registrar 469
receives pursuant to section 4503.763 of the Revised Code to the 470
Ohio history connection to be used solely to build, support, and 471
maintain the Ohio battleflag collection within the Ohio history 472
connection. 473

The registrar shall pay the contributions the registrar 474
receives pursuant to section 4503.764 of the Revised Code to the 475
Medina county historical society, which shall use those 476
contributions to distribute between the various historical 477
societies and museums in Medina county. 478

The registrar shall pay the contributions the registrar 479
receives pursuant to section 4503.765 of the Revised Code to the 480
Amaranth grand chapter foundation, which shall use the 481
contributions for communal outreach, charitable service, and 482
scholarship purposes. 483

The registrar shall pay the contributions the registrar 484
receives pursuant to section 4503.767 of the Revised Code to 485

folds of honor of central Ohio, which shall use the 486
contributions to provide scholarships to spouses and children 487
either of disabled veterans or of members of any branch of the 488
armed forces who died during their service. 489

The registrar shall pay the contributions the registrar 490
receives pursuant to section 4503.85 of the Revised Code to the 491
Ohio sea grant college program to be used for Lake Erie area 492
research projects. 493

The registrar shall pay the contributions the registrar 494
receives pursuant to section 4503.86 of the Revised Code to the 495
Ohio Lincoln highway historic byway, which shall use those 496
contributions solely to promote and support the historical 497
preservation and advertisement of the Lincoln highway in this 498
state. 499

The registrar shall pay the contributions the registrar 500
receives pursuant to section 4503.87 of the Revised Code to the 501
Grove City little league dream field fund, which shall use those 502
contributions solely to build, maintain, and improve youth 503
baseball fields within the municipal corporation of Grove City. 504

The registrar shall pay the contributions the registrar 505
receives pursuant to section 4503.871 of the Revised Code to the 506
Solon city school district. The school district shall use the 507

Ross high school located in Ross township in Butler county. The 1041
high school shall not use the contributions for any political 1042
purpose. 1043

The registrar shall pay the contributions the registrar 1044
receives pursuant to section 4503.97 of the Revised Code to the 1045
friends of united Hatzalah of Israel, which shall use the money 1046
to support united Hatzalah of Israel, which provides free 1047
emergency medical first response throughout Israel. 1048

The registrar shall pay the contributions the registrar 1049
receives pursuant to section 4503.98 of the Revised Code to the 1050
Westerville parks foundation to support the programs and 1051
activities of the foundation and its mission of pursuing the 1052
city of Westerville's vision of becoming "A City Within A Park." 1053

(C) All investment earnings of the license plate 1054
contribution fund shall be credited to the fund. Not later than 1055
the first day of May of every year, the registrar shall 1056
distribute to each entity described in division (B) of this 1057
section the investment income the fund earned the previous 1058
calendar year. The amount of such a distribution paid to an 1059
entity shall be proportionate to the amount of money the entity 1060

received from the fund during the previous calendar year. 1061

Sec. 4503.703. (A) The owner or lessee of any passenger 1062
car, noncommercial motor vehicle, recreational vehicle, or other 1063
vehicle of a class approved by the registrar of motor vehicles 1064
may apply to the registrar for the registration of the vehicle 1065
and issuance of "Loyal Order of the Moose" license plates. The 1066
application may be combined with a request for a special 1067
reserved license plate under section 4503.40 or 4503.42 of the 1068
Revised Code. Upon receipt of the completed application and 1069
compliance by the applicant with divisions (B) and (C) of this 1070
section, the registrar shall issue to the applicant the 1071
appropriate vehicle registration and a set of "Loyal Order of 1072
the Moose" license plates and a validation sticker, or a 1073
validation sticker alone when required by section 4503.191 of 1074
the Revised Code. 1075

In addition to the letters and numbers ordinarily 1076
inscribed on the license plates, "Loyal Order of the Moose" 1077
license plates shall display an appropriate logo and words that 1078
are selected by representatives of the Ohio chapter of the loyal 1079
order of the moose and approved by the registrar. "Loyal Order 1080
of the Moose" license plates shall display county identification 1081
stickers that identify the county of registration as required 1082
under section 4503.19 of the Revised Code. 1083

(B) "Loyal Order of the Moose" license plates and a 1084
validation sticker, or validation sticker alone, shall be issued 1085
upon receipt of an application for registration of a motor 1086
vehicle under this section; payment of the regular license tax 1087
as prescribed under section 4503.04 of the Revised Code, any 1088
applicable motor vehicle license tax levied under Chapter 4504. 1089
of the Revised Code, any applicable additional fee prescribed by 1090

section 4503.40 or 4503.42 of the Revised Code, an additional 1091
administrative fee of ten dollars, and a contribution as 1092
provided in division (C)(1) of this section; and compliance with 1093
all other applicable laws relating to the registration of motor 1094
vehicles. 1095

(C)(1) For each application for registration and 1096
registration renewal notice the registrar receives under this 1097
section, the registrar shall collect a contribution of twenty 1098
dollars. The registrar shall deposit this contribution into the 1099
state treasury to the credit of the license plate contribution 1100
fund created in section 4501.21 of the Revised Code. 1101

(2) The registrar shall deposit the administrative fee of 1102
ten dollars, the purpose of which is to compensate the bureau of 1103
motor vehicles for additional services required in the issuing 1104
of "Loyal Order of the Moose" license plates, into the state 1105
treasury to the credit of the public safety - highway purposes 1106
fund created in section 4501.06 of the Revised Code. 1107

Section 2. That existing section 4501.21 of the Revised 1108
Code is hereby repealed. 1109
