Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear a 11 phrase and logo selected by the North Carolina State University College of 12 13 Veterinary Medicine Turtle Rescue Team. 14 15 **SECTION 2.** G.S. 20-79.7 reads as rewritten: 16 "§ 20-79.7. Fees for special registration plates and distribution of the fees. 17 18 Fees. – All other special registration plates are subject to the regular motor vehicle 19 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount: 20 21 Special Plate Additional Fee Amount 22 23 Turtle Rescue Team Expired July 1, 2016\$30.00 24 25 Distribution of Fees. – The Special Registration Plate Account and the Collegiate and (b) 26 Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a1) of this 27 28 section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural 29 Attraction Plate Account (CCAPA), the North Carolina Land and Water Fund (NCLWF) which 30 is established under G.S. 143B-135.234, and the Parks and Recreation Trust Fund, which is 31 established under G.S. 143B-135.56, as follows: 32 33 Special Plate SRPA **CCAPA** NCLWF **PRTF** 34
