A BILL

To amend the Higher Education Act of 1965 to improve education opportunities for physician assistants, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Physician Assistant
- 5 Higher Education Modernization Act of 2017".

1	SEC. 2. INCREASING ANNUAL LOAN LIMITS FOR PHYSICIAN
2	ASSISTANT STUDENTS UNDER THE FEDERAL
3	DIRECT LOAN PROGRAM.
4	(a) In General.—Section 455 of the Higher Edu-
5	cation Act of 1965 (20 U.S.C. 1087e) is amended by add-
6	ing at the end the following:
7	"(r) Increasing Annual Loan Limits for Physi-
8	CIAN ASSISTANT STUDENTS.—Notwithstanding section
9	428H(d)(2)(A), the maximum annual amount of Federal
10	Direct Unsubsidized Stafford Loans that a graduate stu-
11	dent in a physician assistant education program (as de-
12	fined in section 799B of the Public Health Service Act
13	(42 U.S.C. 295p)) may borrow in any academic year (as
14	defined in section 481(a)(2)) or its equivalent shall be—
15	"(1) \$40,000 in the first academic year of such
16	program;
17	"(2) \$40,000 in the second academic year of
18	such program; and
19	"(3) \$15,000 in the third academic year of such
20	program.".
21	(b) Effective Date.—The amendment made by
22	this section shall apply with respect to award years begin-
23	ning more 60 days after the date of enactment of this Act.

1	SEC. 3. MAKING PHYSICIAN ASSISTANTS ELIGIBLE FOR IN-
2	CENTIVES WHEN SERVING AS PRIMARY CARE
3	PROVIDERS OR FACULTY MEMBERS.
4	(a) In General.—Section 428K of the Higher Edu-
5	cation Act of 1965 (20 U.S.C. 1078–11) is amended—
6	(1) in subsection (b), by adding at the end the
7	following:
8	"(19) Physician assistants.—The individual
9	is a physician assistant employed full-time—
10	"(A) as a physician assistant in a clinical
11	setting providing primary care services; or
12	"(B) as a member of the physician assist-
13	ant faculty at a physician assistant education
14	program (as defined in section 799B of the
15	Public Health Service Act (42 U.S.C. 295p)).";
16	(2) in subsection (g), by adding at the end the
17	following:
18	"(11) Physician assistant.—The term 'phy-
19	sician assistant' means an individual who—
20	"(A) graduated from a physician assistant
21	education program (as defined in section 799B
22	of the Public Health Service Act (42 U.S.C.
23	295p));
24	"(B) is certified as a physician assistant by
25	the National Commission on the Certification of

1	Physician Assistants or any successor organiza-
2	tion; and
3	"(C) either—
4	"(i) holds a valid and unrestricted li-
5	cense to practice medicine as a physician
6	assistant in the State in which the physi-
7	cian assistant practices in a clinical set-
8	ting; or
9	"(ii) is qualified for licensure in the
10	State where the individual is employed as
11	a full-time physician assistant faculty
12	member of a physician assistant education
13	program (as defined in section 799B of the
14	Public Health Service Act (42 U.S.C.
15	295p))."; and
16	(3) in subsection (h), by striking "fiscal year
17	2009" and inserting "fiscal year 2018".
18	(b) Effective Date.—The amendments made by
19	this section shall apply with respect to employment occur-
20	ring on or after the date of the enactment of this Act.

8	SEC. 6. GRANTS TO RURAL SERVING INSTITUTIONS OF
9	HIGHER EDUCATION FOR PHYSICIAN ASSIST-

11	Part Q of title VIII of the Higher Education Act of
12	1965 (20 U.S.C. 1161q) is amended—
13	(1) in section 861(b), by striking "For the pur-
14	poses of this section" and inserting "For the pur-

16	(2) by inserting after section 861 the following:
17	"SEC. 862. GRANTS TO SUPPORT THE DEVELOPMENT AND

13	"(3) Limitations.—A rural-serving institution
14	of higher education or a consortium of such institu-
15	tions shall not receive more than one grant under
16	this section.
17	"(b) Applications.—
18	"(1) In general.—Each rural-serving institu-
19	tion of higher education or consortium of such insti-
20	tutions desiring a grant under this section shall sub-
21	mit to the Secretary an application at such time, in
22	such manner, and containing such information as
23	the Secretary may require.

5	SEC. 7. IMPROVING PHYSICIAN ASSISTANT EDUCATION
6	PROGRAMS.
7	Title VIII of the Higher Education Act of 1965 is
8	amended by inserting after section 898 (20 U.S.C.
9	1161aa–1) the following:
10	"PART BB—PHYSICIAN ASSISTANT EDUCATION
11	ENHANCEMENT
12	"SEC. 899. DEMONSTRATION PROGRAM TO SUPPORT PHYSI-
13	CIAN ASSISTANT FACULTY PREPARATION.
14	"(a) Grants.—
15	"(1) IN GENERAL.—The Secretary shall provide
16	grants to not more than 10 institutions of higher
17	education to develop, expand, and support graduate-
18	level programs to prepare certified physician assist-
19	ants to become physician assistant faculty members
20	in accredited graduate-level physician assistant edu-
21	cation programs through collaboration between such
22	a program and an institution of higher education
23	that awards a graduate degree in education.
24	"(2) CAP.—No institution of higher education
25	may receive more than an aggregate of \$600,000

1	under this section during fiscal years 2018, 2019,
2	and 2020.
3	"(b) Application.—
4	"(1) IN GENERAL.—An institution of higher
5	education desiring a grant under this section shall
6	submit to the Secretary, at such time and in such
7	manner as the Secretary may require, an application
8	including—
9	"(A) a description of the intended collabo-
10	ration to develop, expand, and support grad-
11	uate-level programs to prepare certified physi-
12	cian assistants to become physician assistant
13	faculty members in accredited graduate-level
14	physician assistant education programs; and
15	"(B) an estimate of the number of stu-
16	dents who will be affected by such collaboration.
17	"(2) Priority.—The Secretary shall give pri-
18	ority to applications that demonstrate the potential
19	to maximize quality instruction through the use of
20	technology.
21	"(c) Report.—Not later than 18 months after the
22	date of the first grant under this section, the Secretary
23	shall submit to Congress a report that—
24	"(1) describes the steps taken to implement this
25	section: and

1	"(2) lists all recipients of grants under this sec-
2	tion as of the date of such submission.
3	"(d) Definitions.—In this section:
4	"(1) Institution of higher education.—
5	The term 'institution of higher education' has the
6	meaning given such term in section 101.
7	"(2) Physician assistant education pro-
8	GRAM.—The term 'physician assistant education
9	program' has the meaning given such term in sec-
10	tion 799B of the Public Health Service Act (42
11	U.S.C. 295p).
12	"(e) Authorization of Appropriations.—There
13	are authorized to be appropriated such sums as may be
14	necessary to carry out this section for fiscal years 2018
15	through 2020.
16	"SEC. 899A. GRANTS FOR INFRASTRUCTURE AND TECH-
17	NOLOGY IMPROVEMENTS IN PHYSICIAN AS-
18	SISTANT EDUCATION PROGRAMS.
19	"(a) Grants.—
20	"(1) In general.—The Secretary is authorized
21	to award grants, on a competitive basis, to not more
22	than 20 physician assistant education programs to
23	enhance physician assistant education programs and
24	improve patient safety by supporting the purchase of
25	new infrastructure and technology.

"(2) DURATION.—A grant awarded under this 1 2 section shall be awarded for a period of not longer than five years. 3 "(b) APPLICATION.— 4 "(1) IN GENERAL.—A physician assistant edu-5 cation program may apply for a grant under this 6 7 section by submitting an application to the Secretary 8 at such time and in such manner as the Secretary 9 may require that demonstrates how the grant funds 10 will be used to improve physician assistant education 11 programs and patient safety with respect to such 12 programs. 13 "(2) Priority.—In awarding grants under this 14 section, the Secretary shall give priority to applica-15 tions that demonstrate the potential to— "(A) increase the number of physician as-16 17 sistant graduates; and 18 "(B) maximize accessibility to new and 19 emerging technologies, including human patient 20 simulators for physician assistant education 21 programs, through partnerships between the 22 grant recipient and other institutions of higher 23 education. 24 "(c) Use of Funds.—A physician assistant edu-

cation program that receives a grant awarded under this

1	section may use the grant for one or more of the following
2	purposes:
3	"(1) Purchase, rental, or lease of scientific
4	medical or laboratory equipment, including human
5	patient simulators and other new and emerging tech-
6	nologies, for education purposes, including instruc-
7	tional and research purposes.
8	"(2) Construction, maintenance and renovation
9	and improvement of classrooms, libraries, labora-
10	tories, and other instructional facilities, including
11	purchase or rental of telecommunications technology
12	equipment or services.
13	"(3) Supporting faculty training in the use of
14	new and emerging technologies, including human pa-
15	tient simulators.
16	"(4) Other activities proposed in the application
17	submitted pursuant to subsection (b) that—
18	"(A) contribute to carrying out the pur-
19	poses of this section; and
20	"(B) are approved by the Secretary as part
21	of the review and acceptance of such applica-
22	tion.
23	"(d) Definitions.—In this section:
24	"(1) Physician assistant education pro-
25	GRAM.—The term 'physician assistant education

- 4 "(2) Human patient simulator.—The term
