A BILL

To amend the Public Health Service Act to provide for research and improvement of cardiovascular health among the South Asian population of the United States, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "South Asian Heart
- 5 Health Awareness and Research Act of 2021".

1 SEC. 2. HEART HEALTH PROMOTION GRANTS.

- Title III of the Public Health Service Act (42 U.S.C.
- 3 241 et seq.) is amended by inserting after section 317U
- 4 (42 U.S.C. 247b–23) the following new section:
- 5 "SEC. 317V. HEART HEALTH PROMOTION GRANTS.
- 6 "(a) IN GENERAL.—The Secretary shall make grants
- 7 to States for the purpose of promoting awareness of the
- 8 increasing prevalence of heart disease, including, where
- 9 appropriate, its relationship to type 2 diabetes, in commu-
- 10 nities disproportionately affected by heart disease such as
- 11 South Asian communities in the United States.
- 12 "(b) Use of Funds.—A State that receives a grant
- 13 under subsection (a) shall use such grant funds—
- "(1) to develop culturally appropriate materials
- on evidence-based topics such as nutrition education,
- optimal diet plans, and programs for regular exer-
- 17 cise;
- 18 "(2) to support heart health promotion activi-
- 19 ties of community organizations that work with or
- 20 serve communities disproportionately affected by
- 21 heart disease, such as South Asian communities in
- the United States; or
- "(3) to support conferences or workshops on re-
- search practices, methodology, and design to include
- 25 more members of communities disproportionately af-

- 1 fected by heart disease, such as South Asian com-
- 2 munities in the United States, in scientific studies.
- 3 "(c) Annual Report to Congress.—Not later
- 4 than 180 days after the date of the enactment of the
- 5 South Asian Heart Health Awareness and Research Act
- 6 of 2021, and annually thereafter, the Secretary shall sub-
- 7 mit to Congress a report on outreach efforts and data re-
- 8 lating to heart disease in communities disproportionately
- 9 affected by heart disease, such as South Asian commu-
- 10 nities in the United States.
- 11 "(d) Authorization of Appropriations.—For
- 12 purposes of carrying out this section, there is authorized
- 13 to be appropriated \$1,000,000 for each of fiscal years
- 14 2022 through 2026.".
- 15 SEC. 3. HEART HEALTH RESEARCH.
- Part B of title IV of the Public Health Service Act
- 17 (42 U.S.C. 284 et seq.) is amended by adding at the end
- 18 the following new section:
- 19 "SEC. 409K. HEART HEALTH RESEARCH.
- 20 "(a) IN GENERAL.—The Secretary may—
- 21 "(1) conduct or support research and related
- activities regarding cardiovascular disease, type 2 di-
- abetes, and other heart health-related ailments
- among at-risk populations, including South Asian
- communities in the United States; and

1	"(2) establish an internet clearinghouse to cata-
2	log existing evidence-based heart health research and
3	treatment options for communities disproportion-
4	ately affected by heart disease, such as South Asian
5	communities in the United States, to prevent, treat,
6	or reverse heart disease and diabetes.
7	"(b) Authorization of Appropriations.—For
8	purposes of carrying out this section, there is authorized
9	to be appropriated \$1,000,000 for each of fiscal years
0	2022 through 2026.".
