- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- IN THIS SECTION, "CONSEQUENCES OF A CONVICTION FOR FELONY 18
- MURDER" MEANS THE LEGAL PENALTIES THAT TAKE AWAY AN INDIVIDUAL'S 19

- 1 (C) THE BALTIMORE CITY BOARD OF SCHOOL COMMISSIONERS SHALL 2 DEVELOP AN AGE-APPROPRIATE COURSE ON THE CONSEQUENCES OF A CONVICTION FOR FELONY MURDER FOR STUDENTS IN GRADES 6 THROUGH 8 IN BALTIMORE CITY PUBLIC SCHOOLS.
- 5 (D) BEGINNING IN THE 2026–2027 SCHOOL YEAR, THE BOARD SHALL 6 IMPLEMENT THE COURSE ON THE CONSEQUENCES OF A CONVICTION FOR FELONY 7 MURDER DEVELOPED UNDER SUBSECTION (C) OF THIS SECTION.
- 8 (E) THE CHIEF ACADEMIC OFFICER SHALL ENSURE THAT A COURSE ON 9 THE CONSEQUENCES OF A CONVICTION FOR FELONY MURDER IS TAUGHT TO STUDENTS AT LEAST ONCE DURING GRADES 6 THROUGH 8.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025.
