A BILL

To provide competitive grants for the promotion of Japanese American confinement education as a means to understand the importance of democratic principles, use and abuse of power, and to raise awareness about the importance of cultural tolerance toward Japanese Americans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Japanese American
- 5 Confinement Education Act".

SEC. 2. DEFINITIONS.

- 3 (1) Japanese American Museum.—The term
- 4 "Japanese American museum" means a museum lo-
- 5 cated in the United States established to promote
- 6 the understanding and appreciation of the ethnic
- 7 and cultural diversity of the United States by illus-
- 8 trating the Japanese American experience through-
- 9 out the history of the United States.
- 10 (2) Secretary.—The term "Secretary" means
- the Secretary of the Interior.

12 SEC. 3. COMPETITIVE GRANTS FOR JAPANESE AMERICAN

- 13 CONFINEMENT EDUCATION.
- 14 (a) IN GENERAL.—The Secretary shall establish a
- 15 program to award competitive grants to a Japanese Amer-
- 16 ican museum to educate individuals in the United States
- 17 on the historical importance of Japanese American con-
- 18 finement during World War II so that present and future
- 19 generations may learn from Japanese American confine-
- 20 ment and the commitment of the United States to equal
- 21 justice under the law.
- 22 (b) Use of Funds.—A grant awarded under sub-
- 23 section (a)—
- 24 (1) shall be used—

1	(A) for the research and education relating
2	to the Japanese American confinement in
3	World War II; and
4	(B) for the disbursement of accurate, rel-
5	evant, and accessible resources to promote un-
6	derstanding about how and why the Japanese
7	American confinement in World War II hap-
8	pened, which—
9	(i) shall include digital resources; and
10	(ii) may include other types of re-
11	sources, including print resources and exhi-
12	bitions; and
13	(2) shall not be used at a Japanese American
14	museum that does not provide—
15	(A) free admission to individuals who were
16	placed within a Japanese American confinement
17	camp; and
18	(B) dedicated free admission hours for the
19	general public not less than once per month.
20	(c) APPLICATION.—To be eligible to receive a grant
21	under this section, a Japanese American museum shall
22	submit to the Secretary an application at such time, in
23	such manner, and containing such information as the Sec-
24	retary may require.

1	(d) Deadline for Award.—Not later than 120
2	days after the date on which the Secretary receives an ap-
3	plication from a Japanese American museum for a grant
4	that is approved by the Secretary under this section, the
5	Secretary shall award a grant to the Japanese American
6	museum.
7	(e) Priority Considerations.—In awarding a
8	grant under this section, the Secretary shall give priority
9	using the following considerations:
10	(1) The needs of the Japanese American mu-
11	seum.
12	(2) The proximity of the project for which the
13	grant funds will be used to cities with populations
14	that include not less than 100,000 Japanese Ameri-
15	cans, as certified by the most recent census.
16	(3) The ability and commitment of the Japa-
17	nese American museum to use grant funds—
18	(A) to educate future generations of indi-
19	viduals in the United States; and
20	(B) to locate Japanese American confine-
21	ment survivors.
22	(4) The existing relationship the Japanese
23	American museum has with Japanese American cul-
24	tural and advocacy organizations.

- 1 (f) Report.—Not later than 90 days after the end 2 of each fiscal year for which a Japanese American mu-
- 3 seum obligates or expends amounts made available under
- 4 a grant under this section, the Japanese American mu-
- 5 seum shall submit to the Secretary and the appropriate
- 6 committees of Congress a report that—
- 7 (1) specifies the amount of grant funds obli-8 gated or expended for the preceding fiscal year;
- 9 (2) specifies any purposes for which the funds 10 were obligated or expended; and
- 11 (3) includes any other information that the Sec-12 retary may require to more effectively administer the
- grant program.
- 14 (g) AUTHORIZATION OF APPROPRIATIONS.—There is
- 15 authorized to be appropriated to the Secretary to carry
- 16 out this Act \$2,000,000 for each of fiscal years 2022
- 17 through 2026.
- 18 SEC. 4. PRESERVATION OF HISTORIC CONFINEMENT SITES.
- 19 (a) SUNSET.—Section 1 of Public Law 109–441 (120
- 20 Stat. 3288) is amended by striking subsection (e).
- 21 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
- 22 4 of Public Law 109–441 (120 Stat. 3290) is amended,
- 23 in the first sentence—
- 24 (1) by striking "are authorized" and inserting
- 25 "is authorized"; and

- 1 (2) by inserting "for fiscal year 2022 and each
- 2 fiscal year thereafter" after "this Act".
