BY repealing and reenacting, with amendments, Article – Transportation Section 21–803.1 and 21–809(a)(7) Annotated Code of Maryland (2020 Replacement Volume and 2022 Supplement) BY repealing and reenacting, without amendments, Article – Transportation Section 21–809(a)(1) and (8) and (b)(1)(vi)2.
