7	(3) Objective.—The objective of the System is					
8	to monitor all the volcanoes in the United States at					
9	a level commensurate with the threat posed by the					
10	volcanoes by—					
11	(A) upgrading existing networks on mon-					
12	itored volcanoes;					
13	(B) installing new networks on					
14	unmonitored volcanoes; and					
15	(C) employing geodetic and other compo-					
16	nents when applicable.					
17	(b) System Components.—					
18	(1) In general.—The System shall include—					
19	(A) a national volcano watch office that					
20	operational 24 hours a day and 7 days a week;					
21	(B) a national volcano data center; and					
22	(C) an external grants program to support					
23	research in volcano monitoring science and					
24	technology.					

1	(2) Modernization activities.—Moderniza-
2	tion activities under the System shall include the
3	comprehensive application of emerging technologies,
4	including digital broadband seismometers, real-time
5	continuous Global Positioning System receivers, sat-
6	ellite and airborne radar interferometry, acoustic
7	pressure sensors, and spectrometry to measure gas
8	emissions.
9	(c) Management.—
10	(1) Management plan.—
11	(A) IN GENERAL.—Not later than 180
12	days after the date of enactment of this Act,
13	the Secretary shall submit to Congress a 5-year
14	management plan for establishing and oper-
15	ating the System.
16	(B) Inclusions.—The management plan
17	submitted under subparagraph (A) shall in-
18	clude—
19	(i) annual cost estimates for mod-
20	ernization activities and operation of the
21	System;
22	(ii) annual milestones, standards, and
23	performance goals; and
24	(iii) recommendations for, and
25	progress towards, establishing new, or en-

1	hancing existing, partnerships to leverage						
2	resources.						
3	(2) Advisory committee.—The Secretary						
4	shall establish an advisory committee to assist the						
5	Secretary in implementing the System, to be con-						
6	prised of representatives of relevant agencies and						
7	members of the scientific community, to be ap-						
8	pointed by the Secretary.						
9	(3) Partnerships.—The Secretary may ente						
10	into cooperative agreements with institutions						
11	higher education and State agencies designating the						
12	institutions of higher education and State agencie						
13	as volcano observatory partners for the System.						
14	(4) COORDINATION.—The Secretary shall co						
15	ordinate the activities under this Act with the heads						
16	of relevant Federal agencies, including—						
17	(A) the Secretary of Transportation;						
18	(B) the Administrator of the Federal Avia-						
19	tion Administration;						
20	(C) the Administrator of the National Oce-						
21	anic and Atmospheric Administration; and						
22	(D) the Director of the Federal Emergency						
23	Management Administration.						

- 1 (d) Annual Report.—Annually, the Secretary shall
- 2 submit to Congress a report that describes the activities
- 3 carried out under this Act.
- 4 SEC. 4. FUNDING.
- 5 (a) AUTHORIZATION OF APPROPRIATIONS.—There is
- 6 authorized to be appropriated to carry out this Act
- 7 \$55,000,000 for the period of fiscal years 2019 through
- 8 2023.
- 9 (b) Effect on Other Sources of Federal
- 10 Funding.—Amounts made available under this section
- 11 shall supplement, and not supplant, Federal funds made
- 12 available for other United States Geological Survey haz-
- 13 ards activities and programs.
