Ms. Mace (for herself, Mr. Ogles, Mr. Weber of Texas, Mr. Burchett, and Mr. Brecheen) introduced the following bill; which was referred to the Committee on Foreign Affairs, and in addition to the Committees on Armed Services, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To prohibit actions recognizing the Islamic Emirate of Afghanistan, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Preventing the Rec-
- 5 ognition of Terrorist States Act of 2024".
- 6 SEC. 2. STATEMENT OF POLICY.
- 7 It is the policy of the United States—

- 1 (1) to not recognize the Islamic Emirate of Af-2 ghanistan, which is controlled by the Taliban, as the 3 official Government of Afghanistan under any cir-4 cumstances;
 - (2) to view the Taliban's takeover of Afghanistan as a coup d'état and therefore illegitimate; and
- 7 (3) to recognize that individuals designated as 8 terrorists by the United States, such as Sirajuddin 9 Haqqani, will play a key role in the Taliban regime.

10 SEC. 3. PROHIBITION ON ACTIONS RECOGNIZING THE IS-

11 LAMIC EMIRATE OF AFGHANISTAN.

- 12 (a) In General.—In furtherance of the policy set
- 13 forth in section 2, no Federal department or agency may
- 14 take any action or extend any assistance that states or
- 15 implies recognition of the Taliban's claim of sovereignty
- 16 over Afghanistan.

- 17 (b) Funding Limitation.—Notwithstanding any
- 18 other provision of law, no Federal funds appropriated or
- 19 otherwise made available for the Department of State, the
- 20 United States Agency for International Development, or
- 21 the Department of Defense on or after the date of the
- 22 enactment of this Act may be obligated or expended to
- 23 prepare or promulgate any policy, guidance, regulation,
- 24 notice, or Executive order, or to otherwise implement, ad-

- 1 minister, or enforce any policy, that extends diplomatic
- 2 recognition to the Islamic Emirate of Afghanistan.
- 3 SEC. 4. DESIGNATION OF ISLAMIC EMIRATE OF AFGHANI-
- 4 STAN AS A STATE SPONSOR OF TERRORISM.
- 5 (a) IN GENERAL.—The Secretary of State shall des-
- 6 ignate the Islamic Emirate of Afghanistan as a State
- 7 sponsor of terrorism.
- 8 (b) State Sponsor of Terrorism Defined.—In
- 9 this section, the term "state sponsor of terrorism" means
- 10 a country the government of which the Secretary of State
- 11 has determined has repeatedly provided support for acts
- 12 of international terrorism, for purposes of—
- 13 (1) section 1754(c)(1)(A)(i) of the Export Con-
- trol Reform Act of 2018 (50 U.S.C.
- 15 4813(c)(1)(A)(i));
- 16 (2) section 620A of the Foreign Assistance Act
- 17 of 1961 (22 U.S.C. 2371);
- 18 (3) section 40(d) of the Arms Export Control
- 19 Act (22 U.S.C. 2780(d)); or
- 20 (4) any other provision of law.

1 SEC. 5. DESIGNATION OF THE TALIBAN AS A FOREIGN TER-

- 2 RORIST ORGANIZATION.
- 3 The Secretary of State shall designate the Taliban
- 4 as a foreign terrorist organization pursuant to section 219
- 5 of the Immigration and Nationality Act (8 U.S.C. 1189).
