7	WHEREAS, millions of adults and children are affected
8	by mental illnesses every year; and
9	WHEREAS, one in six United States youth aged six to
10	17 experience a mental health disorder each year; and
11	WHEREAS, people with mental illnesses have the
12	possibility of recovering if given necessary services and
13	support in their communities; and
14	WHEREAS, schools are an effective and efficient place
15	to teach youths to identify, understand, and respond to
16	signs of mental health disorders in themselves and among
17	their peers; and
18	WHEREAS, schools can provide meaningful instruction
19	to students on how to help someone who is developing a
20	mental health problem or experiencing a mental health
21	crisis; now therefore,
22	BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
23	HOUSES THEREOF CONCURRING, That there is created the Alabama
24	K-12 Mental Health Task Force to evaluate and recommend
25	policies that promote student mental health in public
26	schools.

 President Pro Tempore of the Senate, and one member of the

 Senate appointed by the Minority Leader of the Senate.
- 36 (3) The Chairs of the House Education Policy Standing
 37 Committee and the Senate Education Policy Standing
 38 Committee.
- 39 (4) The State Superintendent of Education or his or 40 her designee.
- 41 (5) The Secretary of Early Childhood Education or his 42 or her designee.
- 43 (6) The Commissioner of the Alabama Department of 44 Mental Health or his or her designee.
- 45 (7) The Commissioner of the Alabama Department of Human Resources or his or her designee.
- 47 (8) The Executive Director of the Alabama Department 48 of Youth Services or his or her designee.
- (9) One psychiatrist with expertise in treating children to be appointed by the Governor.
- 51 (10) One clinical psychologist with expertise in 52 treating children appointed by the Lieutenant Governor.
- 53 (11) Any member of the Senate or the House of
 54 Representatives who desires to promote the mental health of
 55 students in Alabama schools.

- (b) The appointing authorities shall coordinate their appointments to assure the task force membership is inclusive and reflects the racial, gender, geographic, urban, rural, and economic diversity of the state.
- 62 (c) The work of the task force may include, but not 63 be limited to, any of the following in pursuit of its goal 64 of evaluating and recommending policies that promote student 65 mental health in public K-12 schools:
 - (1) Collecting and analyzing data related to the current state of student mental health in public K-12 schools across the state.
- (2) Evaluating the resources currently available to 70 students to address mental health issues and identifying the gaps in those resources.
- 72 (3) Developing early childhood mental health 73 prevention programs in public elementary schools to help 74 students identify, understand, and respond to signs of mental health disorders in themselves and among their peers. 75
- 76 (4) Exploring the impact of mental health issues on 77 student behavior and safety, dropout and graduation rates, academic achievement, and employment. 78
- 79 (5) Reviewing mental health training, professional 80 development, and gaps in training provided to school 81 personnel for classroom management, identification, 82 referral, intervention, and prevention of mental health 83 issues.

84 (6) Reviewing the workforce landscape to determine if 85 there are sufficient personnel to address the mental health 86 issues of students.

- (d) The Chair of the House Education Policy Standing Committee shall call the first meeting of the task force no later than 90 days after this resolution's passage, at which time the members shall elect a chair and a vice chair from among the membership. The task force may then meet as necessary to conduct business.
 - (e) The Legislative Services Agency, the Clerk of the House of Representatives, and the Secretary of the Senate shall provide administrative and other assistance for the work of the task force as necessary.
- (f) (1) The legislative members of the task force shall be entitled to their legislative compensation, per diem, and travel expenses for each day they attend a meeting of the task force pursuant to Section 49 of the Constitution of Alabama of 2022.
 - (2) The nonlegislative members of the task force shall serve without compensation but may be reimbursed for necessary expenses in attending meetings of the task force pursuant to the policies of their respective appointing authority.
- 107 (g) The task force shall prepare and submit a report
 108 of its findings, conclusions, and recommendations to the
 109 Legislature not later than the fifteenth legislative day of
 110 the 2027 Regular Session. Upon filing its report with the

111	Legislature, the task force shall stand dissolved and
112	discharged of any future duties and liabilities.
113	(h) Pursuant to Section 36-14-17.1, Code of Alabama
114	1975, the task force shall provide to the Secretary of State
115	a notice of all meetings, the name of each member serving on
116	the task force, and a copy of the final report and other
117	documents produced throughout the duration of the task
118	force.
119	(i) Each appointing authority named herein shall be
120	provided a copy of this resolution upon its passage.
