A BILL

To amend title II of the Social Security Act to provide a midyear cost-of-living increase to account for an insufficient increase for 2017, to apply the Consumer Price Index for the Elderly (CPI–E) to future Social Security COLAs, and for other purposes.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fair COLA for Seniors

- 9 for Elderly Consumers".
- 10 (e) Effective Date.—The amendments made by
- 11 this section shall apply with respect to determinations
- 12 made under section 215(i)(2)(A)(i) of the Social Security
- 13 Act with respect to base quarters occurring in 2017 or
- 14 later.
