A BILL

To amend title 38, United States Code, to improve the benefits and services provided by the Department of Veterans Affairs to women veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) Short Title.—This Act may be cited as the
- 5 "Deborah Sampson Act".
- 6 (b) Table of Contents for

TITLE I—PEER-TO-PEER ASSISTANCE

- Sec. 101. Pilot program on peer-to-peer assistance for women veterans separating or newly separated from service in the Armed Forces.

1	TITLE I—PEER-TO-PEER
2	ASSISTANCE
3	SEC. 101. PILOT PROGRAM ON PEER-TO-PEER ASSISTANCE
4	FOR WOMEN VETERANS SEPARATING OR
5	NEWLY SEPARATED FROM SERVICE IN THE
6	ARMED FORCES.
7	(a) Pilot Program Required.—Commencing not
8	later than January 1, 2018, the Secretary of Veterans Af-
9	fairs shall carry out a pilot program to assess the feasi-
10	bility and advisability of facilitating peer-to-peer assist-
11	ance for women veterans who are separating or newly sep-
12	arated from service in the Armed Forces.
13	(b) Peer-to-Peer Assistance.—Peer-to-peer as-
14	sistance under the pilot program shall consist of the fol-
15	lowing:
16	(1) Provision of information about services and
17	benefits provided under laws administered by the
18	Secretary of Veterans Affairs.
19	(2) Employment mentoring.
20	(c) Duration.—The Secretary shall carry out the
21	pilot program during the three-year period beginning on
22	the date of the commencement of the pilot program.
23	(d) Emphasis.—In carrying out the pilot program,
24	the Secretary shall emphasize facilitating peer-to-peer as-
25	sistance for women described in subsection (a) who suf-

- 1 fered sexual trauma while serving in the Armed Forces,
- 2 have post-traumatic stress disorder or suffer from another
- 3 mental health condition, or are otherwise at risk of becom-
- 4 ing homeless.

- 5 (e) Outreach.—As part of the pilot program, the
- 6 Secretary conduct a program of outreach to inform women
- 7 veterans about the pilot program and the assistance avail-
- 8 able under the pilot program.

(f) Coordination.—

- (1) WITH GOVERNMENT AND COMMUNITY OR-GANIZATIONS.—Under the pilot program, the Secretary shall facilitate engagement and coordination with such community organizations, State and local governments, institutions of higher education, chambers of commerce, local business organizations, organizations that provide legal assistance, and other organizations as the Secretary considers appropriate to facilitate the transition of women described in subsection (a) into their communities.
 - (2) WITH TRANSITION ASSISTANCE PROGRAM.—To the degree practicable, the Secretary shall coordinate facilitation of assistance under the pilot program with the program carried out under section 1144 of title 10, United States Code.
- 25 (g) Authorization of Appropriations.—

1	(1) In general.—There are authorized to be
2	appropriated to the Secretary such funds as may be
3	necessary to carry out the pilot program.
4	(2) Limitation.—Of the amounts appropriated
5	under paragraph (1), the Secretary may not expend
6	more than \$100,000 on training and developing
7	training materials for peer counselors.
8	SEC. 102. EXPANSION OF CAPABILITIES OF WOMEN VET-
9	ERANS CALL CENTER TO INCLUDE TEXT MES-
10	SAGING.
11	The Secretary of Veterans Affairs shall expand the
12	capabilities of the Women Veterans Call Center of the De-
13	partment of Veterans Affairs to include a text messaging
14	capability.
15	SEC. 103. PROVISION OF REINTEGRATION AND READJUST-
16	MENT SERVICES TO VETERANS AND FAMILY
17	MEMBERS IN GROUP RETREAT SETTINGS.
18	(a) In General.—Section 1712A of title 38, United

2	as redesignated by subparagraph (B), by strik-
3	ing "Counseling" and inserting "(i) Coun-
4	seling"; and
5	(D) by adding at the end the following new
6	clause:
7	"(ii)(I) Except as provided in subclause (IV), coun-
8	seling furnished to an individual under subparagraph (A)
9	may include reintegration and readjustment services de-
10	scribed in subclause (II) furnished in group retreat set-
11	tings.
12	"(II) Reintegration and readjustment services de-
13	scribed in this subclause are the following:
14	"(aa) Information on reintegration of the indi-
15	vidual into family, employment, and community.
16	"(bb) Financial counseling.
17	"(ce) Occupational counseling.

22	"(ff) Such other information and counseling as
23	the Secretary considers appropriate to assist the in-

21	OF VETERANS AFFAIRS IN CONNECTION
22	WITH CARE FOR NEWBORN CHILDREN.
23	Section 1786 of title 38, United States Code, is
24	amended by adding at the end the following new sub-
25	section:

- 2 paid by the Department for medically necessary travel in

5	(a) In General.—The Secretary of Veterans Affairs
6	shall survey the Internet websites and information re-
7	sources of the Department of Veterans Affairs in effect
8	on the day before the date of the enactment of this Act
9	and publish an Internet website that serves as a central-
10	ized source for the provision to women veterans of infor-
11	mation about the benefits and services available to them
12	under laws administered by the Secretary.
13	(b) Elements.—The Internet website published
14	under subsection (a) shall provide to women veterans in-
15	formation regarding all of the services available in the dis-
16	trict in which that the veteran is seeking such services,
17	including, with respect to each medical center and commu-
18	nity-based outpatient clinic in the applicable Veterans In-

8	(d) Outreach.—In carrying out this section, the
9	Secretary shall ensure that the outreach conducted under
10	section 1720F(i) of title 38, United States Code, includes
11	information regarding the Internet website required by
12	subsection (a).
13	(e) Derivation of Funds.—Amounts used by the
14	Secretary to carry out this section shall be derived from
15	amounts made available to the Secretary to publish Inter-
16	net websites of the Department.
