A BILL

To direct the Secretary of Defense to conduct a study on the feasibility, costs, and benefits of providing housing for civilian workers at certain naval shipyards, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Defense Shipyard
- 5 Workforce Housing Act of 2025".

1	SEC. 2. DEPARTMENT OF DEFENSE STUDY ON FEASIBILITY,
2	COSTS, AND BENEFITS OF PROVIDING HOUS-
3	ING FOR CIVILIAN WORKERS AT CERTAIN
4	NAVAL SHIPYARDS.
5	(a) Study.—The Secretary of Defense, in coordina-
6	tion with the Secretary of the Navy and the Director of
7	the Office of Industrial Policy of the Department of De-
8	fense, shall conduct a study to assess the feasibility, costs,
9	and benefits of providing apartment-style or dormitory
10	housing for civilian workers at covered naval shipyards.
11	Such study shall include each of the following:
12	(1) An assessment of the estimated costs of
13	constructing, maintaining, or leasing apartment-style
14	housing units for shipyard workers.
15	(2) An assessment of the potential economic
16	and workforce benefits, including recruitment and
17	retention rates.
18	(3) An assessment of the feasibility of imple-
19	menting housing solutions at various public shipyard
20	locations.
21	(4) An assessment of the operational effects of
22	providing housing, including on worker availability,
23	morale, and commuting burdens.
24	(5) Options for deducting fair-market rent or
25	below-market housing fees directly from employee

1	paychecks, including administrative, legal, and con-
2	tractual implications.
3	(6) Comparisons with similar workforce housing
4	models used by the Department of Defense or other
5	Federal agencies.
6	(7) Case studies of at least two covered naval
7	shipyards that include specific data on the potential
8	effectiveness of workforce housing solutions.
9	(b) Report.—Not later than 18 months after the
10	date of the enactment of this Act, the Secretary shall sub-
11	mit to Congress a report on the results of the study con-
12	ducted under subsection (a).
13	(c) COVERED NAVAL SHIPYARDS.—In this section, a
14	covered naval shipyard is any of the following:
15	(1) Norfolk Naval Shipyard, Virginia.
16	(2) Pearl Harbor Naval Shipyard and Inter-
17	mediate Maintenance Facility, Hawaii.
18	(3) Portsmouth Naval Shipyard, Maine.
19	(4) Puget Sound Naval Shipyard and Inter-
20	mediate Maintenance Facility, Washington.
