- 4 a highway shall be registered under this subtitle.

- 6 (12) A golf cart that is operated on a highway in accordance with § 21–104.2,
- 7 § 21–104.3, § 21–104.4, [or] § 21–104.6, OR § 21–104.7 of this article;

- 9 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A PERSON WHO
- 10 OPERATES A GOLF CART ON A HIGHWAY IN THE TOWN OF CHARLESTOWN, CECIL
- 11 COUNTY, WITHOUT REGISTRATION AS AUTHORIZED UNDER § 13–402(C)(12) OF THIS
- 12 ARTICLE:
- 13 (1) MAY OPERATE THE GOLF CART ONLY:
- 14 (I) ON A HIGHWAY ON WHICH THE MAXIMUM POSTED SPEED
- 15 LIMIT DOES NOT EXCEED 30 MILES PER HOUR; AND
- 16 (II) IF THE GOLF CART IS EQUIPPED WITH LIGHTING DEVICES
- 17 AS REQUIRED BY THE ADMINISTRATION;
- 18 (2) SHALL KEEP THE GOLF CART AS FAR TO THE RIGHT OF THE
- 19 ROADWAY AS FEASIBLE; AND
- 20 (3) SHALL POSSESS A VALID DRIVER'S LICENSE.
- 21 (B) THE TOWN COMMISSIONERS OF THE TOWN OF CHARLESTOWN MAY
- 22 DESIGNATE BY RESOLUTION THE HIGHWAYS IN THE TOWN OF CHARLESTOWN,
- 23 CECIL COUNTY, ON WHICH A PERSON MAY OPERATE A GOLF CART.
