A BILL

1	SEC. 6. GUIDANCE AND SUPPORT FOR INDIGENOUS FOR-
2	EIGN TREATMENT CENTERS AND PROGRAMS
3	FOR VICTIMS OF TORTURE.
4	(a) In General.—The Administrator of the United
5	States Agency for International Development shall provide
6	guidance and support for indigenous foreign treatment
7	centers and programs for victims of torture in order to
8	increase the capacity of such centers and programs and
9	to train other local health care providers, including hos-
10	pitals, clinics and other health treatment facilities.
11	(b) Authorization of Appropriations.—Of the
12	amounts authorized to be appropriated for fiscal years
13	2018 and 2019 to carry out section 130 of the Foreign
14	Assistance Act of 1961, there are authorized to be appro-
15	priated to the Administrator 11,000,000 to carry out sub-
16	section (a) for each of the fiscal years 2018 and 2019.
