Mr. MANN introduced the following bill; which was referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Transportation and Infrastructure, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To prohibit the importation of all petroleum products originating from Russia into the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Use Stocks, Stop Rus-
5 sia Act of 2022”.

1 **SEC. 2. PROHIBITION ON IMPORTATION OF RUSSIAN PE-**
2 **TROLEUM PRODUCTS.**

3 (a) PROHIBITION.—The President shall prohibit the
4 importation of all petroleum products (as such term is de-
5 fined in section 3 of the Energy Policy and Conservation
6 Act (42 U.S.C. 6202)) originating from Russia into the
7 customs territory of the United States (as such term is
8 defined in General Note 2 of the Harmonized Tariff
9 Schedule).

10 (b) REMOVAL.—The President may remove the prohi-
11 bition under subsection (a) with respect to petroleum
12 products described in such subsection if the President de-
13 termines that all hostile Russian troops have been with-
14 drawn from areas under the sovereignty of Ukraine.

15 **SEC. 3. KEYSTONE XL PIPELINE.**

16 (a) AUTHORIZATION.—TransCanada Keystone Pipe-
17 line, L.P. may construct, connect, operate, and maintain
18 the pipeline facilities at the international border of the
19 United States and Canada at Phillips County, Montana,
20 for the import of oil from Canada to the United States
21 as described in the Presidential Permit of March 29, 2019
22 (84 Fed. Reg. 13101 (April 3, 2019)).

23 (b) PRESIDENTIAL PERMITS.—No Presidential per-
24 mit or any other Executive order shall be required for the
25 construction, connection, operation, or maintenance of the
26 pipeline facilities described in paragraph (1).

1 **SEC. 4. SENSE OF CONGRESS REGARDING DOMESTIC ETH-**
2 **ANOL AND OTHER FUELS.**

3 It is the sense of Congress that the United States—

4 (1) can use domestically produced energy, in-
5 cluding renewable energy, to meet the current de-
6 mand for energy in the United States; and

7 (2) should prioritize the use of available inven-
8 tories and surpluses of fossil fuel and ethanol in the
9 United States before using fossil fuel and ethanol
10 that is imported from foreign countries.

11 **SEC. 5. PROHIBITION ON DRAWDOWN AND SALE OF PETRO-**
12 **LEUM PRODUCTS FROM THE STRATEGIC PE-**
13 **TROLEUM RESERVE.**

14 Notwithstanding any other provision of law, during
15 the period that begins on the date of enactment of this
16 Act and ends on the date the President determines that
17 all hostile Russian troops have been withdrawn from areas
18 under the sovereignty of Ukraine, the drawdown and sale
19 of petroleum products from the Strategic Petroleum Re-
20 serve is prohibited.
