4 FOR the purpose of requiring the Baltimore County School Board Nominating Commission 5 to hold a public hearing on the selection of a nominee for a single vacancy on the 6 Baltimore County Board of Education in a certain manner under certain 7 circumstances; requiring the Commission to make publicly available on its website 8 live video streaming of certain public hearings and certain archived video recordings; 9 authorizing the Commission to retain and reactivate the applications of certain candidates for certain vacancies on the county board; authorizing the Commission to 10 11 reactivate certain applications under certain circumstances; making conforming 12 changes; and generally relating to vacancy procedures and the Baltimore County School Board Nominating Commission. 13

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 20 That the Laws of Maryland read as follows:

- 23 (a) (1) There is a Baltimore County School Board Nominating Commission.
- 24 (2) The purpose of the Commission is to select nominees to be 25 recommended to the Governor as qualified candidates for appointment to the Baltimore



- 1 County Board of Education.
- 2 (3) (I) The Commission shall hold at least three public hearings, each
- 3 in a different councilmanic district, on the selection of MULTIPLE nominees before
- 4 recommending to the Governor nominees for appointment to the county board.
- 5 (II) FOR A SINGLE VACANCY ON THE COUNTY BOARD, THE
- 6 COMMISSION SHALL HOLD PUBLIC MEETINGS IN THE FOLLOWING MANNER ON THE
- 7 SELECTION OF A NOMINEE BEFORE RECOMMENDING TO THE GOVERNOR THE
- 8 NOMINEE FOR APPOINTMENT TO THE COUNTY BOARD:
- 9 1. FOR A VACANCY IN A COUNCILMANIC DISTRICT, AT

- 21 (b) (1) The Commission consists of 19 members who shall be appointed in

- 25 (3) The Governor, in consultation with the County Executive of Baltimore
- 26 County, shall appoint eight members, one from each legislative district that lies in whole
- 27 or in part in Baltimore County.
- 28 (4) The County Executive of Baltimore County shall appoint one member

- 30 (5) The following organizations each shall appoint one member:

10	(ix) The Council of Administrative and Supervisory Employees; and
11	(x) The Education Support Personnel of Baltimore County.
12 13	(c) (1) The County Executive for Baltimore County shall designate one of the Commission's members as chair of the Commission.
14	(2) The term of the chair of the Commission is 4 years.
15	(3) The term of a member of the Commission is 4 years.
16	(d) The Baltimore County Public Schools shall provide staff for the Commission.
17 18	(e) Beginning October 1, 2018, for each nomination for a vacancy on the county board, the Commission shall submit to the Governor a list of nominees that contains:
19	(1) At least two names for each vacancy; or
20 21	(2) If there are fewer than two applicants for a vacancy, the number of names that is equal to the number of applicants for the vacancy.
22 23 24 25 26	(F) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE COMMISSION MAY RETAIN AND REACTIVATE THE APPLICATION OF A CANDIDATE FOR A VACANCY ON THE COUNTY BOARD FOR UP TO 2 YEARS FROM THE DATE THE COMMISSION SUBMITTED THE LIST OF NOMINEES TO THE GOVERNOR FOR THE VACANCY FOR WHICH THE APPLICANT WAS INITIALLY CONSIDERED.
27 28	(2) (I) THE COMMISSION MAY REACTIVATE THE APPLICATION OF A CANDIDATE UNDER PARAGRAPH (1) OF THIS SUBSECTION ONLY WITH THE

CONSENT OF THE APPLICANT.

- 1 (II) TO REACTIVATE AN APPLICATION UNDER THIS 2 SUBSECTION, THE COMMISSION SHALL:
- 3 WITHIN 14 DAYS OF THE DATE OF THE NEW VACANCY,
- 4 SEND A NOTICE TO THE APPLICANT REQUESTING CONSENT TO REACTIVATE THEIR
- 5 APPLICATION; AND
- 2. WITHIN 14 DAYS OF THE DATE THE APPLICANT RECEIVED THE NOTICE UNDER ITEM 1 OF THIS SUBPARAGRAPH, RECEIVE THE
- 8 CONSENT OF THE APPLICANT.
- 9 **[**(f)**] (G)** (1) Absent an extraordinary circumstance, the Governor shall appoint a member to the county board from the list provided by the Commission.
- 11 (2) If the Governor elects not to appoint a member from a list submitted by
- 12 the Commission, the Governor shall return the list to the Commission and request that the
- 13 Commission submit the names of additional qualified candidates.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 15 1, 2021.
