

1 AN ACT relating to the Kentucky Horse Racing and Gaming Corporation and
2 declaring an emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 230.210 is amended to read as follows:

5 As used in this chapter, unless the context requires otherwise:

- 6 (1) "Advance deposit account wagering" means a form of pari-mutuel wagering in
7 which an individual may establish an account with a person or entity licensed by the
8 corporation, and may place a pari-mutuel wager through that account that is
9 permitted by law;
- 10 (2) "Advance deposit account wagering licensee" means a person or entity licensed by
11 the corporation to conduct advance deposit account wagering and accept deposits
12 and wagers, issue a receipt or other confirmation to the account holder evidencing
13 such deposits and wagers, and transfer credits and debits to and from accounts;
- 14 (3) "Amateur youth sporting event" means any sporting event in which an individual:
15 (a) Shall be less than eighteen (18) years of age to participate; and
16 (b) Is prohibited, as a condition of participating in the sporting event, from
17 receiving direct or indirect compensation for the use of the individual's
18 athletic skill in any manner with respect to the sport in which the particular
19 sporting event is conducted;
- 20 (4) "Appaloosa race" or "Appaloosa racing" means that form of horse racing in which
21 each horse participating in the race is registered with the Appaloosa Horse Club of
22 Moscow, Idaho, and is mounted by a jockey;
- 23 (5) "Arabian" means a horse that is registered with the Arabian Horse Registry of
24 Denver, Colorado;
- 25 (6) "Association" means any person licensed by the Kentucky Horse Racing and
26 Gaming Corporation under KRS 230.300 and engaged in the conduct of a
27 recognized horse race meeting;

- 1 (7) "Charitable gaming" means gaming licensed by the corporation on and after July 1,
2 2025, as authorized under this chapter and KRS Chapter 238;
- 3 (8) "Corporation" means the Kentucky Horse Racing and Gaming Corporation;
- 4 (9) "Geofence" means a virtual geographic boundary defined by Global Positioning
5 System (GPS) or Radio Frequency Identification (RFID) technology;
- 6 (10) "Harness race" or "harness racing" means trotting and pacing races of the
7 standardbred horses;
- 8 (11) "Horse race meeting" means horse racing run at an association licensed and
9 regulated by the Kentucky Horse Racing and Gaming Corporation, and may include
10 Thoroughbred, harness, Appaloosa, Arabian, paint, and quarter horse racing;
- 11 (12) "Host track" means the track conducting racing and offering its racing for intertrack
12 wagering, or, in the case of interstate wagering, means the Kentucky track
13 conducting racing and offering simulcasts of races conducted in other states or
14 foreign countries;
- 15 (13) "Interstate wagering" means pari-mutuel wagering on simulcast horse races from a
16 track located in another state or foreign country by patrons at a receiving track or
17 simulcast facility;
- 18 (14) "Intertrack wagering" means pari-mutuel wagering on simulcast horse races from a
19 host track by patrons at a receiving track;
- 20 (15) "Kentucky~~[-quarter horse,]~~ paint horse, Appaloosa, and Arabian purse fund" means
21 a purse fund established to receive funds as specified in KRS 230.3771 for purse
22 programs established in KRS 230.446 to supplement purses for~~[-quarter horse,]~~
23 paint horse, Appaloosa, and Arabian horse races. The purse program shall be
24 administered by the Kentucky Horse Racing and Gaming Corporation;
- 25 (16) **"Kentucky quarter horse purse fund" means a purse fund established to receive**
26 **funds as specified in Section 11 of this Act for purse programs established in**
27 **Section 14 of this Act to supplement purses for quarter horse races. The purse**

1 *program shall be administered by the Kentucky Horse Racing and Gaming*
2 *Corporation;*

3 (17) "Kentucky resident" means:

- 4 (a) An individual domiciled within this state;
- 5 (b) An individual who maintains a place of abode in this state and spends, in the
6 aggregate, more than one hundred eighty-three (183) days of the calendar year
7 in this state; or
- 8 (c) An individual who lists a Kentucky address as his or her principal place of
9 residence when applying for an account to participate in advance deposit
10 account wagering;

11 (18)~~(17)~~ "Licensed facility for sports wagering" means the designated areas to conduct
12 sports wagering for a track licensed to conduct sports wagering pursuant to KRS
13 230.811;

14 (19)~~(18)~~ "Licensed premises" means a track or simulcast facility licensed by the
15 corporation under this chapter;

16 (20)~~(19)~~ "Paint horse" means a horse registered with the American Paint Horse
17 Association of Fort Worth, Texas;

18 (21)~~(20)~~ "Pari-mutuel wagering," "pari-mutuel system of wagering," or "mutuel
19 wagering" each means any method of wagering previously or hereafter approved by
20 the corporation in which one (1) or more patrons wager on a horse race or races,
21 whether live, simulcast, or previously run. Wagers shall be placed in one (1) or
22 more wagering pools, and wagers on different races or sets of races may be pooled
23 together. Patrons may establish odds or payouts, and winning patrons share in
24 amounts wagered including any carryover amounts, plus any amounts provided by
25 an association less any deductions required, as approved by the corporation and
26 permitted by law. Pools may be paid out incrementally over time as approved by
27 the corporation;

1 ~~(22)~~~~(21)~~ "Person" means an individual, sole proprietorship, partnership, association,
2 fiduciary, corporation, limited liability company, or any other business entity;

3 ~~(23)~~~~(22)~~ "President" means the president of the Kentucky Horse Racing and Gaming
4 Corporation, who shall serve as chief executive officer of the corporation;

5 ~~(24)~~~~(23)~~ "Principal" means any of the following individuals associated with a
6 partnership, trust, association, limited liability company, or corporation that is
7 licensed to conduct a horse race meeting or an applicant for a license to conduct a
8 horse race meeting:

9 (a) The chairman and all members of the board of directors of a corporation;

10 (b) All partners of a partnership and all participating members of a limited
11 liability company;

12 (c) All trustees and trust beneficiaries of an association;

13 (d) The president or chief executive officer and all other officers, managers, and
14 employees who have policymaking or fiduciary responsibility within the
15 organization;

16 (e) All stockholders or other individuals who own, hold, or control, either directly
17 or indirectly, five percent (5%) or more of stock or financial interest in the
18 collective organization; and

19 (f) Any other employee, agent, guardian, personal representative, or lender or
20 holder of indebtedness who has the power to exercise a significant influence
21 over the applicant's or licensee's operation;

22 **(25) "Proof of wagers" includes any paper, card, certificate, token, or ticket, which**
23 **indicates the details of one (1) or more pari-mutuel wagers that were placed and,**
24 **if such wagers are successful, that winnings are due to the ticket holder from the**
25 **track;**

26 ~~(26)~~~~(24)~~ "Quarter horse" means a horse that is registered with the American Quarter
27 Horse Association of Amarillo, Texas;

1 ~~(27)~~~~(25)~~ "Receiving track" means a track where simulcasts are displayed for wagering
2 purposes. A track that submits an application for intertrack wagering shall meet all
3 the regulatory criteria for granting an association license of the same breed as the
4 host track, and shall have a heated and air-conditioned facility that meets all state
5 and local life safety code requirements and seats a number of patrons at least equal
6 to the average daily attendance for intertrack wagering on the requested breed in the
7 county in which the track is located during the immediately preceding calendar
8 year;

9 ~~(28)~~~~(26)~~ "Simulcast facility" means any facility approved pursuant to KRS 230.380 to
10 simulcast live racing and conduct pari-mutuel wagering on live racing;

11 ~~(29)~~~~(27)~~ "Simulcasting" means the telecast of live audio and visual signals of horse
12 races for the purpose of pari-mutuel wagering;

13 ~~(30)~~~~(28)~~ "Sporting event" means an event at which two (2) or more persons participate
14 in athletic contests, or an event that takes place in relation to athletic contests as
15 approved by the corporation, but shall not include horse racing or amateur youth
16 sports or athletic events in which the majority of participants are under the age of
17 eighteen (18) years;

18 ~~(31)~~~~(29)~~ "Sports governing body" means the organization, league, or association that
19 oversees a sport, prescribes final rules, and enforces codes of conduct with respect
20 to such sport and participants therein;

21 ~~(32)~~~~(30)~~ "Sports wagering" means the wagering conducted under this chapter on
22 sporting events or portions of sporting events, or on the individual performance
23 statistics of athletes in a sporting event or combination of sporting events, in
24 conformance with federal law and as authorized by the corporation pursuant to this
25 chapter;

26 ~~(33)~~~~(31)~~ "Sports wagering device":

27 (a) Means a mechanical, electrical, or computerized contrivance, terminal,

1 device, apparatus, software, piece of equipment, or supply approved by the
2 corporation for conducting sports wagering under this chapter; and

3 (b) Includes a personal computer, mobile device, or other device used in
4 connection with sports wagering not conducted at a licensed facility for sports
5 wagering;

6 ~~(34)~~~~[(32)]~~ "Sports wagering service provider" or "service provider" means a person
7 authorized to conduct or manage sports wagering through an agreement with a track
8 and provide these services at a licensed facility for sports wagering, simulcast
9 facility, or through a website or mobile interface approved by the corporation;

10 ~~(35)~~~~[(33)]~~ "Telephone account wagering" means a form of pari-mutuel wagering where
11 an individual may deposit money in an account at a track and may place a wager by
12 direct telephone call or by communication through other electronic media owned by
13 the holder of the account to the track;

14 ~~(36)~~~~[(34)]~~ "Thoroughbred race" or "Thoroughbred racing" means a form of horse racing
15 in which each horse participating in the race is a Thoroughbred, (i.e., meeting the
16 requirements of and registered with The Jockey Club of New York) and is mounted
17 by a jockey;~~and~~

18 ~~(37)~~~~[(35)]~~ "Track" means any association duly licensed by the Kentucky Horse Racing
19 and Gaming Corporation to conduct horse racing and includes:

20 (a) For facilities in operation as of 2010, the location and physical plant described
21 in the "Commonwealth of Kentucky Initial/Renewal Application for License
22 to Conduct Live Horse Racing, Simulcasting, and Pari-Mutuel Wagering,"
23 filed for racing to be conducted in 2010;

24 (b) Real property of an association, if the association received or receives
25 approval from the corporation after 2010 for a location at which live racing is
26 to be conducted; or

27 (c) One (1) facility or real property that is:

- 1 1. Owned, leased, or purchased by an association within a sixty (60) mile
2 radius of the association's racetrack but not contiguous to racetrack
3 premises, upon corporation approval; and
- 4 2. Not within a sixty (60) mile radius of another licensed track premise
5 where live racing is conducted and not within a forty (40) mile radius of
6 a simulcast facility, unless any affected track or simulcast facility agrees
7 in writing to permit a noncontiguous facility within the protected
8 geographic area;

9 **(38) "Unclaimed pari-mutuel winning ticket":**

10 **(a) Means the proof of wager that would require payment of winnings upon**
11 **submission to the track, but has been presumed abandoned under Section**
12 **42 of this Act; and**

13 **(b) Includes proof of wagers from live racing and simulcasting; and**

14 **(39) "Unredeemed pari-mutuel voucher":**

15 **(a) Means a voucher issued by a licensed track that evidences the value of**
16 **funds or credits available that a patron may use for placing pari-mutuel**
17 **wagers on live or previously run horse races, or which the patron may**
18 **redeem for cash, but has been presumed abandoned under Section 42 of**
19 **this Act; and**

20 **(b) Does not include:**

- 21 **1. Any proof of wagers or any other information related to specific**
22 **wagers placed on live or historical horse racing; or**
- 23 **2. Any vouchers that were voluntarily surrendered for donation to**
24 **charity or similar purposes.**

25 ➔Section 2. KRS 230.215 (Effective July 1, 2025) is amended to read as follows:

- 26 (1) (a) It is the policy of the Commonwealth of Kentucky, in furtherance of its
27 responsibility to foster and to encourage legitimate occupations and industries

1 in the Commonwealth and to promote and to conserve the public health,
2 safety, and welfare, and it is hereby declared the intent of the Commonwealth
3 to foster and to encourage the horse breeding industry within the
4 Commonwealth and to encourage the improvement of the breeds of horses.

5 (b) Further, it is the policy and intent of the Commonwealth to foster and to
6 encourage the business of legitimate horse racing with pari-mutuel wagering
7 thereon in the Commonwealth on the highest possible plane. Further, it hereby
8 is declared the policy and intent of the Commonwealth that all racing not
9 licensed under this chapter is a public nuisance and may be enjoined as such.

10 (c) Further, it is hereby declared the policy and intent of the Commonwealth that
11 the conduct of horse racing, or the participation in any way in horse racing, or
12 the entrance to or presence where horse racing is conducted, is a privilege and
13 not a personal right; and that this privilege may be granted or denied by the
14 corporation or its duly approved representatives acting in its behalf.

15 (d) Further, it is hereby declared the policy and intent of the Commonwealth that
16 citizens shall be allowed to enjoy wagering on sporting events in a controlled
17 environment that protects the citizens from cheating and fraud, and that such
18 wagering shall be best controlled and overseen by the Kentucky Horse Racing
19 and Gaming Corporation, which has demonstrated a long and successful
20 history of regulating wagering.

21 (e) Further, it is hereby declared the policy and intent of the Commonwealth that
22 charitable gaming conducted by charitable organizations is an important
23 method of raising funds for legitimate charitable purposes and is in the public
24 interest. The intent of this chapter and KRS Chapter 238 is to prevent the
25 commercialization of charitable gaming, to prevent participation in charitable
26 gaming by criminal and other undesirable elements, and to prevent the
27 diversion of funds from legitimate charitable purposes, and that charitable

1 gaming shall be ~~best controlled and~~ overseen by the Kentucky Horse Racing
2 and Gaming Corporation.

3 (f) It is hereby declared the intent of the Commonwealth to vest in the
4 corporation the power to regulate the industries under its jurisdiction and
5 ensure compliance, transparency, and protection of the public in
6 accordance with applicable law.

7 (2) (a) It is hereby declared the purpose and intent of this chapter in the interest of
8 the public health, safety, and welfare, to vest in the corporation forceful
9 control of horse racing in the Commonwealth with ~~plenary~~ power to
10 promulgate administrative regulations prescribing conditions under which all
11 legitimate horse racing and wagering thereon is conducted in the
12 Commonwealth so as to encourage the improvement of the breeds of horses in
13 the Commonwealth, to regulate and maintain horse racing at horse race
14 meetings in the Commonwealth of the highest quality and free of any corrupt,
15 incompetent, dishonest, or unprincipled horse racing practices, and to regulate
16 and maintain horse racing at race meetings in the Commonwealth so as to
17 dissipate any cloud of association with the undesirable and maintain the
18 appearance as well as the fact of complete honesty and integrity of horse
19 racing in the Commonwealth.

20 (b) In addition, it is hereby declared the purpose and intent of this chapter to vest
21 in the corporation exclusive jurisdiction over sports wagering in the
22 Commonwealth, with ~~plenary~~ power to promulgate administrative
23 regulations prescribing conditions under which all sports wagering is to be
24 conducted.

25 (c) In addition to the general powers and duties vested in the corporation by this
26 chapter, it is the intent hereby to vest in the corporation the power to eject or
27 exclude from association grounds or any part thereof any person, licensed or

1 unlicensed, whose conduct or reputation is such that his or her presence on
2 association grounds may, in the opinion of the corporation, reflect on the
3 honesty and integrity of horse racing or interfere with either the orderly
4 conduct of horse racing or the orderly conduct of sports wagering.

5 (d) In addition, it is hereby declared the purpose and intent of this chapter to vest
6 in the corporation exclusive jurisdiction over charitable gaming in the
7 Commonwealth, with ~~plenary~~ power to promulgate administrative
8 regulations prescribing conditions under which all charitable gaming is to be
9 conducted.

10 (e) In addition to the general powers and duties vested in the corporation by this
11 chapter, it is the intent hereby to vest in the corporation the power to eject or
12 exclude from charitable gaming facilities or any part thereof any person,
13 licensed or unlicensed, whose conduct or reputation is such that his or her
14 presence at a charitable gaming facility may, in the opinion of the corporation,
15 reflect on the honesty and integrity of charitable gaming or interfere with the
16 orderly conduct of charitable gaming.

17 ➔Section 3. KRS 230.225 is amended to read as follows:

18 (1) There is hereby created and established the Kentucky Horse Racing and Gaming
19 Corporation to regulate all forms of live horse racing, pari-mutuel wagering, sports
20 wagering, breed integrity and development, and on and after July 1, 2025,
21 charitable gaming, in the Commonwealth, exclusive of the state lottery established
22 under KRS Chapter 154A. It shall be an independent, de jure municipal corporation
23 and political subdivision of the Commonwealth of Kentucky which shall be a public
24 body corporate and politic. The corporation shall be deemed a public agency within
25 the meaning of KRS 61.805 and 61.870. The corporation shall be managed in such
26 a manner that enables the people of the Commonwealth to benefit from its actions
27 and to enjoy the best possible racing and gaming experiences. The General

1 Assembly hereby recognizes that the operations of racing and gaming are unique
2 activities for state government and that a corporate structure will best enable racing
3 and gaming to be managed in a businesslike manner. It is the intent of the General
4 Assembly that the Kentucky Horse Racing and Gaming Corporation shall be
5 accountable to the Governor, the General Assembly, and the people of the
6 Commonwealth.

7 (2) (a) 1. The Auditor of Public Accounts shall perform an ~~annual~~ audit of the
8 corporation once every four (4) years, a copy of which shall be sent to
9 the Governor and the Legislative Research Commission.

10 2. A different auditing entity that is qualified to evaluate municipal
11 corporations shall conduct an annual audit of the corporation once
12 each year in every year when the Auditor of Public Accounts does not
13 perform an audit. A copy of this audit shall be sent to the Governor
14 and Legislative Research Commission.

15 3. This first audit conducted under this subsection shall cover fiscal year
16 2026-2027.

17 (b) The corporation shall submit a written annual report to the Governor and the
18 Legislative Research Commission on or before July 1 of each year. The first
19 report shall be due July 1, 2025. The corporation shall file any additional
20 reports requested by the Governor or the Legislative Research Commission.
21 The annual report shall include the following information:

- 22 1. The receipts and disbursements of the corporation; and
- 23 2. Actions taken by the corporation.

24 (c) The corporation may submit any additional information and recommendations
25 that the corporation considers useful or that the Governor or the Legislative
26 Research Commission requests.

27 (3) The Kentucky Horse Racing and Gaming Corporation shall be administered by a

1 board of directors to regulate the conduct of:

- 2 (a) Live horse racing;
- 3 (b) Pari-mutuel wagering;
- 4 (c) Sports wagering;
- 5 (d) Charitable gaming on and after July 1, 2025;
- 6 (e) Breed integrity and development; and
- 7 (f) Related activities within the Commonwealth of Kentucky.

8 (4) (a) The corporation shall establish and maintain a general office for the
9 transaction of its business and may, in its discretion, establish a branch office
10 or offices.

11 (b) The corporation may hold meetings at any of its offices or at any other place
12 at its convenience.

13 (c) A majority of the voting members of the corporation shall constitute a quorum
14 for the transaction of its business or exercise of any of its powers.

15 (5) Except as otherwise provided, the corporation shall be responsible for the
16 following:

17 (a) Developing and implementing programs designed to ensure the safety and
18 well-being of horses, jockeys, and drivers;

19 (b) Developing programs and procedures that will ~~aggressively~~ fulfill its
20 oversight and regulatory role on such matters as medical practices and
21 integrity issues;

22 (c) Recommending tax incentives and implementing incentive programs to ensure
23 the strength and growth of the equine industry;

24 (d) Designing and implementing programs that strengthen the ties between
25 Kentucky's horse industry and the state's universities, with the goal of
26 significantly increasing the economic impact of the horse industry on
27 Kentucky's economy, improving research for the purpose of promoting the

- 1 enhanced health and welfare of the horse, and other related industry issues;
- 2 (e) Developing and supporting programs which ensure that Kentucky remains in
- 3 the forefront of equine research;
- 4 (f) Designing and implementing programs that support and ensure breed integrity
- 5 and development;
- 6 (g) Developing monitoring programs to ensure the highest integrity of sporting
- 7 events and sports wagering;
- 8 (h) Developing a program to share wagering information with sports governing
- 9 bodies upon which sports wagering may be conducted. The program shall be
- 10 designed to assist the corporation in determining potential problems or
- 11 questionable activity and provide reports to sports governing bodies
- 12 effectively;
- 13 (i) Developing programs and procedures that will~~[-aggressively]~~ fulfill its
- 14 oversight and regulatory role to ensure the highest integrity in charitable
- 15 gaming;
- 16 (j) Developing programs and procedures that will~~[-aggressively]~~ provide
- 17 oversight and regulation for all current forms of gaming and wagering;
- 18 **(k) Annually evaluating the allocation and use of funds among the purposes**
- 19 **listed in Section 10 of this Act from unredeemed pari-mutuel vouchers;** and
- 20 ~~(L)(k)~~ Ensuring that the correct responsibilities are assigned to each of its
- 21 offices as established in KRS 230.232.
- 22 (6) (a) The corporation shall ~~[-~~
- 23 ~~1.---~~conduct all procurements in accordance with procedures which are not
- 24 inconsistent with the provisions of KRS Chapter 45A and this chapter;
- 25 provided, however, that this chapter shall control if and to the extent that
- 26 any provision in this chapter is expressly inconsistent with any provision
- 27 of KRS Chapter 45A.~~[-or]~~

1 ~~(b)(2)~~ **The corporation may** promulgate administrative regulations establishing
2 its procurement procedures. If the corporation elects to promulgate
3 administrative regulations establishing its procurement procedures rather than
4 conduct procurements in accordance with KRS Chapter 45A, the corporation
5 may include sections of KRS Chapter 45A as part of its administrative
6 regulations.

7 ~~(c)(b)~~ Major procurements for personal service contracts shall not be subject to
8 the requirements of KRS 45A.695(2)(b) due to the unique operational
9 activities conducted for state government by the corporation. The
10 corporation's procurement procedures or administrative regulations shall be
11 designed to provide for the purchase of supplies, equipment, services, and
12 construction items that provide the greatest long-term benefit to the state and
13 the greatest integrity for the corporation and the public.

14 ~~(d)(e)~~ In its bidding and negotiation processes, the corporation may do its own
15 bidding and procurement, or may utilize the services of the Finance and
16 Administration Cabinet, or a combination thereof. The president of the
17 corporation may, in lieu of the secretary of the Finance and Administration
18 Cabinet, declare an emergency for purchasing purposes.

19 (7) Corporation records shall be open and subject to public inspection in accordance
20 with KRS 61.870 to 61.884 unless:

- 21 (a) A record is exempted from inspection under KRS 61.878;
- 22 (b) A record involves a trade secret or other legally protected intellectual property
23 or confidential proprietary information of the corporation or of an applicant,
24 licensee, individual, or entity having submitted information of such character
25 to the corporation, in which case, the portion of the record relating to these
26 subjects may be closed; or
- 27 (c) The disclosure of the record could impair or adversely affect the operational

1 security of the corporation in the regulation of matters within its jurisdiction
2 or could impair or adversely impact the operational security of applicants or
3 licensees.

4 (8) Meetings of the corporation through its board of directors shall be open to the
5 public in accordance with KRS 61.800 to 61.850 unless the exceptions set forth in
6 KRS 61.810 apply or the meeting addresses trade secrets, confidential or
7 proprietary information, or operational security issues as described in subsection
8 (7)(c) of this section. If this is the case, the corporation may meet in closed session
9 and shall follow the procedures set forth in KRS 61.815.

10 (9) *The corporation may participate in all state agency price contracts to the same*
11 *extent as agencies of the Commonwealth in accordance with KRS 45A.050(3).*

12 **(10)** (a) The corporation is hereby authorized to accept and expend such moneys as
13 may be appropriated by the General Assembly or such moneys as may be
14 received from any source for effectuating its purposes, including without
15 limitation the payment of the initial expenses of administration and operation
16 of the corporation.

17 (b) After the transfer to the corporation of any funds appropriated in fiscal year
18 2024-2025 and fiscal year 2025-2026 for the administration of this chapter
19 and KRS Chapter 238, the corporation shall be self-sustaining and self-funded
20 and moneys in the state general fund shall not be used or obligated to pay the
21 expenses of the corporation.

22 **(11)**~~**(10)**~~ On July 1, 2024:

23 (a) The Kentucky Horse Racing and Gaming Corporation shall assume all
24 responsibilities of the Kentucky Horse Racing Commission;

25 (b) The Kentucky Horse Racing Commission shall be abolished and all
26 employees of the Kentucky Horse Racing Commission are transferred to the
27 corporation; and

1 (c) All personnel, equipment, and funding shall be transferred from the Kentucky

~~(c)}~~ Except for the Thoroughbred steward and the standardbred judge authorized in subsection (1) of this section, the employees referred to in this section shall be~~[deemed employees of the corporation, and are]~~ paid by the licensee or association.

(4) Each person, as a condition precedent to the privilege of receiving a license under this chapter to conduct a horse race meeting, shall be deemed to have agreed to pay expenses and compensation as provided in this section and as may be actually and reasonably incurred.

11 itself; and any individual with a ten percent (10%) or more financial interest in the
12 applicant. The office shall require the fingerprinting of all applicants for licensure
13 under KRS 238.530 and 238.555 and may require, if deemed reasonably necessary,
14 the fingerprints of all applicants for licensure under KRS 238.535, who are natural
15 persons in connection with the national criminal history background check to assure
16 the identity of the applicant or applicants. The office may charge a reasonable fee
17 not to exceed the actual cost of fingerprinting and records searching.

18 (4) No applicant shall be licensed and no license holder shall be able to maintain a
19 license if an individual associated with the applicant or license holder in a capacity
20 listed in subsection (3) of this section or the applicant or license holder itself has
21 been convicted of a felony, gambling offense, criminal fraud, forgery, theft,
22 falsifying business records, violation of KRS 238.995(7), or any two (2)
23 misdemeanor crimes in federal court or the courts of any state, the District of
24 Columbia, or any territory, consistent with the provisions of KRS Chapter 335B
25 within ten (10) years preceding the application for licensure.

26 (5) No applicant shall be licensed unless all applicants required to be fingerprinted
27 under the provision of subsection (3) of this section have been fingerprinted. The

1 Department of Kentucky State Police may submit fingerprints of any applicant to
2 the Federal Bureau of Investigation for the national criminal history background
3 check. The corporation may by administrative regulation impose additional
4 qualifications to meet the requirements of Pub. L. No. 92-544.

5 (6) If a change occurs in any information submitted during the license application
6 process, the applicant or licensee shall notify the office in writing within thirty (30)
7 days of the date the change occurred.

8 ➔Section 28. KRS 238.535 (Effective July 1, 2025) is amended to read as
9 follows:

10 (1) Any charitable organization conducting charitable gaming in the Commonwealth of
11 Kentucky shall be licensed by the corporation~~office~~. A charitable organization
12 qualifying under subsection (12) of this section but not exceeding the limitations
13 provided in this subsection shall be exempt from the licensure requirements when
14 conducting the following charitable gaming activities:

- 15 (a) Bingo in which the gross receipts do not exceed a total of twenty-five
16 thousand dollars (\$25,000) per year;
- 17 (b) A raffle or raffles for which the gross receipts do not exceed twenty-five
18 thousand dollars (\$25,000) per year; and
- 19 (c) A charity fundraising event or events that do not involve special limited
20 charitable games and the gross gaming receipts for which do not exceed
21 twenty-five thousand dollars (\$25,000) per year.

22 However, at no time shall a charitable organization's total limitations under this
23 subsection exceed twenty-five thousand dollars (\$25,000).

24 (2) (a) Any charitable organization exempt from the process of applying for a license
25 under subsection (1) of this section, shall notify the office in writing, on a
26 simple form issued by the office, of its intent to engage in exempt charitable
27 gaming and the address at which the gaming is to occur. Any charitable

1 organization exempt from the process of applying for a license under
2 subsection (1) of this section, shall comply with all other provisions of this
3 chapter relating to the conduct of charitable gaming, except:

- 4 1. Payment of the fee imposed under the provisions of KRS 238.570; and
- 5 2. The quarterly reporting requirements imposed under the provisions of
6 KRS 238.550(7), unless the exempt charitable organization obtains a
7 retroactive license pursuant to subsection (9) of this section.

8 (b) Before January 31 of the year immediately following the year of exemption, a
9 charitable organization exempt from licensure under the provisions of
10 subsection (1) of this section shall file a financial report with the office, on a
11 form issued by the office, that contains the following information:

- 12 1. The type of gaming activity in which it engaged during that year;
- 13 2. The total gross receipts derived from gaming;
- 14 3. The amount of charitable gaming expenses paid;
- 15 4. The amount of net receipts derived; and
- 16 5. The disposition of those net receipts.

17 (3) An exemption that has been granted to a charitable organization for the preceding
18 calendar year shall be automatically renewed on January 1 of the following year.

19 (4) If upon receipt of the financial report the office determines that the information
20 appearing on the financial report renders the charitable organization ineligible to
21 possess an exemption, the office shall notify the charitable organization that its
22 exemption is rescinded. The organization may request an appeal of this rescission
23 pursuant to KRS 238.565.

24 (5) If the annual financial report is not received by January 31, the exemption is
25 automatically rescinded unless an extension of no more than thirty (30) days is
26 granted by the office. The organization may request an appeal of this rescission
27 pursuant to KRS 238.565.

- 1 (6) If an exemption is revoked because an organization has exceeded the limit imposed
2 in subsection (1) of this section, the organization shall apply for a retroactive
3 license in accordance with subsection (7) of this section.
- 4 (7) If an organization exceeds the limit imposed by any subsection of this section it
5 shall:
- 6 (a) Report the amount to the office; and
7 (b) Apply for a retroactive charitable gaming license.
- 8 (8) Upon receipt of a report and application for a retroactive charitable gaming license,
9 the office shall investigate to determine if the organization is otherwise qualified to
10 hold the license.
- 11 (9) If the office determines that the applicant is qualified, it shall issue a charitable
12 gaming license retroactive to the date on which the exemption limit was exceeded.
13 The retroactive charitable gaming license shall be issued in the same manner as
14 regular charitable gaming licenses.
- 15 (10) If the office determines that the applicant is not qualified it shall deny the license
16 and take enforcement action, if appropriate.
- 17 (11) Once a retroactive or regular gaming license is issued to an organization, that
18 organization shall not be eligible for exempt status in the future and shall maintain a
19 charitable gaming license if it intends to continue charitable gaming activities,
20 unless the charitable organization has not exceeded the exemption limitations of
21 subsection (1) of this section for a period of two (2) years prior to its exemption
22 request.
- 23 (12) (a) In order to qualify for licensure, a charitable organization shall:
- 24 1. a. Possess a tax exempt status under 26 U.S.C. secs. 501(c)(3),
25 501(c)(4), 501(c)(8), 501(c)(10), or 501(c)(19), or be covered
26 under a group ruling issued by the Internal Revenue Service under
27 authority of those sections; or

1 b. Be organized within the Commonwealth of Kentucky as a local

7 years immediately prior to application for licensure and be able to
8 demonstrate, to the satisfaction of the office, reasonable progress in

10 paragraph, "reasonable progress in accomplishing its charitable
11 purposes" means the regular and uninterrupted conduct of activities
12 within the Commonwealth or the expenditure of funds within the
13 Commonwealth to accomplish relief of poverty, advancement of
14 education, protection of health, relief from disease, relief from suffering
15 or distress, protection of the environment, conservation of wildlife,
16 advancement of civic, governmental, or municipal purposes, or
17 advancement of those purposes delineated in KRS 238.505(3). In order
18 to demonstrate reasonable progress in accomplishing its charitable
19 purposes when applying to renew an existing license, a licensed
20 charitable organization shall additionally provide to the office a detailed
21 accounting regarding its expenditure of charitable gaming net receipts
22 for the purposes described in this paragraph; and
- 23 4. Have maintained an office or place of business, other than for the
24 conduct of charitable gaming, for at least one (1) year in the county in
25 which charitable gaming is to be conducted. The office or place of
26 business shall be a separate and distinct address and location from that
27 of any other licensee of the Office of Charitable Gaming; except that up

1 to three (3) licensed charitable organizations may have the same address
2 if they legitimately share office space.

3 (b) 1. A charitable organization that has established and maintained an office
4 or place of business in the county for a period of at least one (1) year
5 may hold a raffle drawing or a charity fundraising event, including
6 special limited charity fundraising events, in a Kentucky county other
7 than that in which the organization's office or place of business is

9 2. For raffles, the organization shall notify the Office of Charitable
10 Gaming in writing of the organization's intent to change the drawing's

26 (13) In applying for a license, the information to be submitted shall include but not be
27 limited to the following:

- 1 (a) The name and address of the charitable organization;
- 2 (b) The date of the charitable organization's establishment in the Commonwealth
3 of Kentucky and the date of establishment in the county or counties in which
4 charitable gaming is to be conducted;
- 5 (c) A statement of the charitable purpose or purposes for which the organization
6 was organized. If the charitable organization is incorporated, a copy of the
7 articles of incorporation shall satisfy this requirement;
- 8 (d) A statement explaining the organizational structure and management of the
9 organization. For incorporated entities, a copy of the organizations' bylaws
10 shall satisfy this requirement;
- 11 (e) A detailed accounting of the charitable activities in which the charitable

- 14 (f) The names, addresses, dates of birth, and Social Security numbers of all
15 officers of the organization;
- 16 (g) The names, addresses, dates of birth, and Social Security numbers of all
17 employees and members of the charitable organization who will be involved
18 in the management and supervision of charitable gaming. No fewer than two
19 (2) employees or members of the charitable organization who are involved in
20 the management and supervision of charitable gaming, along with the chief
21 executive officer or the director of the applicant organization, shall be
22 designated as chairpersons;
- 23 (h) The address of the location at which charitable gaming will be conducted and
24 the name and address of the owner of the property, if it is owned by a person
25 other than the charitable organization;
- 26 (i) A copy of the letter or other legal document issued by the Internal Revenue
27 Service to grant tax-exempt status;

- 1 (j) A statement signed by the presiding or other responsible officer of the
2 charitable organization attesting that the information submitted in the
3 application is true and correct and that the organization agrees to comply with
4 all applicable laws and administrative regulations regarding charitable
5 gaming;
- 6 (k) An agreement that the charitable organization's records may be released by
7 the Federal Internal Revenue Service to the office; and
- 8 (l) Any other information the office deems appropriate.
- 9 (14) (a) An organization or a group of individuals that does not meet the licensing
10 requirements of subsection (12) of this section may hold a raffle if:
- 11 1. The gross receipts do not exceed five hundred dollars (\$500);
12 2. All proceeds from the raffle are distributed to a charitable organization;
13 and
14 3. The organization or group of individuals holds no more than three (3)
15 raffles each year;
- 16 and shall be exempt from complying with the notification, application, and
17 reporting requirements of subsections (2) and (13) of this section.
- 18 (b) An organization or a group of individuals that does not meet the licensing
19 requirements of subsection (12) of this section may hold a raffle if:
- 20 1. The organization holds a special event raffle license issued by the office
21 and complies with the regulatory requirements in this chapter, including
22 but not limited to the quarterly reporting requirements of KRS
23 238.550(7), the retention requirements of KRS 238.536, and payment of
24 the fee imposed by KRS 238.570;
- 25 2. The organization possesses a tax-exempt status under 26 U.S.C. sec.
26 501(c)(7);
- 27 3. The organization holds no more than twelve (12) raffles per year;

- 1 4. Each raffle complies with the office's raffle standards in KRS 238.545
- 2 and administrative regulations promulgated thereunder and is approved
- 3 by the office in writing prior to the sale of the first raffle ticket;
- 4 5. The gross receipts of each raffle do not exceed five hundred thousand
- 5 dollars (\$500,000); and
- 6 6. One hundred percent (100%) of the net receipts of each raffle shall be
- 7 distributed to a charitable organization licensed by the office pursuant to
- 8 subsection (12) of this section to conduct charitable gaming as follows:
- 9 a. All distributed net receipts shall be maintained by the recipient
- 10 licensed charitable organization in a separate account to be
- 11 designated as the "raffle recipient account";
- 12 b. All distributed net receipts shall be expended by the recipient

- 16 c. All distributed net receipts, and the expenditure thereof, shall be
- 17 reported to the office and be subject to the office's auditing and

- 20 (c) An applicant qualifying under paragraph (b) of this subsection shall submit an
- 21 application for a special event raffle license, and the information to be
- 22 submitted shall include but not be limited to the following:

- 24 2. The date of the organization's establishment in the Commonwealth of
- 25 Kentucky and the date of the organization's establishment in the county
- 26 or counties in which charitable gaming is to be conducted;
- 27 3. A statement of the purpose or purposes for which the organization was

- 1 organized and identification of the licensed charitable organization to
2 which the applicant will distribute its net receipts. If the organization is
3 incorporated, a copy of the articles of incorporation shall satisfy this

8 in a graduated scale promulgated by administrative regulations of the corporation
9 and based on type of license, type of charitable gaming, actual or projected gross
10 receipts, or other applicable factors, or combination of factors.

11 (17) (a) A licensed charitable organization may place its charitable gaming license in

- 22 1. The charitable organization continues to qualify for licensure;

25 3. The charitable organization pays a reinstatement fee established by the
26 office.

27 ➔Section 29. KRS 238.545 (Effective July 1, 2025) is amended to read as

1 follows:

2 (1) A licensed charitable organization shall be limited by the following:

3 (a) In the conduct of bingo, to one (1) session per day, two (2) sessions per week,
4 for a period not to exceed five (5) consecutive hours in any day and not to
5 exceed ten (10) total hours per week:

6 1. No licensed charitable organization shall conduct bingo at more than
7 one (1) location during the same twenty-four (24) hour period;

8 2. No licensed charitable organization shall award prizes for bingo that
9 exceed five thousand dollars (\$5,000) in fair market value per twenty-
10 four (24) hour period, including the value of door prizes; and

11 3. No person under the age of eighteen (18) shall be permitted to purchase
12 bingo supplies or play bingo unless he or she is playing for noncash
13 prizes and is accompanied by a parent or legal guardian and only if the
14 value of any noncash prize awarded does not exceed ten dollars (\$10);

15 (b) 1. A licensed charitable organization may provide card-minding devices
16 for use by players of bingo games.

17 2. If a licensed charitable organization offers card-minding devices for use
18 by players, the devices shall be capable of being used in conjunction
19 with bingo cards or paper sheets at all times.

20 3. Subject to the authority of the corporation, the office shall have broad
21 authority to define and regulate the use of card-minding devices and the
22 corporation ~~may~~^{shall} promulgate an administrative regulation
23 concerning use and control of them;

24 (c) Charity game tickets shall be sold only at the address of the location
25 designated on the license to conduct charitable gaming;

26 (d) Charity game tickets may be sold, with prior approval of the office:

27 1. At any authorized special charity fundraising event conducted by a

- 1 licensed charitable organization at any off-site location; or
- 2 2. By a licensed charitable organization possessing a special limited
- 3 charitable gaming license at any off-site location; and
- 4 (e) An automated charity game ticket dispenser may be utilized by a licensed
- 5 charitable organization, with the prior approval of the office, only at the
- 6 address of the location designated on the license to conduct charitable gaming.
- 7 The corporation ~~may~~shall promulgate administrative regulations regulating
- 8 the use and control of approved automated charity game ticket dispensers.
- 9 (2) (a) No prize for an individual charity game ticket shall exceed five hundred
- 10 ninety-nine dollars (\$599) in value, not including the value of cumulative or
- 11 carryover prizes awarded in seal card games.
- 12 (b) Cumulative or carryover prizes in seal card games shall not exceed two
- 13 thousand four hundred dollars (\$2,400).
- 14 (c) Information concerning rules of the particular game and prizes that are to be
- 15 awarded in excess of fifty dollars (\$50) in each separate package or series of
- 16 packages with the same serial number and all rules governing the handling of
- 17 cumulative or carryover prizes in seal card games shall be posted prominently
- 18 in an area where charity game tickets are sold. A legible poster that lists prizes
- 19 to be awarded, and on which prizes actually awarded are posted at the
- 20 completion of the sale of each separate package shall satisfy this requirement.
- 21 (d) Any unclaimed money or prize shall return to the charitable organization.
- 22 (e) No paper charity game ticket shall be sold in the Commonwealth of Kentucky
- 23 that does not conform to the standards for opacity, randomization, minimum
- 24 information, winner protection, color, and cutting established by the office.
- 25 (f) No electronic pulltab device representation of a charity game ticket shall be
- 26 sold in the Commonwealth of Kentucky that does not conform to the
- 27 construction standards set forth in an administrative regulation promulgated

1 by the corporation. Electronic pulltab devices shall only be used for charitable
2 gaming.

3 (g) No person under the age of eighteen (18) shall be permitted to purchase, or
4 open in any manner, a charity game ticket.

5 (3) (a) Tickets for a raffle shall be sold separately, and each ticket shall constitute a
6 separate and equal chance to win.

7 (b) All raffle tickets shall be sold for the price stated on the ticket, and no person
8 shall be required to purchase more than one (1) ticket or to pay for anything
9 other than a ticket to enter a raffle.

10 (c) Raffle tickets and tickets for charity fundraising raffle games approved by the
11 office which are offered exclusively at charity fundraising events and special
12 limited charity fundraising events are not required to be sold separately and
13 may be sold at discounted package rates.

14 (d) Raffle tickets shall have a unique identifier on each ticket.

15 (e) Winners shall be drawn at random at a date, time, and place announced in
16 advance or printed on the ticket.

17 (f) All prizes for a raffle shall be identified in advance of the drawing and all
18 prizes identified shall be awarded.

19 (4) With respect to charity fundraising events, a licensed charitable organization shall
20 be limited as follows:

21 (a) No licensed charitable organization shall conduct a charity fundraising event
22 or a special limited charity fundraising event unless they have a license for the
23 respective event issued by the office;

24 (b) No special license shall be required for any wheel game, such as a cake wheel,
25 that awards only noncash prizes the value of which does not exceed one
26 hundred dollars (\$100);

27 (c) The office may grant approval for a licensed charitable organization to play

bingo games at a charity fundraising event. Cash prizes for bingo games played during a charity fundraising event may not exceed five thousand dollars (\$5,000) for the entire event. No person under the age of eighteen (18) shall be permitted to play bingo at a charity fundraising event unless accompanied by a parent or legal guardian;

(d) The office may grant approval for a licensed charitable organization to play special limited charitable games at a charity fundraising event authorized under this section. The office shall not grant approval for the playing of special limited charitable games under the provisions of a charity fundraising event license unless the proposed event meets the definition of a charity fundraising event held for community, social, or entertainment purposes apart from charitable gaming in accordance with KRS 238.505(8);

(e) Except for state, county, city fairs, and special limited charity fundraising events, a charity fundraising event license issued under this section shall not exceed seventy-two (72) consecutive hours. A licensed charitable organization shall not be eligible for more than eight (8) total charity fundraising event licenses per year, including two (2) special limited charity fundraising event licenses. No person under eighteen (18) years of age shall be allowed to play or conduct any special limited charitable game. *Subject to the authority of the corporation,* the office shall have broad authority to regulate the conduct of special limited charity fundraising events in accordance with the provisions of KRS 238.547; and

(f) Charity fundraising events may be held:

1. On or in the premises of a licensed charitable organization;
2. In a licensed charitable gaming facility, subject to restrictions contained in KRS 238.555(7); or
3. At an unlicensed facility which shall be subject to the requirements

1 stipulated in KRS 238.555(3), and subject to the restrictions contained in
2 KRS 238.547(2).

3 (5) Presentation of false, fraudulent, or altered identification by a minor shall be an
4 affirmative defense in any disciplinary action or prosecution that may result from a
5 violation of age restrictions contained in this section, if the appearance and
6 character of the minor were such that his or her age could not be reasonably
7 ascertained by other means.

8 ➔Section 30. KRS 238.565 (Effective July 1, 2025) is amended to read as
9 follows:

10 (1) A license holder may appeal any administrative action taken under KRS 238.560. A
11 license holder shall be notified in writing of any action to be taken against him or
12 her. The notification may be delivered in person or mailed by certified mail, return
13 receipt requested, to the last known address of the license holder. Service of
14 notification of administrative action, whether by hand delivery or by certified mail,
15 shall be deemed complete if the license holder fails or refuses to accept delivery.
16 For service by hand delivery, notification shall be deemed received upon
17 acceptance of delivery or upon failure or refusal to accept delivery, and the person
18 affecting service on behalf of the office shall record the fact of the failure or refusal.
19 For service by certified mail, the notification of administrative action shall be

5 (2) (a) Every person who desires to participate in sports wagering in the
6 Commonwealth working in a licensed facility for sports wagering, directly
7 supervising individuals who have the capability of affecting the outcome of
8 sports wagering, or having the capability to affect the outcome of sports
9 wagering through deployment of code to production for any critical
10 component of a sports wagering system or the capability to deploy code to
11 production shall first apply to the corporation for a valid occupational license
12 to participate in that activity.

13 (b) An applicant for an occupational license shall submit to the corporation

23 under which any licensee or other person participating in Kentucky horse racing
24 may be assessed an administrative fine or required to forfeit or return a purse.

25 (2) (a) Following a hearing by the stewards, a person who has been disciplined by a
26 ruling of the stewards may apply to the corporation for a stay of the ruling,
27 pending action on an appeal by the corporation.

- 1 (b) An application for a stay shall be received by the president or his or her
2 designee within ten (10) calendar days of the issuance of the stewards' ruling.
- 3 (c) An application for a stay shall be in writing and include the following:
- 4 1. The name, address, telephone number, and signature of the person
5 requesting the stay;
- 6 2. A statement of the justification for the stay; and
- 7 3. The period of time for which the stay is requested.
- 8 (d) On a finding of good cause, the president or his or her designee may grant the
9 stay. The president or his or her designee shall issue a written decision
10 granting or denying the request for stay within five (5) calendar days from the
11 time the application for stay is received by the president or his or her
12 designee. If the president or his or her designee fails to timely issue a written
13 decision, then the stay is deemed granted. The president or his or her designee
14 may rescind a stay granted under this subsection for good cause.
- 15 (e) A person who is denied a stay by the president or his or her designee, or has a
16 previously granted stay rescinded under paragraph (d) of this subsection, may
17 petition the corporation to overrule the president's or designee's denial or
18 rescission of the stay. The petition shall be filed in writing with the
19 chairperson of the board of directors of the corporation and received by the
20 chairperson within ten (10) calendar days of the mailing of the president's or
21 designee's denial of the stay. The petition shall state the name, address, phone
22 number, and signature of the petitioner; a statement of justification of the stay;
23 and the time period for which the stay is requested. The chairperson shall
24 convene a special meeting of the board of directors of the corporation within
25 ten (10) calendar days of receipt of the petition, and the corporation shall issue
26 a written final order granting or denying the petition within two (2) calendar
27 days of the special meeting. If the corporation fails to timely issue a final

1 order on the petition, then the stay is granted. The corporation may rescind a
2 stay granted under this subsection for good cause.

3 (f) A person who is denied or has a previously granted stay rescinded by the
4 corporation may file an appeal of the final written order of the corporation in
5 the Circuit Court of the county in which the cause of action arose.

6 (g) The fact that a stay is granted is not a presumption that the ruling by the
7 stewards is invalid.

8 (3) If any license is denied, suspended, or revoked, or if any licensee or other person
9 participating in Kentucky horse racing is assessed an administrative fine or required
10 to forfeit or return a purse, after a hearing by the stewards or by the corporation
11 acting on a complaint or by its own volition, the corporation shall grant the
12 applicant, licensee, or other person the right to appeal the decision, and upon
13 appeal, an administrative hearing shall be conducted in accordance with KRS
14 Chapter 13B.

15 (4) The corporation may at any time order that any case pending before the stewards be
16 immediately transferred to the corporation for an administrative hearing conducted
17 in accordance with KRS Chapter 13B.

18 (5) (a) In an administrative appeal to the corporation by a licensee or other person
19 participating in Kentucky horse racing, the corporation may determine in its
20 final order that the appeal is frivolous. If the corporation finds that an appeal
21 is frivolous:

- 22 1. This fact shall be considered an aggravating circumstance and may be
23 considered in assessing any penalty against the licensee; and
- 24 2. The licensee or other person who raised the appeal may be required to
25 reimburse the corporation for the cost of the investigation of the
26 underlying circumstances of the case and the cost of the adjudication of
27 the appeal. Costs may include but are not limited to fees paid to a

1 hearing officer or court reporter, attorneys fees, and laboratory expenses.

2 (b) The corporation ~~may~~~~shall~~ by administrative regulation prescribe the
3 conditions or factors by which an appeal may be determined to be frivolous.

4 (6) Any administrative action authorized in this chapter shall be in addition to any
5 criminal penalties provided in this chapter or under other provisions of law.

6 ➔Section 42. KRS 230.361 is amended to read as follows:

7 (1) (a) The corporation ~~may~~~~shall~~ promulgate administrative regulations governing
8 and regulating mutuel wagering on horse races under what is known as the
9 pari-mutuel system of wagering.

10 (b) The wagering shall be conducted only by a person licensed under this chapter
11 to conduct a race meeting and only upon the licensed premises, and provided
12 further that only pari-mutuel wagering on simulcasting shall be allowed at
13 simulcast facilities.

14 (c) The pari-mutuel system of wagering shall be operated only by a totalizator or
15 other mechanical equipment approved by the corporation. The corporation
16 shall not require any particular make of equipment.

17 (2) The corporation ~~may~~~~shall~~ promulgate administrative regulations governing and
18 regulating sports wagering, including administrative regulations for the deposit of
19 funds by credit or debit cards or other means of electronic funds transfer. The
20 corporation ~~may~~~~shall~~ promulgate administrative regulations to establish a fully
21 functioning sports wagering system within six (6) months after June 29, 2023.

22 (3) The operation of a pari-mutuel system for betting, or the conduct of sports
23 wagering, where authorized by law shall not constitute grounds for the revocation
24 or suspension of any license issued and held under KRS 242.1238 and 243.265.

25 (4) **Notwithstanding any law to the contrary:**

26 **(a) The corporation may promulgate administrative regulations governing** all
27 reported but unclaimed pari-mutuel winning tickets **and unredeemed pari-**

1 mutuel vouchers held in this state by any person or association operating a
2 pari-mutuel or similar system of betting authorized under this chapter; and
3 (b) The unclaimed pari-mutuel winning tickets and unredeemed pari-mutuel
4 vouchers~~[at horse race meetings]~~ shall be presumed abandoned if not claimed
5 by the person entitled to them within one (1) year from the time the ticket was
6 issued~~[became payable]~~.

7 (5) The corporation may issue a license to conduct pari-mutuel wagering on steeple
8 chases or other racing over jumps; if all proceeds from the wagering, after expenses
9 are deducted, is used for charitable purposes. If the dates requested for such a
10 license have been granted to a track within a forty (40) mile radius of the race site,
11 the corporation shall not issue a license until it has received written approval from
12 the affected track. Pari-mutuel wagering licensed and approved under this
13 subsection shall be limited to four (4) days per year. All racing and wagering
14 authorized by this subsection shall be conducted in accordance with applicable
15 administrative regulations promulgated by the corporation.

16 ➔Section 43. KRS 230.374 is amended to read as follows:

17 All sums reported and paid to the corporation under the provisions of KRS 230.361 to
18 230.373, with the exception of funds paid under Section 10 of this Act and KRS 230.398,
19 shall be paid by the corporation to the Kentucky Racing Health and Welfare Fund, Inc., a
20 nonprofit charitable corporation, organized for the benefit, aid, assistance, and relief of
21 Thoroughbred owners, trainers, jockeys, valets, exercise riders, grooms, stable attendants,
22 pari-mutuel clerks, and other Thoroughbred racing personnel employed in connection
23 with racing, and their spouses and children, who can demonstrate their need for financial
24 assistance connected with death, illness, or off-the-job injury and are not otherwise
25 covered by union health and welfare plans, workers' compensation, Social Security,
26 public welfare, or any type of health, medical, death, or accident insurance. These sums
27 shall be paid on or before December 31 in each year, however, no payments shall be

1 made by the corporation to the Kentucky Racing Health and Welfare Fund, Inc., unless
2 the corporation and the Auditor of Public Accounts are satisfied that the fund is in all
3 respects being operated for the charitable and benevolent purposes as set forth in this
4 section and that no part of the funds paid to the fund by the corporation or any net
5 earnings of the fund inure to the benefit of any private individual, director, officer, or
6 member of the fund or any of the persons who turned over sums to the corporation
7 representing unclaimed pari-mutuel tickets.

8 ➔Section 44. KRS 230.779 is amended to read as follows:

9 (1) Notwithstanding KRS 230.361(1), a licensee may operate the hub either
10 independently or in association with one (1) or more racetracks licensed by the
11 corporation to run live races and conduct pari-mutuel wagering in Kentucky. Hub
12 operations may be physically located on property other than that operated by a
13 racetrack and may accept wagers at that location and shall comply with the
14 Interstate Horseracing Act, 15 U.S.C. secs. 3001 to 3007.

15 (2) As a part of the application for licensure as a hub, an applicant shall submit a
16 detailed plan of operations in a format and containing any information as required
17 by the corporation. The application shall be accompanied by an application fee to
18 cover incremental costs to the corporation, in an amount the corporation determines
19 to be appropriate. At a minimum, the operating plan shall address the following:

- 20 (a) The manner in which the proposed wagering system will operate, including its
21 proposed operating schedule;
- 22 (b) The requirements for a qualified subscriber-based service set out in KRS
23 230.775; and
- 24 (c) The requirements for accounts established and operated for persons whose
25 principal residence is outside of the Commonwealth of Kentucky.

26 (3) The corporation may require changes in a proposed plan of operations as a
27 condition of licensure. Subsequent material changes in the system's operation shall

1 not occur unless approved by the corporation.

2 (4) The corporation may conduct investigations or inspections or request additional
3 information from any applicant as it deems appropriate in determining whether to
4 approve the license application.

5 (5) An applicant licensed under this section may enter into any agreements that are
6 necessary to promote, advertise, and further the sport of horse racing, or for the
7 effective operation of hub operations, including, without limitation, interstate
8 account wagering, television production, and telecommunications services.

9 (6) The corporation ~~may~~^{shall} promulgate administrative regulations to effectuate the
10 provisions of KRS 230.775 to 230.785. The administrative regulations shall include
11 but not be limited to criteria for licensing, the application process, the format for the
12 plan of operations, requisite fees, procedures for notifying the corporation of
13 substantive changes, contents of agreements entered into under subsection (5) of
14 this section, procedures for accounting for wagers made, and other matters
15 reasonably necessary to implement KRS 230.775 to 230.785.

16 (7) The corporation may require the hub to make the following payments to the
17 corporation:

18 (a) A license fee not to exceed two hundred dollars (\$200) per operating day; and

19 (b) A fee of not more than one percent (1%) of the hub's total gross wagering
20 receipts.

21 (8) A hub's records and financial information shall not be subject to the provisions of
22 KRS 61.870 to 61.884.

23 (9) The Auditor of Public Accounts may review and audit all records and financial
24 information of the hub, including all account information. The Auditor shall prepare
25 a report of the review and audit which shall not contain any proprietary information
26 regarding the hub. A copy of the report shall be sent to the Legislative Research
27 Commission for referral to the appropriate committee.

1 ➔Section 45. KRS 230.805 is amended to read as follows:

- 2 (1) The corporation shall institute a system of sports wagering in conformance with
3 federal law, this chapter, and by administrative regulations promulgated under the
4 authority of KRS 230.215.
- 5 (2) Sports wagering shall not be offered in this state except as authorized by this
6 section and KRS 230.811. A track that holds a license to operate sports wagering
7 may contract with sports wagering service providers to conduct or manage sports
8 wagering operations as authorized by this chapter. Sports wagering may be
9 provided at a licensed facility for sports wagering or online through a website or
10 mobile application. The licensed facility for sports wagering or a sports wagering
11 service provider may provide sports wagering through a website or mobile interface
12 as approved by the corporation. The corporation may provide temporary licenses to
13 licensed facilities for sports wagering or sports wagering service providers, if the
14 corporation deems that the information submitted by them is sufficient to determine
15 the applicant's suitability. The corporation ~~may~~shall promulgate administrative
16 regulations to establish the suitability for temporary and ordinary license
17 applications for licensed facilities for sports wagering, sports wagering service
18 providers, and any related parties.
- 19 (3) Sports wagering licensees and service providers that accept wagers online via
20 websites and mobile applications shall impose the following requirements:
- 21 (a) Prior to placing a wager online via websites or mobile applications operated
22 by either a sports wagering licensee or a service provider, a patron shall
23 register the patron's sports wagering account with the operating sports
24 wagering licensee or service provider either in person at a licensed facility for
25 sports wagering or remotely through the service provider's website or mobile
26 application;
- 27 (b) 1. The registration process shall include attestation that the patron meets

- 1 the requirements to place a wager with a sports wagering licensee or
2 service provider in this state.
- 3 2. Prior to verification of a patron's identity, a sports wagering licensee or
4 service provider shall not allow the patron to engage in sports wagering,
5 make a deposit, or process a withdrawal via the patron's sports wagering
6 account.
- 7 3. A sports wagering licensee or service provider shall implement
8 commercially and technologically reasonable procedures to prevent
9 access to sports wagering by any person under the age of eighteen (18):
10 a. At a licensed facility; and
11 b. Online via website or mobile application.
- 12 4. A sports wagering licensee or service provider may use information
13 obtained from third parties to verify that a person is authorized to open
14 an account, place wagers, and make deposits and withdrawals;
- 15 (c) A sports wagering licensee or service provider shall adopt an account
16 registration policy to ensure that all patrons are authorized to place a wager
17 with a sports wagering licensee or service provider within the Commonwealth
18 of Kentucky. This policy shall include, without limitation, a mechanism by
19 which to:
- 20 1. Verify the name and age of the patron;
21 2. Verify that the patron is not prohibited from placing a wager; and
22 3. Obtain the following information:
23 a. A physical address other than a post office box;
24 b. A phone number;
25 c. A unique user name; and
26 d. An e-mail account;
- 27 (d) A sports wagering licensee or service provider shall use all commercially and

1 technologically reasonable means to ensure that each patron is limited to one
2 (1) account with that service provider in the Commonwealth, but nothing in
3 this paragraph restricts a patron from holding other sports wagering accounts
4 in other jurisdictions;

5 (e) A sports wagering licensee or service provider, in addition to complying with
6 state and federal law pertaining to the protection of the private, personal
7 information of patrons, shall use all other commercially and technologically
8 reasonable means to protect this information consistent with industry
9 standards;

10 (f) A sports wagering licensee or service provider shall use all commercially and
11 technologically reasonable means to verify the identity of the patron making a
12 deposit or withdrawal;

13 (g) A sports wagering licensee or service provider shall utilize geolocation or
14 geofencing technology to ensure that wagers are only accepted from patrons
15 who are physically located in the Commonwealth. A sports wagering licensee
16 or service provider shall maintain in this state its servers used to transmit
17 information for purposes of accepting or paying out wagers on a sporting
18 event placed by patrons in this state;

19 (h) A patron may fund the patron's account using any acceptable form of payment
20 or advance deposit method, which shall include the use of cash, cash
21 equivalents, credit cards, debit cards, automated clearing house, other
22 electronic methods, and any other form of payment authorized by the
23 corporation; and

24 (i) The corporation may enter into agreements with other jurisdictions or entities
25 to facilitate, administer, and regulate multijurisdictional sports betting by
26 sports betting operators to the extent that entering into the agreement is
27 consistent with state and federal laws and the sports betting agreement is

1 conducted only in the United States.

2 (4) A track may contract with no more than three (3) service providers at a time to
3 conduct and manage services and technology which support the operation of sports
4 betting both on the track and online via websites and mobile applications. The
5 website or mobile application used to offer sports betting shall be offered only
6 under the same brand as the track or that of the service provider contracted with the
7 track, or both.

8 (5) A track or service provider through an agreement with a licensed track shall not
9 offer sports wagering until the corporation has issued a sports wagering license to
10 the track, except for temporary licenses authorized under KRS 230.814.

11 (6) (a) A track licensed under KRS 230.811 may offer sports wagering at a facility
12 that meets the definition of "track" in KRS 230.210.

13 (b) A simulcast facility may offer sports wagering through an agreement with a
14 track by using any of that track's already established service providers.

15 ➔Section 46. KRS 238.536 (Effective July 1, 2025) is amended to read as
16 follows:

17 (1) The net receipts from charitable gaming retained by a charitable organization for
18 the previous calendar year, provided the charitable organization was licensed at the
19 start of the calendar year, shall be equal to or greater than forty percent (40%) of the
20 adjusted gross receipts of the charitable organization for the same period. A
21 licensed charitable organization shall expend net receipts exclusively for purposes
22 consistent with the charitable, religious, educational, literary, civic, fraternal, or
23 patriotic functions or objectives for which the licensed charitable organization
24 received and maintains federal tax-exempt status, or consistent with its status as a
25 local school district, a common school, an institution of higher education, or a state
26 college or university. No net receipts shall inure to the benefits or financial gain of
27 an individual. Any charitable organization which permits its license to expire or

1 otherwise lapse shall still be subject to the retention requirement. The following
2 fees and taxes shall be excluded from the calculation of the percentage retained,
3 retroactive to calculations made for calendar year 1999:

- 4 (a) All fees paid to the office during the calendar year;
- 5 (b) Any sales or use taxes levied under KRS Chapter 139 on charitable gaming
6 supplies and equipment that are paid by a licensed charitable organization
7 during the calendar year; and
- 8 (c) Any federal excise taxes levied under 26 U.S.C. secs. 4401 and 4411 and paid
9 by a licensed charitable organization during the calendar year.

10 (2) The following actions shall be imposed on a licensed charitable organization that
11 fails to retain the requisite percentage of adjusted gross receipts required in
12 subsection (1) of this section. The calculation of percentages shall be rounded to the
13 nearest tenth of a percent:

- 14 (a) If the percentage retained is between thirty-five percent (35%) and thirty-nine
15 and nine-tenths percent (39.9%), the licensee shall be placed on probation for
16 a period of six (6) months and shall be required to submit to the office an
17 acceptable financial plan detailing corrective actions to be taken by the
18 licensee to achieve the forty percent (40%) threshold by the end of the
19 calendar year in which the probation is imposed;
- 20 (b) If the percentage retained is between thirty percent (30%) and thirty-four and
21 nine-tenths percent (34.9%), the licensee shall be placed on probation for a
22 period of one (1) year and shall be required to submit to the office a financial
23 plan as described in paragraph (a) of this subsection. The office shall conduct
24 a six (6) month review of the charitable gaming activities of a licensee placed
25 on probation pursuant to this subsection to evaluate the licensee's compliance
26 with its financial plan;
- 27 (c) If the percentage retained falls between twenty-nine and nine-tenths percent

1 (29.9%) and twenty-five percent (25%), the licensee shall be placed on
2 probation for a period of one (1) year, shall submit to the office an acceptable
3 financial plan as described in paragraph (a) of this subsection, and shall
4 participate in a mandatory training program designed by the office. The office
5 shall conduct a quarterly review of the licensee's activities to evaluate the
6 licensee's compliance with its financial plan and its progress toward
7 achievement of the forty percent (40%) threshold during the probationary
8 period;

9 (d) If the percentage falls below twenty-five percent (25%) or if the licensee fails
10 to attain the forty percent (40%) threshold for a second consecutive calendar
11 year, the licensee shall have its license suspended for a period of one (1) year;
12 and

13 (e) For purposes of paragraphs (a), (b), (c), and (d) of this subsection, periods of
14 probation and suspension shall commence, unless appealed, from the date the
15 office notifies the licensee of its failure to satisfy the retention requirement for
16 the previous calendar year. If a probation or suspension is appealed, the action
17 shall commence on the date final adjudication of the matter is complete.

18 (3) Any licensee that has had its license suspended under the provisions of subsection
19 (2)(d) of this section shall be required to submit to the office an acceptable financial
20 plan as described in subsection (2)(a) of this section, upon applying for
21 reinstatement of its license. As a condition of reinstatement, the licensee shall be on
22 probation for a period of one (1) year and shall be subject to quarterly review by the
23 office in accordance with subsection (2)(c) of this section.

24 ➔Section 47. KRS 238.550 (Effective July 1, 2025) is amended to read as
25 follows:

26 (1) All adjusted gross receipts from charitable gaming shall be handled only by
27 chairpersons, officers, or employees of the licensed charitable organization.

- 1 (2) Except as authorized by subsection (11) of this section, within five (5)~~two (2)~~
2 business days after the completion of a charitable gaming event or session, all gross
3 receipts and adjusted gross receipts shall be deposited into one checking account
4 devoted exclusively to charitable gaming. This checking account shall be
5 designated the "charitable gaming account," and the licensed charitable
6 organization shall maintain its account at a financial institution located in the
7 Commonwealth of Kentucky. No other funds may be deposited or transferred into
8 the charitable gaming account.
- 9 (3) All payments for charitable gaming expenses, payments made for prizes purchased,
10 and any charitable donations from charitable gaming receipts shall be made from
11 the charitable gaming account and the payments or donations shall be made only by
12 bona fide officers of the organization by checks having preprinted consecutive
13 numbers and made payable to specific persons or organizations. No check drawn on
14 the charitable gaming account may be made payable to "cash," or "bearer," except
15 that a licensed charitable organization may withdraw start-up funds for a charitable
16 gaming event or session from the charitable gaming account by check made payable
17 to "cash" or "bearer," if these start-up funds are redeposited into the charitable
18 gaming account together with all adjusted gross receipts derived from the particular
19 event or session. Checks shall be imprinted with the words "charitable gaming
20 account" and shall contain the organization's license number on the face of each
21 check. Payments for charitable gaming expenses, prizes purchased, and charitable
22 donations may be made by electronic funds transfer if the payments are made to
23 specific persons or organizations. The corporation may by administrative regulation
24 adopt alternative reporting requirements for charitable gaming of limited scope or
25 duration, if these requirements are sufficient to ensure accountability for all moneys
26 handled.
- 27 (4) A licensed charitable organization shall expend net receipts exclusively for

1 purposes consistent with the charitable, religious, educational, literary, civic,
2 fraternal, or patriotic functions or objectives for which the licensed charitable
3 organization received and maintains federal tax-exempt status, or consistent with its
4 status as a local school district, a common school, an institution of higher
5 education, or a state college or university. No net receipts shall inure to the private
6 benefit or financial gain of any individual.

7 (5) Accurate records and books shall be maintained by each organization exempt from
8 licensure under KRS 238.535(1) and each licensed charitable organization for a
9 period of three (3) years. Office staff shall have access to these records at
10 reasonable times. Licensed charitable organizations and exempt organizations shall
11 maintain their charitable gaming records at their offices or places of business within
12 the Commonwealth of Kentucky as identified in their license applications or
13 applications for exempt status. An exempt organization shall submit a yearly
14 financial report in accordance with KRS 238.535(2), and failure to file this report
15 shall constitute grounds for revocation of the organization's exempt status.

16 (6) All licensed charitable organizations that have annual gross receipts of two hundred
17 thousand dollars (\$200,000) or less and do not have a weekly bingo session shall
18 report to the office annually at the time and on a form established in administrative
19 regulations promulgated by the corporation.

20 (7) All other licensed charitable organizations shall submit reports to the office at least
21 quarterly at the time and on a form established in administrative regulations
22 promulgated by the corporation.

23 (8) Failure by a licensed charitable organization to file reports required under this
24 chapter shall constitute grounds for revocation of the organization's license or
25 denial of the organization's application to renew its license in accordance with KRS
26 238.560(3). Reports filed by a licensed charitable organization shall include but
27 shall not be limited to the following information:

- 1 (a) All gross receipts received from charitable gaming for the reporting period,
2 classified by type of gaming activity;
- 3 (b) The names and addresses of all persons who are winners of prizes having a
4 fair market value of six hundred dollars (\$600) or more;
- 5 (c) All expenses paid and the names and addresses of all persons to whom
6 expenses were paid;
- 7 (d) All net receipts retained and the names and addresses of all charitable
8 endeavors that received money from the net receipts; and
- 9 (e) Any other information the office deems appropriate.
- 10 (9) No licensed charitable organization shall incur charitable gaming expenses, except
11 as provided in this chapter. No licensed charitable organization shall be permitted to
12 expend amounts in excess of prevailing market rates for the following charitable
13 gaming expenses:
- 14 (a) Charitable gaming supplies and equipment;
- 15 (b) Rent;
- 16 (c) Utilities;
- 17 (d) Insurance;
- 18 (e) Advertising;
- 19 (f) Janitorial services;
- 20 (g) Bookkeeping and accounting services;
- 21 (h) Security services;
- 22 (i) Membership dues for its participation in any charitable gaming trade
23 organization; and
- 24 (j) Any other expenses the corporation may determine by administrative
25 regulation to be legitimate.
- 26 (10) No licensed charitable organization shall expend receipts from charitable gaming
27 activities nor incur expenses to form, maintain, or operate as a labor organization.

(11) For the purposes of deposits under subsection (2) of this section, a licensed charitable organization conducting charitable gaming events or sessions shall only be required to deposit its gross receipts and adjusted gross receipts one (1) time per week if the following conditions are met:

- (a) The charitable gaming involves only games using charity game tickets;
- (b) The charitable gaming is not part of a charity fundraising event; and
- (c) The licensed charitable organization's deposits of gross receipts and adjusted gross receipts from charitable gaming total less than two thousand five hundred dollars (\$2,500) in the week prior to the deposit.

➔Section 48. KRS 238.560 (Effective July 1, 2025) is amended to read as follows:

(1) The office may investigate allegations of wrongdoing upon complaint or upon its own volition. The corporation by administrative regulation ~~may~~~~shall~~ establish procedures for receiving and investigating complaints in an expeditious manner.

(2) In carrying out its enforcement responsibilities, the office may:

- (a) Inspect and examine all premises in which or on which charitable gaming is conducted or charitable gaming supplies or equipment are manufactured or distributed;
- (b) Seize and remove from premises and impound charitable gaming supplies and equipment for the purposes of examination and inspection pursuant to an appropriate court order;
- (c) Demand access to, inspect, and audit books and records of licensees for the purpose of determining compliance with laws and the corporation's administrative regulations relative to charitable gaming; and
- (d) Conduct in-depth audits and investigations, when warranted.

(3) (a) As used in this subsection, "willful" means that the conduct constituting the violation was committed with intent, not accidentally or inadvertently.

1 (b) The office may take appropriate administrative action against any person
2 licensed under this chapter for any violation of the provisions of this chapter
3 or administrative regulations promulgated thereunder subject to the conditions
4 established by this subsection.

5 (c) The office may deny a license, suspend or revoke a license, issue a cease and
6 desist order, place a license holder on probation, issue a letter of reprimand or
7 letter of warning, and levy a fine. An administrative fine shall not exceed one
8 thousand dollars (\$1,000) for each offense. The office may deny the issuance
9 of a license or a license renewal if the applicant or licensee has failed to pay a
10 fine levied by the office. The corporation ~~may~~shall by administrative
11 regulation classify types of offenses and the recommended administrative
12 action. The type of action to be taken shall be based on the history of previous
13 violations and the nature, severity, and frequency of the offense.
14 Administrative action authorized in this section shall be in addition to any
15 criminal penalties provided in this chapter or under other provisions of law.

16 (d) 1. Notwithstanding any other provisions of this section, the office shall
17 review, within two (2) months of receipt, timely filed organization
18 quarterly reports that include payment of the fee due as reflected on the
19 organization quarterly report. If the office discovers reporting errors that
20 are not willful, the office shall, prior to taking any other administrative
21 action, issue a letter of warning to the licensee and allow the licensee
22 thirty (30) days from the issuance of the letter to correct the identified
23 violation. The purpose of this subparagraph is for the office to identify
24 correctable reporting errors in a timely manner, and to notify the
25 licensee of the errors prior to the due date of the next organization
26 quarterly report so that the errors are corrected and are not repeated in
27 subsequent organization quarterly reports.

- 1 2. A review conducted under subparagraph 1. of this paragraph shall not be
2 considered an audit or final review and acceptance of an organization
3 quarterly report and payment. The office shall have four (4) years from
4 the date of filing to fully audit and review an organization quarterly
5 report, and may pursue administrative actions against the licensee
