3 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE.
4 The General Assembly of North Carolina enacts:

27 **SECTION 2.1.** This act is effective when it becomes law. Unless otherwise provided,
28 terms begin upon the effective date of this act.
