- 2 (a) A cannabis agent must be registered with the Administration before the agent 3 may volunteer or work for a cannabis licensee or cannabis registrant.
- 4 (b) A cannabis agent registration is valid for 2 years.
- 5 (c) (1) [To] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS 6 SUBSECTION, TO register as a cannabis agent with the Administration, an individual 7 must:
- 8 **[**(1)**] (I)** be at least 21 years old; and
- 9 **[(2)] (II)** if the records are legally accessible, obtain a State and national 10 criminal history records check in accordance with § 36–505 of this subtitle.
- 11 **(2)** A CANNABIS AGENT WHO IS EMPLOYED TO PROVIDE SECURITY 12 SERVICES FOR A CANNABIS LICENSEE OR CANNABIS REGISTRANT AS A SECURITY GUARD OR BY A SECURITY GUARD AGENCY, AS DEFINED IN § 19-101 OF THE 13 BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE, IS NOT REQUIRED TO 14 OBTAIN A STATE OR NATIONAL CRIMINAL HISTORY RECORDS CHECK IN 15 16 ACCORDANCE WITH § 36-505 OF THIS SUBTITLE IF THE CANNABIS AGENT IS AUTHORIZED TO PROVIDE SECURITY GUARD SERVICES UNDER TITLE 19, SUBTITLE 17 4 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE. 18
- 19 (d) (1) The Administration may not register as a cannabis agent an individual 20 who does not meet the criteria established under subsection (c) of this section.
- 21 (2) The Administration may disqualify an individual from registering as a 22 cannabis agent if the individual has been convicted of or pleaded nolo contendere to a crime 23 involving moral turpitude, whether or not any appeal or other proceeding is pending to 24 have the conviction or plea set aside.
- 25 (e) The Administration may not deny a cannabis agent registration based on any 26 cannabis—related offenses occurring before July 1, 2023.
- 27 (f) A cannabis licensee shall require each registered cannabis agent to complete 28 an annual responsible vendor training program authorized under this title.
- 29 (g) A registration of a cannabis agent issued by the Natalie M. LaPrade Medical 30 Cannabis Commission on or before July 1, 2023, shall:
- 31 (1) be valid under this title; and
