22	(2) "CABLE TELEVISION COMPANY" MEANS A FRANCHISED OR

PRIVATE CABLE TELEVISION COMPANY.

- 1 (3) (I) "CABLE TELEVISION SYSTEM" MEANS A NONBROADCAST
- 2 FACILITY THAT CONSISTS OF A SET OF TRANSMISSION PATHS AND ASSOCIATED
- 3 SIGNAL GENERATION, RECEPTION, AND CENTRAL EQUIPMENT, UNDER COMMON
- 4 OWNERSHIP AND CONTROL, THAT DISTRIBUTES OR IS DESIGNED TO DISTRIBUTE TO
- 5 SUBSCRIBERS THE SIGNALS OF ONE OR MORE TELEVISION BROADCAST STATIONS.
- 6 (II) "CABLE TELEVISION SYSTEM" DOES NOT INCLUDE A 7 FACILITY THAT SERVES:
- 8 1. 49 OR FEWER SUBSCRIBERS; OR
- 9 2. ONLY SUBSCRIBERS IN ONE OR MORE MULTIPLE 10 DWELLING UNITS UNDER COMMON OWNERSHIP, CONTROL, OR MANAGEMENT.
- 11 (B) THIS SECTION APPLIES ONLY TO RESIDENTIAL RENTAL PROPERTY IN
- 12 MONTGOMERY COUNTY WITH MORE THAN FIVE RESIDENTIAL DWELLING UNITS FOR
- 13 RENT ON A SINGLE PARCEL OF PROPERTY OR AT A SINGLE LOCATION.
- 14 (C) A LANDLORD MAY NOT:
- 15 (1) PROHIBIT OR OTHERWISE PREVENT A CABLE TELEVISION
- 16 COMPANY FROM ACCESSING A DWELLING UNIT FOR THE PURPOSE OF
- 17 CONSTRUCTING, INSTALLING, OR SERVICING CABLE TELEVISION SYSTEM
- 18 EQUIPMENT IF A TENANT HAS REQUESTED CABLE TELEVISION SYSTEM SERVICE; OR
- 19 (2) DISCRIMINATE IN RENTAL OR OTHER CHARGES BASED ON A
- 20 CABLE TELEVISION SYSTEM SUBSCRIPTION.
- 21 (D) A LANDLORD MAY REQUIRE:
- 22 (1) COMPENSATION THAT IS COMPETITIVELY NEUTRAL AND
- 23 NONDISCRIMINATORY IN EXCHANGE FOR ALLOWING THE INSTALLATION OF CABLE
- 24 TELEVISION SYSTEM EQUIPMENT ON THE PARCEL OF PROPERTY; AND
- 25 (2) THAT A CABLE TELEVISION COMPANY INDEMNIFY THE LANDLORD
- 26 FOR ANY DAMAGE THAT RESULTS FROM THE INSTALLATION OR REMOVAL OF CABLE
- 27 TELEVISION SYSTEM EQUIPMENT.
- 28 (E) A CABLE TELEVISION COMPANY MAY NOT:
- 29 (1) CHARGE A LANDLORD FOR THE INSTALLATION OF CABLE
- 30 TELEVISION EQUIPMENT IN AN INDIVIDUAL DWELLING UNIT THAT WAS REQUESTED

## 1 BY A TENANT; OR

- 2 (2) INSTALL A CABLE TELEVISION SYSTEM IN AN INDIVIDUAL
- 3 DWELLING UNIT UNLESS PERMISSION HAS BEEN GIVEN BY THE TENANT OCCUPYING
- 4 THE DWELLING UNIT.
- 5 (F) A TENANT, LANDLORD, OR CABLE TELEVISION COMPANY MAY BRING AN
- 6 ACTION IN THE DISTRICT COURT TO ENFORCE THE PROVISIONS OF THIS SECTION.
- 7 (G) A COUNTY MAY ADOPT A LOCAL LAW, ORDINANCE, OR REGULATION TO 8 ENFORCE THE PROVISIONS OF THIS SECTION.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 10 October 1, 2022.
