A BILL

To require the Secretary of Labor to establish apprenticeships or expanding opportunities through apprenticeships for outlying areas, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Outlying Area Appren-
- 5 ticeship Expansion Act".
- 6 SEC. 2. OUTLYING AREA APPRENTICESHIP PROGRAMS.
- 7 (a) In General.—The Secretary of Labor shall
- 8 make grants, cooperative agreements, contracts, and other

- 1 arrangements available to the outlying areas for the pur-
- 2 poses of—
- 3 (1) establishing registered apprenticeships
- 4 under the Act of August 16, 1937 (commonly known
- 5 as the "National Apprenticeship Act"; 50 Stat. 664,
- 6 chapter 663; 29 U.S.C. 50 et seq.); or
- 7 (2) expanding opportunities through apprentice-
- 8 ships only registered under the Act of August 16,
- 9 1937 (commonly known as the "National Appren-
- 10 ticeship Act"; 50 Stat. 664, chapter 663; 29 U.S.C.
- 11 50 et seq.).
- 12 (b) Funding.—Of the amount appropriated under
- 13 subsection (d), the Secretary of Labor shall divide the
- 14 amount for each fiscal year equally among the outlying
- 15 areas.
- 16 (c) Outlying Area Defined.—The term "outlying
- 17 area" means American Samoa, Guam, the Commonwealth
- 18 of the Northern Mariana Islands, and the United States
- 19 Virgin Islands.
- 20 (d) Authorization of Appropriations.—There
- 21 are authorized to be appropriated to carry out this sec-
- 22 tion—
- 23 (1) \$1,786,000 for fiscal year 2021;
- 24 (2) \$2,024,000 for fiscal year 2022;
- 25 (3) \$2,262,000 for fiscal year 2023;

- 1 (4) \$2,500,000 for fiscal year 2024; and
- 2 (5) \$2,738,000 for fiscal year 2025.
- 3 (e) Effective Date.—This Act shall take effect be-

4 ginning on July 1, 2021.
