## A BILL ENTITLED

1 AN ACT concerning

2 **Consumer Protection – Motor Vehicle Glass Repair or Replacement – Advanced**  
3 **Driver Assistance System Recalibration**

4 FOR the purpose of establishing consumer protections related to the repair or replacement  
5 of motor vehicle glass on motor vehicles equipped with an advanced driver assistance  
6 system; and generally relating to consumer protections related to the repair or  
7 replacement of motor vehicle glass on motor vehicles equipped with advanced driver  
8 assistance systems.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
25 That the Laws of Maryland read as follows:

26 **Article – Commercial Law**

2 Unfair, abusive, or deceptive trade practices include any:

3 (14) Violation of a provision of:

4 (xxxv) Section 11–210 of the Education Article; [or]

5 (xxxvi) Title 14, Subtitle 44 of this article; or

6 (xxxvii) **SECTION 14–1327 OF THIS ARTICLE; OR**

7 **14–1327.**

8 (A) (1) **IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**  
9 **INDICATED.**

10 (2) **“ADVANCED DRIVER ASSISTANCE SYSTEM” MEANS AN**  
11 **ELECTRONIC SYSTEM THAT USES AUTOMATED TECHNOLOGY INCLUDING CAMERAS**  
12 **AND SENSORS TO DETECT NEARBY OBSTACLES AND DRIVER ERRORS TO ASSIST A**  
13 **DRIVER IN THE SAFE OPERATION OF A MOTOR VEHICLE.**

14 (3) **“MOTOR VEHICLE” HAS THE MEANING STATED IN TITLE 11 OF**  
15 **THE TRANSPORTATION ARTICLE.**

16 (4) **“MOTOR VEHICLE SAFETY GLASS FACILITY” MEANS A PERSON**  
17 **THAT:**

18 (I) **REPAIRS OR REPLACES MOTOR VEHICLE SAFETY GLASS;**  
19 **AND**

20 (II) **PROVIDES RELATED RECALIBRATION OF AN ADVANCED**  
21 **DRIVER ASSISTANCE SYSTEM.**

22 (5) **“PERSON” INCLUDES AN INDIVIDUAL, A CORPORATION, A**  
23 **BUSINESS TRUST, A TRUST ESTATE, AN ASSOCIATION, TWO OR MORE PERSONS**  
24 **HAVING A JOINT OR COMMON INTEREST, OR ANY OTHER LEGAL OR COMMERCIAL**  
25 **ENTITY.**

26 (6) **“RECALIBRATION” MEANS THE READJUSTMENT OF CAMERAS,**  
27 **SENSORS, AND OTHER TECHNOLOGY IN AN ADVANCED DRIVER ASSISTANCE SYSTEM**  
28 **TO ENSURE PROPER WORKING ORDER IN ACCORDANCE WITH MOTOR VEHICLE**  
29 **MANUFACTURER SPECIFICATIONS.**

1       **(B) BEFORE REPAIRING OR REPLACING MOTOR VEHICLE GLASS, IF A**  
2 **MOTOR VEHICLE IS EQUIPPED WITH AN ADVANCED DRIVER ASSISTANCE SYSTEM, A**  
3 **MOTOR VEHICLE SAFETY GLASS FACILITY SHALL:**

4               **(1) INFORM THE CUSTOMER IF THE RECALIBRATION OF AN**  
5 **ADVANCED DRIVER ASSISTANCE SYSTEM IS REQUIRED; AND**

6               **(2) PROVIDE THE CUSTOMER WITH A STATEMENT THAT THE WORK TO**  
7 **BE PERFORMED ON THE MOTOR VEHICLE WILL MEET OR EXCEED ORIGINAL**  
8 **EQUIPMENT MANUFACTURER SPECIFICATIONS.**

9       **(C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A MOTOR**  
10 **VEHICLE SAFETY GLASS FACILITY IS NOT LIMITED TO MOTOR VEHICLE GLASS,**  
11 **TOOLING, EQUIPMENT, OR REPAIR PROCEDURES PROVIDED BY THE VEHICLE**  
12 **MANUFACTURER.**

13               **(2) RECALIBRATION OF AN ADVANCED DRIVER ASSISTANCE SYSTEM**  
14 **PERFORMED BY A MOTOR VEHICLE SAFETY GLASS FACILITY SHALL MEET OR**  
15 **EXCEED THE MOTOR VEHICLE MANUFACTURER'S SPECIFICATIONS.**

16               **(3) A MOTOR VEHICLE SAFETY GLASS FACILITY MAY NOT CHARGE**  
17 **FOR SERVICES THAT ARE NOT PERFORMED OR SUCCESSFULLY COMPLETED.**

18       **(D) A MOTOR VEHICLE SAFETY GLASS FACILITY SHALL INFORM THE**  
19 **CUSTOMER IF RECALIBRATION OF AN ADVANCED DRIVER ASSISTANCE SYSTEM IS**  
20 **REQUIRED AND IS NOT PERFORMED OR SUCCESSFULLY COMPLETED.**

21       **(E) A VIOLATION OF THIS SECTION BY A MOTOR VEHICLE SAFETY GLASS**  
22 **FACILITY IS:**

23               **(1) AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE PRACTICE WITHIN**  
24 **THE MEANING OF TITLE 13 OF THIS ARTICLE; AND**

25               **(2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS**  
26 **CONTAINED IN TITLE 13 OF THIS ARTICLE.**

27       SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
28 October 1, 2023.
