## A BILL

To authorize health insurance issuers to continue to offer for sale health insurance coverage offered in the individual market before the enactment of the Patient Protection and Affordable Care Act in satisfaction of the minimum essential health insurance coverage requirement, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Patient Fairness and
- 3 Relief Act of 2017".
- 4 SEC. 2. EXTENDING OPTION TO CONTINUE PRE-ACA COV-
- 5 ERAGE.
- 6 (a) IN GENERAL.—Notwithstanding any provision of
- 7 the Patient Protection and Affordable Care Act (including
- 8 any amendment made by such Act or by the Health Care
- 9 and Education Reconciliation Act of 2010), a health insur-
- 10 ance issuer that had in effect health insurance coverage
- 11 in the individual market as of January 1, 2013, and has
- 12 continued such coverage through January 1, 2017, under
- 13 CCIIO guidance (as defined in subsection (c)) may renew
- 14 and continue to offer such coverage for sale on and after
- 15 the date of the enactment of this Act in the individual
- 16 market outside of an Exchange established under section
- 17 1311 or 1321 of such Act (42 U.S.C. 18031, 18041).
- 18 (b) Treatment as Grandfathered Health
- 19 Plan in Satisfaction of Minimum Essential Cov-
- 20 Erage.—Health insurance coverage described in sub-
- 21 section (a) shall be treated as a grandfathered health plan
- 22 for purposes of the amendment made by section 1501(b)
- 23 of the Patient Protection and Affordable Care Act.
- (c) CCIIO GUIDANCE DEFINED.—In this section, the
- 25 term "CCIIO guidance" means the letter issued by the
- 26 Centers for Medicare & Medicaid Services on November

- 1 14, 2013, to the State Insurance Commissioners outlining
- 2 a transitional policy for non-grandfathered coverage in the
- 3 small group and individual health insurance markets, as
- 4 subsequently extended and modified (including by a com-
- 5 munication entitled "Insurance Standards Bulletin Se-
- 6 ries—INFORMATION—Extension of Transitional Policy
- 7 through Calendar Year 2017" issued on February 29,
- 8 2016, by the Director of the Center for Consumer Infor-
- 9 mation & Insurance Oversight of such Centers).
