- 3 (a) On issuance in this State of an original or subsequent certificate of title for a 4 vehicle, the vehicle is exempt from the excise tax imposed by this part, if it is:
- 5 (3) A vehicle owned **OR LEASED** by this State or any political subdivision 6 of this State;
- 7 17–106.
- 8 (e) (1) (i) In addition to any other penalty provided for in the Maryland 9 Vehicle Law, if the required security for a vehicle terminates or otherwise lapses during its 10 registration year, the Administration may assess the owner of the vehicle with a penalty of 11 \$150 for each vehicle without the required security for a period of 1 to 30 days. If a fine is 12 assessed, beginning on the 31st day the fine shall increase by a rate of \$7 for each day.
- 13 (ii) Each period during which the required security for a vehicle 14 terminates or otherwise lapses shall constitute a separate violation.
- 15 (iii) The penalty imposed under this subsection may not exceed 16 \$2,500 for each violation in a 12-month period.
- 17 (3) If the Administration assesses a vehicle owner, [or] co-owner, **OR**18 **LESSEE** with a penalty under this subsection, the Administration may not take any of the
  19 following actions until the penalty is paid:
- 20 (i) Reinstate a registration suspended under this subsection;
- 21 (ii) Except for a temporary registration as provided under § 22 13-602(a)(2) of this article, issue a new registration for any vehicle that is owned, [or] 23 co-owned, **OR LEASED** by that person and is titled after the violation date; or
- 24 (iii) Renew a registration for a vehicle that is owned, [or] co—owned, 25 OR LEASED by that person.
