

## 115 TH CONGRESS 1ST SESSION H.R. 1390

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to pay costs relating to the transportation of certain deceased veterans to veterans' cemeteries owned by a State or tribal organization.

## A BILL

- To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to pay costs relating to the transportation of certain deceased veterans to veterans' cemeteries owned by a State or tribal organization.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. TRANSPORTATION OF DECEASED VETERANS
  - 4 TO VETERANS' CEMETERIES.
- 5 (a) In General.—Subsection (a) of section 2308 of
- 6 title 38, United States Code, is amended to read as fol-
- 7 lows:

- 1 "(a) IN GENERAL.—(1) The Secretary may pay, in
- 2 addition to any amount paid pursuant to section 2302 or
- 3 2307 of this title, the cost of transportation of the de-
- 4 ceased veteran described in paragraph (1) or (2) of sub-
- 5 section (b) for burial in a national cemetery or a covered
- 6 veterans' cemetery. Such payment shall not exceed the
- 7 cost of transportation to the national cemetery nearest the
- 8 veteran's last place of residence in which burial space is
- 9 available.
- 10 "(2) The Secretary may pay, in addition to any
- 11 amount paid pursuant to section 2302 or 2307 of this
- 12 title, the cost of transportation of the deceased veteran
- 13 described in subsection (b)(3) for burial in a national cem-
- 14 etery. Such payment shall not exceed the cost of transpor-
- 15 tation to the national cemetery nearest the veteran's last
- 16 place of residence in which burial space is available.".
- 17 (b) COVERED VETERANS' CEMETERY DEFINED.—
- 18 Section 2308 of such title is amended by adding at the
- 19 end the following new subsection:
- 20 "(c) Covered Veterans' Cemetery Defined.—
- 21 In this section, the term 'covered veterans' cemetery'
- 22 means, with respect to a deceased veteran described in
- 23 subsection (b), a veterans' cemetery owned by a State or
- 24 a tribal organization (as defined in section 3765(4) of this

- 1 title) in which the deceased veteran is eligible to be bur-
- 2 ied.".
- 3 (c) Conforming Amendment.—Section 2308 of
- 4 such title is amended in the section heading by adding
- 5 at the end the following: "or a veterans' cemetery".
- 6 (d) CLERICAL AMENDMENT.—The table of sections
- 7 at the beginning of chapter 23 of such title is amended
- 8 by striking the item relating to section 2308 and inserting
- 9 the following new item:

"2308. Transportation of deceased veteran to a national cemetery or a veterans' cemetery.".
