A BILL

To reinstate Federal Pell Grant eligibility for individuals incarcerated in Federal and State penal institutions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Restoring Education
- 5 And Learning Act of 2018" or the "REAL Act of 2018".

SEC. 2. REINSTATEMENT OF FEDERAL PELL GRANT ELIGI-2 BILITY. Section 401(b) of the Higher Education Act of 1965 3 4 (20 U.S.C. 1070a(b)) is amended— 5 (1) by striking paragraph (6); (2) by redesignating paragraph (7) as para-6 7 graph (6); and paragraph (2)(A)(ii), by 8 striking "(7)(B)" and inserting "(6)(B)". 9 SEC. 3. EFFECTIVE DATE. 10 11 The amendments made by section 2 shall be effective
