A BILL

To amend the Outer Continental Shelf Lands Act to permanently prohibit the conduct of offshore drilling on the outer Continental Shelf in the Mid-Atlantic, South Atlantic, North Atlantic, and Straits of Florida planning areas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Clean Ocean And Safe
- 3 Tourism Anti-Drilling Act of 2025" or the "COAST Anti-
- 4 Drilling Act of 2025".
- 5 SEC. 2. PROHIBITION OF OIL AND GAS LEASING IN CER-
- 6 TAIN AREAS OF OUTER CONTINENTAL SHELF.
- 7 Section 8 of the Outer Continental Shelf Lands Act
- 8 (43 U.S.C. 1337) is amended by adding at the end the
- 9 following:
- 10 "(q) Prohibition of Oil and Gas Leasing in
- 11 CERTAIN AREAS OF OUTER CONTINENTAL SHELF.—Not-
- 12 withstanding any other provision of this section or any
- 13 other law, the Secretary shall not issue a lease or any
- 14 other authorization for the exploration, development, or
- 15 production of oil, natural gas, or any other mineral in the
- 16 following planning areas, as each such planning area is
- 17 depicted in the 2024–2029 National Outer Continental
- 18 Shelf Oil and Gas Leasing Proposed Final Program ref-
- 19 erenced in the notice of availability published by the Bu-
- 20 reau of Ocean Energy Management titled 'Notice of Avail-
- 21 ability of the 2024–2029 National Outer Continental Shelf
- 22 Oil and Gas Leasing Proposed Final Program and Final
- 23 Programmatic Environmental Impact Statement' (88 Fed.
- 24 Reg. 67798; published October 2, 2023):
- 25 "(1) The North Atlantic planning area.
- 26 "(2) The Mid-Atlantic planning area.

- 1 "(3) The South Atlantic planning area.
- 2 "(4) The Straits of Florida planning area.".
