A BILL

To amend title III of the Social Security Act to extend reemployment services and eligibility assessments to all claimants for unemployment compensation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Building on Reemploy-*
5 *ment Improvements to Deliver Good Employment for Work-*
6 *ers Act” or the “BRIDGE for Workers Act”.*

7 **SEC. 2. FINDINGS.**

8 *Congress finds the following:*

9 *(1) The Bipartisan Budget Act of 2018 (Public*
10 *Law 115-123) improved program accountability for*
11 *effectively serving unemployed workers and made a*
12 *significant new investment in reemployment services.*

13 *(2) Research shows the longer workers are out of*
14 *work, the harder it can be to maintain their skills,*
15 *professional network, and stable home life.*

16 *(3) Reemployment services give workers who*
17 *might otherwise struggle to find new jobs the tools*
18 *that they need to get back to work—such as individ-*
19 *ualized career counseling and job search help as well*
20 *as local labor market information—and they can*
21 *serve as an entry point to the workforce development*
22 *system.*

23 *(4) Reemployment services have been dem-*
24 *onstrated to reduce the number of weeks that program*
25 *participants receive unemployment benefits by im-*

1 *proving their employment outcomes, including earn-*
 2 *ings.*

3 *(5) Unemployment benefits replace less than half*
 4 *of working income, on average, so workers who find*
 5 *new jobs quickly suffer less financial hardship.*

6 *(6) Combining targeted reemployment services*
 7 *with unemployment benefits helps keep people at-*
 8 *tached to the labor force who might otherwise become*
 9 *discouraged and drop out.*

10 *(7) The Congressional Budget Office estimates*
 11 *that, over time, investments in reemployment services*
 12 *create savings for taxpayers and unemployment trust*
 13 *funds by reducing spending on unemployment bene-*
 14 *fits.*

15 *(8) Many different types of workers can benefit*
 16 *from reemployment services. Reemployment services*
 17 *should be used to shorten the duration of unemploy-*
 18 *ment for workers even if they are not projected to*
 19 *fully exhaust their unemployment benefits.*

20 **SEC. 3. ELIGIBILITY FOR REEMPLOYMENT SERVICES.**

21 *Section 306(a) of the Social Security Act (42 U.S.C.*
 22 *506(a)) is amended—*

23 *(1) by striking “individuals referred to reem-*
 24 *ployment services as described in section 303(j)” and*
 25 *inserting “claimants for unemployment compensa-*

- 1 *tion, including claimants referred to reemployment*
2 *services as described in section 303(j),”; and*
3 *(2) by striking “such individuals” and inserting*
4 *“such claimants”.*

Amend the title so as to read: “A bill to amend title III of the Social Security Act to extend reemployment services and eligibility assessments to all claimants for unemployment benefits, and for other purposes.”.
