A BILL

To amend the Richard B. Russell National School Lunch Act to require a school food authority to make publicly available any waiver of the Buy American requirement, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Food for
- 5 American Schools Act of 2021".

I	SEC. 2. WAIVER TO PURCHASE FOREIGN COMMODITIES OR
2	PRODUCTS.
3	(a) In General.—Section 12(n)(2) of the Richard
4	B. Russell National School Lunch Act (42 U.S.C.
5	1760(n)(2)) is amended—
6	(1) in subparagraph (A), by striking "subpara-
7	graph (B)" and inserting "subparagraphs (B) and
8	(C)";
9	(2) in subparagraph (B)(ii), by striking "for the
10	school lunch program under this Act or the school
11	breakfast program under section 4 of the Child Nu-
12	trition Act of 1966 (42 U.S.C. 1773)." and inserting
13	"for—
14	"(I) the school lunch program
15	under this Act, including any snacks
16	served under such program;
17	"(II) the special milk program
18	under section 3 of the Child Nutrition
19	Act of 1966 (42 U.S.C. 1772); and
20	"(III) the school breakfast pro-
21	gram under section 4 of the Child Nu-
22	trition Act of 1966 (42 U.S.C.
23	1773).".
24	(3) by adding at the end the following:
25	"(C) Waiver.—

1	"(i) Waiver request.—Except as
2	provided in clause (ii), a school food au-
3	thority shall request from the Secretary a
4	waiver of subparagraph (A) to purchase
5	foreign commodities or products.
6	"(ii) Exception.—A school food au-
7	thority may purchase foreign commodities
8	or products without a waiver under clause
9	(i) if such commodities or products are
10	not—
11	"(I) produced domestically; or
12	"(II) available domestically.
13	"(iii) Requirements.—The Sec-
14	retary may not provide a waiver to pur-
15	chase foreign commodities or products
16	under clause (i) unless—
17	"(I) the commodities or prod-
18	ucts—
19	"(aa) are not produced do-
20	mestically in sufficient amounts
21	or of satisfactory quality; and
22	"(bb) if purchased domesti-
23	cally, would be significantly high-
24	er in price than such foreign
25	commodities or products; and

1	"(II) the school enters into an
2	agreement under clause (iv).
3	"(iv) AGREEMENT.—The Secretary
4	may not provide a waiver under clause (i)
5	unless the school food authority requesting
6	such waiver agrees to—
7	"(I) not later than 30 days after
8	receiving such a waiver, make the
9	waiver publicly available on the
10	website of the school food authority;
11	and
12	"(II) not less than once each
13	school year, email a notification of all
14	waivers to parents or guardians of
15	students who will be served the for-
16	eign commodity or product purchased
17	pursuant to any such waivers.".
18	(b) Definition of Foreign Commodity.—Section
19	12(n)(1) of the Richard B. Russell National School Lunch
20	Act (42 U.S.C. $1760(n)(1)$) is amended to read as follows:
21	"(1) Definitions.—In this subsection:
22	"(A) Domestic commodity or prod-
23	UCT.—The term 'domestic commodity or prod-
24	uct' means—

1	"(i) an agricultural commodity that is
2	produced in the United States; and
3	"(ii) a food product that is processed
4	in the United States substantially using
5	agricultural commodities that are produced
6	in the United States.
7	"(B) Foreign commodity or prod-
8	UCT.—The term 'foreign commodity or product'
9	means a commodity or product other than a do-
10	mestic commodity or product.".
11	(c) Conforming Amendments.—Section 12(n) of
12	the Richard B. Russell National School Lunch Act (42
13	U.S.C. 1760(n)) is amended—
14	(1) in paragraph (3), by striking "Paragraph
15	(2)(A)" and inserting "Subparagraphs (A) and (C)
16	of paragraph (2)"; and
17	(2) in paragraph (4), by striking "Paragraph
18	(2)(A)" and inserting "Subparagraphs (A) and (C)
19	of paragraph (2)".
20	(d) Rule of Construction.—Nothing in this Act
21	or the amendments by this Act shall affect the require-
22	ments under section 4207 of the Agriculture Improvement
23	Act of 2018 (42 U.S.C. 1760 note).
