BY repealing and reenacting, with amendments, Article – Education Section 2-202 Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Education 2-202.The State Board consists of [13] 14 regular members, and 1 student member, appointed by the Governor with the advice and consent of the Senate. (b) In making appointments to the State Board, the Governor shall (1) consider representation from: (i) All parts of this State; and

1 The dismissal of or other disciplinary action involving personnel; (i) 2 or 3 (ii) Appeals to the State Board under § 2–205 of this subtitle or § 4-205 or § 6-202 of this article. 4 5 Each regular member serves for a term of 4 years and until a successor 6 is appointed and qualifies. These terms are staggered as required by the terms of the 7 members serving on the State Board as of July 1, 1989. 8 **(2)** The Governor shall appoint a new member to fill any vacancy on the 9 Board for the remainder of that term and until a successor is appointed and qualifies. 10 (3)A member is eligible for reappointment but may not serve for more than two full 4-year terms. 11 12 **(4)** The student member shall serve for a term of 1 year. A student member 13 is eligible for reappointment but may not serve more than two full 1-year terms. 14 SECTION 2. AND BE IT FURTHER ENACTED, That the Governor shall appoint, in accordance with § 2–202(b)(5) of the Education Article, as enacted by Section 1 of this 15 Act, the initial principal member of the State Board of Education, who shall serve for a 16 17 term beginning July 1, 2026. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 18 19 1, 2025.
