Community Development Administration – Live Near Your School Program – Establishment

FOR the purpose of requiring the Community Development Administration in the 4 5 Department of Housing and Community Development to administer a home buyer 6 assistance program that assists certain individuals with receiving certain 7 low-interest mortgages for the purchase of homes near the individuals' schools; 8 requiring the Administration to coordinate with, and match where appropriate, 9 similar other programs under certain circumstances; requiring the Administration 10 to allow public institutions of higher education to provide certain matching funds; 11 requiring the Administration to facilitate the marketing of a certain home buyer 12 assistance program with certain persons; requiring the Department to report to the 13 General Assembly on a certain home buyer assistance program on or before a certain 14 date each year; requiring the Administration to administer certain community 15 development projects to provide certain individuals with certain financial assistance 16 to buy homes near the individuals' schools under certain circumstances; exempting 17 certain community development projects from certain requirements regarding 18 income; designating certain community development projects as the Live Near Your 19 School program; requiring the Administration to adopt certain regulations; defining 20 certain terms; and generally relating to the Live Near Your School program.
